VILLAGE EDGE ROAD ROADWAY IMPROVEMENTS PROJECT
VILLAGE OF ARENA
JULY 18, 2023

1. ***Where is the project?*** Village Edge Road (From USH 14 to Sharon Street). New trail construction on the east side of Village Edge Road from the north driveway of BP Gas Station to Sharon Street.
2. ***What work is being done?***
 - Storm culvert replacement
 - Water service replacement (3 each)
 - Fire hydrant relocation (1 each)
 - Roadway pulverizing and paving
 - New asphalt trail and concrete ramps at intersections.
 - Turf restoration
3. ***Who is the contractor?*** S&L Underground Inc, Lodi WI
4. ***What is the schedule for the proposed project?*** End of August – End of October 2023. Railroad grade crossing replacement in the spring of 2024.
5. ***Will I have to plow the trail?***
The new 8' wide trail will be in the Village right-of-way and will be maintained by the public works staff.
6. ***Will there be landscaping associated with this project?***
Any disturbed areas will be seeded and mulched or matted. Property owners are encouraged to water and care for the new seeding.
7. ***Will trees be removed?***
One tree will be removed to accommodate the trail.
8. ***How is the project paid for?***
The project will be funded by the Village budget.
9. ***How will the project affect access to my driveway?***
Generally, the contractor will be required to provide access to homes at the end of the working day and on weekends. As with any construction project, there may be short periods when driveways are inaccessible during active excavation.
10. ***Will access for emergency vehicles be maintained?***
Yes, the contractor will be required to accommodate emergency vehicles at all times.
11. ***Will mail be delivered during construction?***
Mail delivery will be maintained during construction. A portion of the roadway will shift slightly to the west to accommodate the new trail. After road paving, Homeowners should plan to relocate mailboxes and/or coordinate with the contractor. Property owners are encouraged to make arrangements to pick up

their mail at the post office during construction.

12. ***How will garbage/recycling be handled during construction?***

This may vary from week to week, as construction changes and progresses. If the garbage/recycle trucks are not able to access the pick-up points, the Village and/or contractor will coordinate to pick up the trash/recyclables and move them to the closest intersecting street for pick-up. **Please put your address on your trash and recycle bins so they can be returned to the correct property owner.**

13. ***Will any work take place on private property?***

Generally, the contractor may need to do limited work on private property near the street right-of-way to match existing grades. The contractor will be responsible for restoring any areas of private property disturbed by construction operations to a condition as good, or better than existed before the construction.

14. ***Will water service be interrupted?***

Water service may be interrupted for short periods of time during hydrant relocation or service connections. The contractor will be required to provide 24-hour prior notification to all residents prior to any planned interruption of water service

15. ***Will sanitary sewer service be interrupted?***

Sanitary sewer service will be maintained at all times during construction.

16. ***Private Utilities***

Private utilities, Alliant Energy and Frontier Communications will be fully relocated prior to construction.

Persons with special needs should inform the Village if accommodations need to be made during construction.
