

**ORDINANCE NO. 2015-05**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BEACH CITY, TEXAS, AUTHORIZING ITS MAYOR TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT WITH BRIDGEHAVEN CHILDREN'S ADVOCACY CENTER FOR A SUM NOT GREATER THAN ONE THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$1,500.00) TO PROVIDE FOR CHILDREN WHO HAVE BEEN ABUSED AND TO ACT AS AN INTERMEDIARY FOR SUCH CHILDREN WITH AGENCIES CHARGED WITH THE DUTY OF TREATING SUCH CHILDREN OR LAW ENFORCEMENT AGENCIES CHARGED WITH THE DUTY OF PROSECUTING OR INVESTIGATING CRIMES AGAINST CHILDREN; MAKING OTHER PROVISIONS RELATED THERETO; AND PROVIDING FOR AN EFFECTIVE DATE THEREOF.**

**BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF BEACH CITY, TEXAS:**

**SECTION ONE:** That the City Council for the City of Beach City, Texas hereby desires to enter into a contract for professional services with Bridgehaven Children's Advocacy Center;

**SECTION TWO:** That the Contract shall be for a one year term beginning on the date the last party signs the contract;


**SECTION THREE:** That the Contract shall be for an amount not exceed the sum of \$1,500.00;

**SECTION FOUR:** That the Mayor of the City of Beach City, Texas is hereby granted general authority to sign the Contract on behalf of the City;


**SECTION FIVE:** That Bridgehaven Children's Advocacy Center in consideration of this contractual amount shall provide to the citizens of the City of Beach City, Texas, counseling and such other services as may be deemed proper and necessary for children who have been abused. Further, the Center agrees to act as intermediary for such children with agencies charged with the duty of treating such children or law enforcement agencies charged with the duty of prosecuting or investigating crimes against children in an effort to avoid or minimize the trauma generally associated with such events. Such services shall be rendered as more fully set forth in the Contract;

**SECTION SIX:** That Bridgehaven Children's Advocacy Center in consideration of this contractual amount shall provide to the City Council of the City of Beach City, Texas, an annual summary report of the level and nature of services provided to the City of Beach City;


