# City of Beach City Council Regular Meeting Minutes

The Beach City Council met for a Regular Meeting on **December 15, 2015** at the Beach City Community Building 12723 FM 2354 Beach City, TX. 77523

## 1. Call to order

On Tuesday, December 15, 2015 Mayor Combs called the meeting to order at 6:02 pm.

# 2. Invocation and Pledge of Allegiance

Mayor Combs offered prayer.

Alderman Newman led the Pledge of Allegiance to the United States and Texas flags.

3. Public Comments (Limited to five minutes per person)

None

4. Hear report and update from Chambers County Commissioner, Rusty Senac

5. Hear report and update from Beach City Volunteer Fire Department (BCVFD)

Fire Chief Pat McDonald stated that the BCVFD is up to date on filing their taxes. The BCVFD is still working on bids to obtain a new truck.

Santa on the Bay was a huge success. There were a lot of canned goods collected for the West Chambers County Food Pantry. The BCVFD also collected \$2,080.00 in donations which will be donated to the food pantry as well.

6. Approval of Minutes for Regular Meeting and Public Hearing of November 17<sup>th</sup>, 2015

Discussion: Secretary Donnelly sent an email to Mayor and Council regarding an overcharge of training costs she miscalculated for a legislative update in August. The total overcharge is: \$133.39 and Secretary Donnelly will write a personal check to the City to cover the unintentional charges. The Secretary caught this mistake while calculating her expense report. Council concurred a personal check is acceptable.

8. Discussion and possible action on a water and wastewater utility rate increase for customers served by the Bayridge Water system filed by Nerro Supply, LLC

Beach City received a rate increase request from Nerro Supply last week. Nerro Supply did not submit an application only a letter stating their intent to the City.

Mayor Combs created a spreadsheet for Council to review.

Mayor Combs requested more information from Nerro Supply but has not received it to date.

This rate increase would affect Bayridge Subdivision residents and Oaks at Houston Point. Nerro Supply also requested, via phone call to Mayor Combs, that the City include OceanWay Park in this rate increase request and take action on it. Mayor Combs noted that Council cannot take action on a rate increase request the City has not formally received.

9. Consider and approve Ordinance suspending rate increase filed by Nerro Supply, LLC

10. Discussion and possible action on a Utility District for Nerro Supply, LLC customers within Beach City

Mayor Combs spoke with Attorney Ron Young on the options of forming a Municipal Utility District (MUD). Mr. Young said he would speak to a financial advisor and get back to the Mayor. There has been no further contact from Mr. Young.

The Chambers County Appraisal District sent Mayor Combs the appraised tax value of each

subdivision and the numbers are as follows:

- a). Bayridge Subdivision = \$8,855,270
- b). OceanWay Mobile Home Park = \$2,633,180
- c). Oaks at Houston Point = \$10,645,450

Someone who understands the financial side of this can use these numbers to determine what type of bonds may be obtained and what tax rate could be implemented. There has not been much head way made in the last thirty days.

Mayor Combs requests Council to give him permission to speak to another attorney. The City has dealt with Austin Attorney Art Rodriguez in the past. Mayor Combs received a vote of confidence from Alderman Walker to do what is necessary in exploring his options with other attorneys and financial advisors regarding this matter.

#### 11. Consider and approve Council meeting schedule for 2016

The Chamber banquet will be held the fourth Tuesday of January 2016. The Council meeting will be moved to January 19, 2016. The meetings for November and December 2016 will be held the third Tuesdays of those months.

#### 13. Discuss and consider a Sales Tax for Beach City businesses

Mayor Combs asked Council if there is enough interest to explore the idea of implementing a City Sales Tax. Currently, there is a sales tax rate of 6¾ % in Beach City. The State gets 6¼ % of this rate, while Chambers County Health Services collects ½ %. This leaves 1½ % open for Beach City to implement, via voter approval.

A sales tax could help the City generate revenue for future issues such as utilities, a new office and financial assistance that maybe needed by the Beach City Volunteer Fire Department (BCVFD) to purchase a new engine, etc.

Alderman Smith would like for the City to move forward with this process.

Alderman Newman stated that he is not certain he is ready to vote for a tax and would like an investigation to determine what type of revenue stream the City would be looking at. The question he posed is, would this be thousands of dollars or a thousand dollars? Alderman Walker concurred with Alderman Newman. Alderman Walker does not feel comfortable voting for a tax collection system and would like an investigation to answer these questions:

- a). How much it might be?
- b). How the mechanism would work that Beach City would get it?

c). What does it do to local businesses, if anything?

Alderman Lasater would like to reserve the  $1\frac{1}{2}$  % for Beach City and not allow another entity the opportunity to collect this tax.

Secretary Donnelly will contact the State Comptroller's Office in the near future.

Attorney Jackson asked if we could have someone from the Comptroller's office to speak to Council.

# 14. Consider and approve Interlocal Agreement with Chambers County Sheriff's Office

Deputy Gilbert Phillips represented the Chambers County Sheriff's Department to answer any questions Council may have.

Discussion: Mayor Combs pointed out that in Item 6 of the Interlocal Agreement it states, "The City agrees to pay County consideration for services rendered by the Sheriff herein, the sum equal to the current contractual rate Chambers County pays per day to house inmates at other facilities (example Jefferson County)".

Mayor Combs added that currently Jefferson County is receiving \$41.00 per day, other counties are getting up to \$49.00 per day.

Deputy Gilbert stated that Galveston County is getting \$82.00 per day for one violent inmate in particular. High risk inmates tend to be sent to Galveston County.

15. Consider and approve Resolution vesting within the Chambers County Sheriff and within each Deputy Sheriff, to the extent allowed by applicable law, Beach City police powers to the extent necessary or desirable to perform the law enforcement services herein during the agreement period

# 17. Discuss and consider 50th Anniversary celebration of Beach City's Incorporation

Assistant Secretary Marge Bercaw stated that she will be interviewing former City Secretary Margaret Gainer and former Alderman Rita Standridge hopes of gathering more Beach City history for the celebration. The 50<sup>th</sup> celebration is scheduled for April 23<sup>rd</sup>, 2016.

#### 18. Update on legal action for non compliance to City ordinances

The City now has an Interlocal Agreement with the Chambers County Sheriff's Department. The property on Ocean Drive is waiting on a court date to be scheduled after the first of the year. The City Prosecutor will set this date up with Judge Cryer.

There is a property in Bayridge Subdivision that has received several complaints. The owner has been cleaning up and removing the abandoned cars.
