

BLAKELY BOROUGH
ORDINANCE NO. 11 OF 2021

AN ORDINANCE PROVIDING FOR AMENDMENTS TO THE BLAKELY BOROUGH
REFUSE GARBAGE FEE ORDINANCE NO. 3-06

BE IT ORDAINED by the Blakely Borough Council, and it is hereby ordained by the Blakely Borough Council, that Ordinance No. 3-06 is amended as follows:

1. Section 2 of Ordinance No. 3-06 is amended to read as follows:

The fees for the collection and disposal of appliances, ashes, garbage, recyclables, refuse, rubbish, tires, white goods and yard waste placed for collection pursuant to the provisions of this Ordinance for the calendar year 2022 are as follows:

- (a) For single-family dwellings, the sum of \$200 per year per family payable in full by June 30th of every year.
- (b) For an apartment dwelling entitled to collection pursuant to the provisions of Ordinance 3-06, the sum of \$200 per unit payable in full by June 30th of every year.
- (c) Passenger vehicles and small truck tires shall have a sticker costing \$5.00 prominently displayed.
- (d) All tires larger than passenger vehicle tires, such as large truck tires, bus tires, etc., shall have three stickers, at a cost of \$15.00 prominently displayed.
- (e) White goods or appliances shall have a sticker costing \$5.00 prominently displayed.
- (g) Dumpster/containers supplied by the Borough of Blakely shall be provided at a cost of \$200.00 per each and every time it is filled and dumped. Fees for this service must be paid in full prior to the dumpster/container being delivered or reused.
- (h) Large furniture shall have a \$5.00 sticker.
- (i) Small furniture shall have a \$2.00 sticker.
- (j) Mattresses shall pay a \$10.00 sticker fee and be in a plastic bag for pickup.
- (k) Box springs shall pay a \$5.00 sticker fee and be in a plastic bag for pickup.
- (l) Mattress/Box Springs bags can be purchased at the borough for \$5.00 each.
- (m) Yard Waste/Leaf bags can be purchased at the borough for \$0.50 each.

All accounts referenced in paragraphs (a) and (b) shall be due and payable by the owners of the real estate, and if the same be unpaid after June 30th, the said account shall be considered delinquent. Thereafter, the owners of the real estate shall be subject to the fines set forth in Ordinance No. 10-08, the provisions of which are incorporated herein by reference as though fully set forth at length.

2. Section 3 of Ordinance No. 3-06 is amended to read as follows:

Each commercial establishment located within the Borough of Blakely contracting with its own private hauler for the collection and disposal of appliances, ashes, garbage, recyclables, refuse, rubbish, tires, white goods and yard waste for the calendar year 2022 shall continue to do so. Commercial customers currently utilizing the trash pickup services of the Borough of Blakely shall have their fees remain the same.


3. All other provisions of Ordinance 3-06 shall remain in full force and effect.

4. This Ordinance shall be effective January 1, 2022.


