Electrical Permit Fee Schedule & Information

Cambridge Township, Lenawee County

Cambridge Township issues building, electrical, plumbing and mechanical permits. If work for which a permit is issued is not started within six (6) months of being issued, or if the work is abandoned for a period of six (6) months, the permit may lapse and cease to be in effect. In the absence of any inspections over a six (6) month period the Township shall cause the premises to be inspected to ascertain the work status. The respective permit applicant will be assessed an eighty (\$80) dollar inspection fee to reimburse the cost of such status inspection. In the event the permit lapses, any unexpended amounts of the permit fee shall be used to defray related costs. If a permit has lapsed, no further work shall take place until a new permit for the remaining work has been issued in accordance with the Township fee schedule. If the applicant communicates and explains the need for an extension prior to expiration one will be granted.

***PERMIT COSTS ARE BASED ON AN ESTIMATED NUMBER OF INSPECTIONS AND AN EIGHTY (\$80) DOLLAR PER INSPECTION FEE. ADDITIONAL INSPECTIONS WILL BE CHARGED OVER AND ABOVE THE INITIAL PERMIT FEE AND PAID PRIOR TO FINAL APPROVAL. SITE VISITS WHERE WORK HAS STARTED PRIOR TO THE PERMIT BEING OBTAINED WILL BE CHARGED AS AN INSPECTION. FINAL APPROVAL AND/OR A CERTIFICATE OF OCCUPANCY MUST BE ISSUED PRIOR TO USE OF PERMITTED EQUIPMENT AND/OR AREA. PLEASE ALLOW 2 BUSINESS DAYS FOR THE INSPECTION.**
