

CAMBRIDGE TOWNSHIP  
REGULAR MEETING  
MAY 8, 2013

The meeting was called to order by the supervisor at 7:00 P.M. with the pledge to the flag.

Roll call showed the following members present: Hawkins, Richardson, Johncox, Gentner, Garrison.

Motion by Johncox, supported by Gentner to approve the minutes of the previous meeting. Motion carried unanimously.

Motion by Garrison, supported by Gentner to approve the treasurer's report. Motion carried unanimously.

Motion by Richardson, supported by Garrison to approve P.O. request for the cemetery for a six-month renewal of record search software at \$150. Motion carried unanimously.

Motion by Gentner, supported by Richardson to approve P.O. request for the fire department for 800 feet of 1 ¾ inch hose at a cost of \$2,692.87. Motion carried unanimously.

Motion by Garrison, supported by Johncox to approve P.O. request of the office for a new postage machine at a cost of \$242.31 per quarter for five years-which replaces a five-year old machine currently costing \$351.00 per quarter. Motion carried unanimously.

Motion by Johncox, supported by Gentner to approve P.O. request of police department for \$150 for two sets of "belly chains" which are used to restrain prisoners during transport to jail. Motion carried unanimously.

Motion by Johncox, supported by Gentner to approve payment of bills as follows: \$133,698.55 in bills paid since the last meeting (\$120,876.39 of which is the deposit on approved road contracts for this year), and \$28,055.29 in current month bills. Motion carried unanimously.

The monthly police report was given by Chief Wibbeler. Motion by Richardson, supported by Johncox to approve. Motion carried unanimously.

Chief Wibbeler also asked for board authorization to have the township attorney(s) research and draft language for two ordinances-one for regulation of marihuana care givers and one for use of surveillance equipment. Motion by Richardson, supported by Johncox to approve. Motion carried unanimously.

The monthly fire report was given by Asst. Chief Armstrong. Motion by Johncox, supported by Gentner to approve. Motion carried unanimously.

The monthly zoning report was reviewed by the supervisor. Motion by Garrison, supported by Richardson to approve. Motion carried unanimously.

Correspondence was read.

There was no county commission report this month.

Motion by Gentner, supported by Garrison to approve the rezoning request of Richard Chitwood for a 2.6-acre parcel in the 11000 block of Onsted Highway (parcel #CA0-109-2580) to rezone from Agricultural (AG-1) to Suburban Residential (RS-1). Motion carried unanimously.

Motion by Johncox, supported by Garrison to approve the zoning ordinance amendments for Section 5.15-Fences, as recommended by the planning commission and Region 2. Motion carried unanimously.

Motion by Gentner, supported by Garrison to approve the fireworks permit application from the Loch Erin Property Owners Association for their July display. Motion carried unanimously.

Motion by Garrison, supported by Richardson to approve a 3-year payment plan agreement with the Lenawee County Road Commission for the resurfacing of the roads in the Wadding Dr./Sherlock Dr. area of Loch Erin, with each payment to be \$32,571.23. Motion carried unanimously.

Public comment was received.

Motion by Richardson, supported by Johncox to adjourn. Motion carried unanimously and meeting was adjourned at 7:30 P.M.
