REGULAR BOARD MEETING
OCTOBER 14, 2015

The meeting was called to order by the supervisor at 7:00 P.M. with the pledge to the flag.

Roll call: present-Hawkins, Richardson, Johncox, Gentner, Garrison.

Motion by Gentner, supported by Johncox to approve the minutes of the previous meeting. Motion carried unanimously.

Motion by Richardson, supported by Gentner to approve the treasurer's report as presented. Motion carried unanimously.

Motion by Richardson, supported by Gentner to approve the bid from Green Borders for lawn care services at the township hall for 2016. Motion carried unanimously.

Motion by Gentner, supported by Garrison to approve P.O. requests from the police department as follows: \$500 for uniforms, and for the lease on the 2016 Dodge Charger at approximately \$9,197 per year for three years. Motion carried unanimously.

Motion by Johncox, supported by Gentner to approve payment of bills as follows: \$15,602.44 in bills paid since the last meeting and \$66,438.57 in current month bills. Motion carried unanimously.

The monthly police report was given by Chief Wibbeler. Motion by Richardson, supported by Garrison to approve. Motion carried unanimously.

The monthly fire report was reviewed by the supervisor in the absence of the fire chief. Motion by Gentner, supported by Johncox to approve. Motion carried unanimously.

The monthly zoning report was given by zoning officer Rick Arnold. Motion by Garrison, supported by Gentner to approve. Motion carried unanimously.

Motion by Garrison, supported by Richardson to approve the building committee meeting minutes from September 9, 2015. Motion carried unanimously.

Correspondence was noted.

County commissioner John Lapham reported on county business.

Motion by Gentner, supported by Johncox to adopt resolution confirming the increase in the assessment roll for the Washington Lake Road Maintenance special assessment district, with the per lot assessment going from \$165 to \$248 for 2015 and 2016. Roll call vote: ayes-Gentner, Garrison, Johncox, Richardson, Hawkins; nays-none. Resolution declared adopted.

Motion by Gentner, supported by Richardson to adopt resolution to collect taxes for 2015. Roll call vote: ayes-Gentner, Garrison, Johncox, Richardson, Hawkins; nays-none. Resolution declared adopted.

Motion by Johncox, supported by Gentner to approve the conditional use permit application of Gary Marzolf for outdoor boat storage on property located at 7315 Onsted Highway, per the terms recommended by the planning commission. Motion carried unanimously.

Motion by Gentner, supported by Richardson to approve the list of holiday office closings for the 2015-16 holidays. Motion carried unanimously.

Public comment was received.

Motion by Gentner, supported by Johncox to adjourn. Motion carried and meeting adjourned at 7:32 P.M.
