REGULAR MEETING  
JANUARY 11, 2017

The meeting was called to order by the supervisor at 7:00 P.M. with the pledge to the flag.

A limited public comment period was allowed.

Roll call: present-Gentner, Richardson, Johncox, Kissel, Garrison

Motion by Garrison, supported by Kissel to approve the minutes of the previous meeting. Motion carried unanimously.

Motion by Kissel, supported by Richardson to approve the treasurer's report as presented. Motion carried unanimously.

Motion by Johncox, supported by Kissel to approve P.O. request of fire department of \$400 for a truck extrication class for a fire officer. Motion carried unanimously.

Motion by Garrison, supported by Kissel to approve the P.O. request of the township hall to change out the metal halide lights in the parking lot, flagpole light and sign light to LED's per the quote of \$4,890 from AEG in Adrian, MI. Motion carried unanimously. There will also be an approximate \$378 rebate from Consumers Energy for this project.

Motion by Garrison, supported by Kissel to approve the P.O. request of the township hall to clean and fill the expansion cracks in the parking lot for \$2,500. Motion carried unanimously.

Motion by Johncox, supported by Richardson to approve the P.O. request of the police department for \$1,365 to replace the computer in the squad room. Motion carried unanimously.

Motion by Johncox, supported by Kissel to approve payment of bills as follows: \$16,526.08 in bills paid since the last meeting and \$68,331.27 in current month bills. Motion carried unanimously.

The monthly police report was given by Officer Angela Mason in the absence of Chief Paterson. Motion by Garrison, supported by Kissel to approve. Motion carried unanimously.

The monthly fire report was given by Chief Damon. Motion by Johncox, supported by Kissel to approve. Motion carried unanimously.

The monthly zoning report was given by zoning officer Arnold. Motion by Kissel, supported by Garrison to approve. Motion carried unanimously.

Motion by Richardson, supported by Kissel to approve the minutes of the December 14, 2016 building department meeting. Motion carried unanimously.

Correspondence was read.

County commissioner John Lapham gave an update on county business.

Motion by Johncox, supported by Kissel to approve the 2017 summer tax collection agreement with JISD. Motion carried unanimously.

Motion by Johncox, supported by Garrison to adopt resolution setting the poverty exemption income guidelines for 2017. Roll call vote: ayes-Johncox, Richardson, Gentner, Kissel, Garrison; nays-none. Resolution declared adopted.

Motion by Richardson, supported by Garrison to approve the three PA-116 agreement applications from J & W Warner Farms. Motion carried unanimously.

Motion by Garrison, supported by Kissel to approve the 2017 fireworks permit application for the Sand Lake Property Owners Association. Motion carried unanimously.
