

Cambridge Township
Regular Board Meeting
February 14, 2018

The meeting was called to order by the supervisor at 7:00 P.M. with the pledge to the flag.

A period of limited public comment was allowed.

Roll call was as follows: present-Gentner, Richardson, Johncox, Kissel, Garrison.

Motion by Garrison, supported by Kissel to approve the minutes of the previous meeting. Motion carried unanimously.

Motion by Garrison, supported by Kissel to approve the treasurer's report as presented. Motion carried unanimously.

Motion by Kissel, supported by Richardson to approve P.O. requests for the fire department as follows: \$3,000 for uniform shirts, \$3,176 for the chief and assistant chief to attend the FDIC conference, \$1,766 for one set of turnout gear. Motion carried unanimously.

Motion by Johncox, supported by Kissel to approve P.O. request from the office for \$1,518 for the supervisor and clerk to attend the annual MTA conference in April. Motion carried unanimously.

Motion by Kissel, supported by Johncox to approve payment of bills as follows: \$14,245.91 in bills paid since the last meeting and \$33,887.44 in current month bills. Motion carried unanimously.

The monthly police report was given by Chief Paterson. Motion by Kissel, supported by Johncox to approve. Motion carried unanimously.

The monthly fire report was reviewed by the supervisor. Motion by Richardson, supported by Kissel to approve. Motion carried unanimously.

The monthly zoning report was given by zoning officer Arnold. Motion by Garrison, supported by Kissel to approve. Motion carried unanimously.

Correspondence was noted.

Motion by Richardson, supported by Kissel to advise the Lenawee County Road Commission that it is the understanding of Cambridge Township that all of Oak Hill Road as it appears in the Plat of Irish Hills Village is public, and that the certification map should be corrected accordingly. Motion carried unanimously.

Motion by Johncox, supported by Garrison to adopt Ordinance #18-01, the Code of Ordinances for Cambridge Township. Roll call vote: ayes-Johncox, Richardson, Gentner, Kissel, Garrison; nays-none. Ordinance #18-01 declared adopted.

Motion by Garrison, supported by Kissel to approve the installation of an LED street light at the intersection of US-12 and Person Hwy. at a cost of \$190. Motion carried unanimously.

Motion by Kissel, supported by Richardson to approve the 2018 budgets for the sewer and water systems as recommended by the Lenawee County Drain Commission. Motion carried unanimously.

Public comment was received.

Motion by Richardson, supported by Kissel to adjourn. Motion carried and meeting was adjourned at 7:25 P.M.
