REGULAR MEETING
OCTOBER 9, 2019

The meeting was called to order by the supervisor at 7:00 P.M. with the pledge to the flag.

A period of limited public comment was allowed.

Roll call: present-Gentner, Richardson, Johncox, Kissel, Garrison.

Motion by Garrison, supported by Kissel to approve the minutes of the September 11, 2019 regular meeting as presented. Motion carried unanimously.

Motion by Kissel, supported by Garrison to approve the treasurer's report as presented. Motion carried unanimously.

Motion by Richardson, supported by Kissel to approve the P.O. requests from the fire department as follows: \$11,400 to replace the three overhead doors and openers in the basement truck bays, and \$49,563 for the 2020 Ford Chassis to replace Squad 10. Motion carried unanimously.

Motion by Kissel, supported by Johncox to approve the payment of bills as follows: \$5,678.83 in bills paid since the last meeting and \$55,679.23 in current month bills. Motion carried unanimously.

The monthly police report was given by Chief Paterson. Motion by Kissel, supported by Richardson to approve. Motion carried unanimously.

The monthly fire report was given by Chief Damon. Motion by Richardson, supported by Kissel to approve. Motion carried unanimously.

The monthly zoning report was given by zoning officer Arnold. Motion by Garrison, supported by Kissel to approve. Motion carried unanimously.

Correspondence was noted.

County commissioner Lapham reported on county business.

Motion by Kissel, supported by Johncox to approve the six PA-116 applications for John and Charlotte Garrison. Motion carried unanimously.

Motion by Johncox, supported by Kissel to adopt Ordinance #19-09 which amends certain sections of Ordinance Chapter 12-Cemeteries. Roll call vote: ayes-Johncox, Richardson, Gentner, Kissel, Garrison; nays-none. Ordinance declared adopted.

Motion by Garrison, supported by Kissel to approve the land division application from Traditional Catholics of New Hampshire for four divisions off of parcel #CA0-111-4100 located on Brighton Highway, contingent on receiving the required driveway approvals. Motion carried unanimously.

Motion by Richardson, supported by Kissel to approve the renewal of the health insurance plan for 2020 as proposed by the agent. Motion carried unanimously.

Motion by Kissel, supported by Richardson to approve opting out of the requirements of PA-152 of 2011 for the employees share of health insurance premiums for 2020. Motion carried unanimously.

Motion by Kissel, supported by Garrison to adopt the resolution to collect winter taxes for 2019 as presented by the treasurer. Roll call vote: ayes-Kissel, Garrison, Johncox, Richardson, Gentner; nays-none. Resolution declared adopted.

Motion by Garrison, supported by Kissel to adopt resolution supporting the start of work on forming a new sewer authority among the municipalities currently in the LRUA (Leoni Regional Utility Authority). Roll call vote: ayes-Garrison, Kissel, Gentner, Richardson, Johncox; nays-none. Resolution declared adopted.

Motion by Kissel, supported by Johncox to adopt resolution to approve the amendment to the Articles of Incorporation for the current LRUA. Roll call vote: ayes-Kissel, Garrison, Johncox, Richardson, Gentner; nays-none. Resolution declared adopted.

Motion by Richardson, supported by Kissel to approve the schedule of holiday office closings for 2019-2020. Motion carried unanimously.

Public comment was received.

Motion by Kissel, supported by Garrison to adjourn. Motion carried unanimously and meeting adjourned at 7:45 P.M.
