REGULAR BOARD MEETING
JANUARY 8, 2020

The meeting was called to order by the supervisor at 7:00 P.M. with the pledge to the flag.

A period of limited public comment was allowed.

Roll call of board members: present-Gentner, Richardson, Johncox, Kissel, Garrison.

Motion by Garrison, supported by Kissel to approve the minutes of the December 11, 2019 regular meeting and the December 17, 2019 special meeting. Motion carried unanimously.

Motion by Kissel, supported by Richardson to approve the treasurer's report as presented. Motion carried unanimously.

Motion by Johncox, supported by Kissel to approve P.O. requests from the office as follows: \$1,412 to replace the deputy clerk's computer, \$1,711 for the supervisor and clerk to attend the MTA annual conference in April, and \$410 to send the board of review members to training. Motion carried unanimously.

Motion by Johncox, supported by Kissel to approve payment of bills as follows: \$15,266.59 in bills paid since the last meeting and \$39,947.54 in current month bills. Motion carried unanimously.

The monthly police report was given by Chief Paterson. Motion by Garrison, supported by Kissel to approve. Motion carried unanimously.

The monthly fire report was given by Asst. Chief Armstrong. Motion by Garrison, supported by Kissel to approve. Motion carried unanimously.

The monthly zoning report was given by zoning officer Arnold. Motion by Kissel, supported by Johncox to approve. Motion carried unanimously.

Correspondence was noted.

The county commissioner was not able to attend this month's meeting.

Motion by Garrison, supported by Kissel to adopt the resolution to collect 2020 summer taxes for Columbia Schools. Roll call vote: ayes-Garrison, Kissel, Gentner, Richardson, Johncox; nays-none. Resolution declared adopted.

Motion by Garrison, supported by Kissel to adopt the resolution to collect 2020 summer taxes for Jackson Intermediate School District. Roll call vote: ayes-Garrison, Kissel, Gentner, Richardson, Johncox; nays-none. Resolution declared adopted.

Motion by Kissel, supported by Johncox to adopt resolution moving the start date of the March board of review from Monday, March 9, 2020 to Wednesday, March 11, 2020 due to the conflict with the Presidential Primary Election. Roll call vote: ayes-Kissel, Garrison, Johncox, Richardson, Gentner; nays-none. Resolution declared adopted.

Motion by Kissel, supported by Johncox to move the date of the March, 2020 regular board meeting to March 4, 2020 due to the same conflict with the election. Motion carried unanimously.

Motion by Richardson, supported by Kissel to adopt the Medical Marihuana Facilities Ordinance, allowing specific medical marihuana facilities-secure transporters and safety compliance facilities. Roll call vote: ayes-Richardson, Johncox, Garrison, Kissel, Gentner; nays-none. Ordinance adopted.

Motion by Kissel, supported by Garrison to adopt the Recreational Marihuana Establishments Ordinance, allowing specific recreational marihuana establishments-secure transporters and safety compliance facilities. Roll call vote: ayes-Kissel, Garrison, Johncox, Richardson, Gentner; nays-none. Ordinance adopted.

Motion by Garrison, supported by Kissel to set the date of the budget workshop for Monday, February 17, 2020 at 8:00 A.M. and the date of the budget public hearing for Wednesday, March 4, 2020 at 6:30 P.M. Motion carried unanimously.

A public comment period was allowed.

Motion by Kissel, supported by Johncox to adjourn. Motion carried and meeting adjourned at 7:30 P.M.
