

CAMBRIDGE TOWNSHIP
SPECIAL MEETING-BUDGET WORKSHOP
FEBRUARY 15, 2021

The meeting was called to order by the supervisor at 9:00 A.M.

Board members present: W. Gentner, Roesch, Rohrbach, N. Gentner and Garrison.

The meeting started with the balance of the general fund departments being reviewed, including wage discussions.

Motion by Garrison, supported by W. Gentner to increase the hourly wage of Pat Steele by 3%. Motion carried unanimously.

Motion by W. Gentner, supported by Garrison to increase the hourly wage of Brenda Imm by 3%. Motion carried, 4-yes, N. Gentner- no.

Motion by N. Gentner, supported by Roesch to increase Brenda Imm's hourly rate by \$.50/hour above the 3% previously approved. Motion carried, 3-yes, W. Gentner and Garrison-no.

Motion by N. Gentner, supported by W. Gentner to increase the fire chief's salary by 10%. Motion failed, 2-yes, Roesch, Rohrbach, and Garrison-no.

Motion by Garrison, supported by Rohrbach to increase the fire chief's and assistant fire chief's salary by 3% effective April 1, 2021. Motion carried unanimously.

Motion by N. Gentner, supported by Garrison to increase the fire-on-call hourly rate for firefighters by 3%. Motion carried unanimously.

Motion by Garrison, supported by Roesch to pay fire-on-call time and a half for the following holidays; New Year's Day, Easter, 4th of July, Thanksgiving, and Christmas. Motion carried unanimously.

Motion by W. Gentner, supported by Rohrbach to increase the police chief's salary by 10% effective April 1, 2021. Motion carried, 4-yes, Roesch-no.

Motion by Roesch, supported by W. Gentner to increase the hourly rate of the Sergeant and Full-time police officers' positions by 5%. Motion carried unanimously.

Motion by Roesch, supported by N. Gentner to increase the police department dispatcher/secretary hourly wage by 3%. Motion carried unanimously.

Motion by Roesch, supported by W. Gentner to increase the hourly rate of the Part-time police officers to \$21.50/hour. Motion carried unanimously.

Motion by Roesch, supported by N. Gentner approve the hourly rate of the deputy treasurer at \$15.00/hr with a maximum of 420 hours per year. Motion carried unanimously.

Motion was made by Garrison, supported by W. Gentner to increase the hourly wage of the Rick Arnold by 3%. Motion carried unanimously.

Motion was made by Garrison, supported by N. Gentner to pay the Mechanical and Plumbing Inspector a \$20/ month phone allowance that was recommended by the building official. Motion carried unanimously.

Motion by Garrison, supported by Roesch to change the Fee schedule to reflect a Zoning Compliance Permit fee of \$10 per application. Motion carried unanimously.

Motion by Roesch, supported by N. Gentner to adjourn. Motion carried and meeting adjourned at 3:31 P.M.
