May 28, 2024**

Meeting called to order at 7:00 p.m. by Mayor Brenda Krzak.

24-080 P Motion by Kendzierski, seconded by Jedrzejczak to approve the agenda as amended, reversing 10A1 and 10B2, and adding 10 C1- Roles and Responsibilities. **PASSED**

24-081 P Motion by Kendzierski, seconded by Krosnicki to approve the council meeting minutes of May 13, 2024 as presented. **PASSED**

24-082 P Motion by Kendzierski, seconded by Jedrzejczak to approve bills and draw checks for the same. *Roll call vote, Ayes: Hazel, Jedrzejczak, Kendzierski, Krosnicki, Middleton, and O'Brien. Nays: none.* **PASSED**

Public Comments on agenda items -

Kim Hortop, 114 McColl St- In regard to the water/sewer rates, could COVID funds be used?

Madison Dupuis, 202 S Main St- Has almost been hit 4 times walking to and from school at the intersection of Main St/North St and Park Avenue. Is it possible to get a crossing guard?

Student Advisor Report- Students have less than 2 weeks of school left, many awards ceremonies and student exams will be taking place. Geometry and Construction class is still working on building structures for the school district. Student Council and Class Officer elections are taking place for next school year. Eight students from track and field will compete for state titles, and the girls soccer team will compete in the second round of districts against Almont. The new Student Advisor to City Council will be Raegan Majcher, she will be present for meetings during first semester, and Keirra Taube will take over for second semester.

City Manager's Report-The new Blue Cross broker will be on site June 6th for benefits education. Drafted a letter of interest for a new EGLE Justice Impact grant. Extended heartfelt appreciation to Joe and Amanda of MRWA for all of their hard work with the water rate study. Kudos to Officer Travis Summerer for being the first officer in St. Clair County to obtain a Red Flag warrant. A representative from MRWA was on site recently to conduct an energy evaluation of our water and sewer systems.

24-083 P Motion by Hazel, seconded by Kendzierski to purchase SCADA for an initial cost of \$54,265.00, with an additional yearly fee of 2,650.00 which will increase annually. *Roll call vote, Ayes: Jedrzejczak, Kendzierski, Krosnicki, Middleton, O'Brien and Hazel. Nays: none. PASSED*

24-084 P Motion by Kendzierski, seconded by Hazel to accept the water/sewer rate study as presented by MRWA, and to implement the rates on the billing for July usage. *Roll call vote, Ayes: Kendzierski, Krosnicki, Middleton, Hazel, and Jedrzejczak. Nays: O'Brien. PASSED*

24-085 P Motion by Hazel, seconded by Krosnicki to begin the bid process for park renovation labor & equipment as per the park committee's recommendation. **PASSED**

At this time, Council again discussed what would be done with the 2011 Dodge Charger. Council directed City Manager Natke to obtain a quote for removing all police upfitting from the vehicle.
