This Title XV includes the City's Zoning and Subdivision Ordinances. The City Council also hereby adopts the 2015 update to the City's **Zoning Map**, which accompanies the Zoning Ordinances.

This ordinance shall be effective the later of January 1, 2016, or its date of summary publication, which is hereby authorized by the City Council.
