

**ORDINANCE NO. 100-22**

**AN ORDINANCE TO AMEND SECTION 1 OF ORDINANCE NO. 133-07, ESTABLISHING THE MAXIMUM RATES OF PAY FOR THE FOLLOWING PART-TIME POSITIONS AS FURTHER DESCRIBED IN SECTION 1 BELOW, EFFECTIVE JANUARY 1, 2022, AND DECLARING AN EMERGENCY.**

BE IT ORDAINED, by the City of Conneaut, County of Ashtabula and State of Ohio:

SECTION 1. That Section 1 of Ordinance No. 133-07 is hereby amended to read as follows:

“SECTION 1. That the following maximum rates of pay are hereby established for the following part-time positions, effective January 1, 2022:

Part-Time Utility Inspector	\$18.62 per hour
Part-Time Clerk/Admin. Assistant	\$12.57-\$18.56 per hour **
Part-Time Corrections Officer	\$17.48 per hour
Seasonal Laborer 1	\$12.24 per hour
Seasonal Laborer 2	\$13.26 per hour
Utility/Part-Time Firefighters	\$11.90-\$18.28 per hour *
Animal Control Officer	\$15.14 per hour
Part-Time Records Clerk	\$12.55 per hour
Part-Time Dispatchers	\$20.18 per hour
Part-Time Planning/Zoning Manager	\$12.57-\$18.56 per hour **
Part-Time CHIP Coordinator	\$7,833.00 per year***

\* - Said pay rate shall be dependent upon training and experience. The rate of pay shall be determined by the City Manager based upon the recommendation of the Safety Director and/or Fire Chief.

\*\* - Said pay rate shall be dependent upon training and experience. The rate of pay shall be determined by the City Manager.

\*\*\* - Position is funded through CHIP grant and paid according to CHIP written guidelines.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is declared to be an emergency measure in the interests of public peace, health and safety, and shall take effect immediately upon the signing of the President of Council.
