

ORDINANCE NO. 119-23

AN ORDINANCE TO CLOSE THE FOLLOWING STREETS ON NOVEMBER 24, 2023 FROM 5:00PM TO 9:00PM FOR THE PURPOSE OF HOSTING THE CONNEAUT CHRISTMAS PARADE, AND NOT DECLARING AN EMERGENCY.

BE IT ORDAINED, by the City of Conneaut, County of Ashtabula and State of Ohio:

SECTION 1. That the following streets shall be closed on Friday, November 24, 2023 from 5:00-9:00PM for the purpose of the Conneaut Christmas Parade.

PARADE ROUTE: The parade will line up at Conneaut High School on Jackson Street and go from Jackson to Broad Street then to State Street, from State Street to Harbor Street, from Harbor Street to Main Street and from Main Street to Sandusky Street.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is not declared to be an emergency measure in the interests of public peace, health and safety and, shall take effect thirty (30) days after passage.
