

ORDINANCE NO. 139-23

AN ORDINANCE TO AMEND SECTION 1 OF ORDINANCE NO. 21-04, TO SET THE MAXIMUM RATES OF PAY EFFECTIVE AS OF JANUARY 1, 2023 FOR SAID POSITIONS, AS FURTHER DESCRIBED IN SECTION 1 BELOW, AND DECLARING AN EMERGENCY.

BE IT ORDAINED, by the City of Conneaut, County of Ashtabula and State of Ohio:

SECTION 1. That Section 1 of Ordinance No. 21-04, to set the maximum rates of pay effective as of January 1, 2023 for said positions is hereby amended to read as follows:

“SECTION 1. Salaries – That effective January 1, 2004, the following positions are determined to be in the unclassified service of the City of Conneaut as further defined in Chapter 157 of the Codified Ordinances. The annual maximum salaries are hereby established for the positions as follows:

The rate of pay for each position shall be determined by the City Manager and shall not exceed the maximum rate of pay established herein.

(*) Said position is vacant.

(**) Said position may be in addition to another position

(1) An additional \$5,000.00 is funded and paid by Ashtabula County directly to the Law Director for County services.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is declared to be an emergency measure in the interests of public peace, health and safety, and shall take effect immediately upon passage and signing by the President of Council.
