

## ORDINANCE NO. 23-21

AN ORDINANCE TO AUTHORIZE THE CITY MANAGER TO AWARD THE BID AND ENTER INTO CONTRACT WITH KLINGINSMITH ENTERPRISES, INC. FOR THE WEST MAIN WATERLINE PHASE II PROJECT AT A PRICE NOT TO EXCEED \$389,123.25, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Conneaut has received bids for the West Main Waterline Phase II Project and Klinginsmith Enterprises, Inc. has submitted the lowest and best bid with a bid price of \$389,123.25.


BE IT ORDAINED, by the City of Conneaut, County of Ashtabula and State of Ohio:

SECTION 1. That the City Manager is hereby authorized to award the bid and enter into contract with Klinginsmith Enterprises, Inc. for the West Main Waterline Phase II Project for the bid price of \$389,123.25

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is declared to be an emergency measure in the interests of public peace, health and safety, and to complete the Project as soon as possible, and if approved, shall take effect immediately upon passage.

ORDINANCE NO. 13-21

AN ORDINANCE TO AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT WITH THE CITY OF WEST PALM BEACH FOR THE WEST PALM BEACH TRASH PLANT AT A COST NOT TO EXCEED \$280,000.00 AND BEING PART OF THE BUDGET FOR THE YEAR 2013-2014.


WHEREAS, the City of West Palm Beach has received bids for the West Palm Beach Trash Plant at a cost not to exceed \$280,000.00 and has selected the lowest and best bid for the same; and


IT IS ENACTED by the City of West Palm Beach that the City Manager is hereby authorized to execute and enter into a contract with the City of West Palm Beach for the West Palm Beach Trash Plant at a cost not to exceed \$280,000.00.

SECTION 2. That it is hereby ordered that all current actions of the City Council concerning and relating to the passage of this ordinance be rescinded and that the City Council of the City of West Palm Beach be notified of such rescission in writing by the City Manager in accordance with the provisions of the City Charter, Section 2.2 of the City Charter.

SECTION 3. This ordinance is deemed to be an emergency measure in that it is necessary for the health, safety and general welfare of the City of West Palm Beach and it is hereby enacted that this ordinance shall take effect immediately upon passage.
