

RESOLUTION NO. 43-24

A RESOLUTION TO PROMOTE PEDESTRIAN SAFETY AND AWARENESS WITHIN THE CITY OF CONNEAUT.

WHEREAS, this Council has received a petition from residents of the City of Conneaut requesting additional safety measures at the crosswalk at the intersection of Route 20 and Harbor Street; and

WHEREAS, the Public Safety Committee and this Council have researched and discussed their options to install additional signage in the area to make it safer for pedestrians, especially those residing at the Conneaut Manor; and

WHEREAS, the City is dedicated to making its streets safer for pedestrians and drivers alike and has implemented a plan to install additional crosswalk signage.

NOW, THEREFORE BE IT RESOLVED, by the City of Conneaut, County of Ashtabula and State of Ohio:

SECTION 1. On behalf of the residents of the City of Conneaut, this Council declares its intent to improve the crosswalk at the intersection of Route 20 and Harbor Street for the safety of pedestrians and drivers, in response to the petition attached hereto and marked "Exhibit A".

SECTION 2. This Council hereby encourages the residents of the City of Conneaut to stay alert while driving and while crossing public roadways in an effort to keep our roads safe.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
