ORDINANCE NO. 52-21

(FINAL)

AN ORDINANCE AMENDING SECTION 3.6 OF THE CITY MANAGER'S CONTRACT TO INCREASE THE PERCENTAGE OF OPERS "PICK-UP", EFFECTIVE JULY 17, 2021, AND REPEALING ORDINANCE NO. 46-21, AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 42-92 authorized the City to "pick-up" four percent (4%) of the statutorily required contributions to OPERS for City employees, including the City Manager; and

WHEREAS, Ordinance No. 49-18 authorized the City to "pick-up" five percent (5%) of the statutorily required contributions to OPERS for the City Manager; and

WHEREAS, City Council has agreed to increase the OPERS "pick-up" for the City Manager from 5% to 10%, effective July 17, 2021.

BE IT ORDAINED, by the City of Conneaut, County of Ashtabula and State of Ohio:

SECTION 1. That Section 3.6 – Retirement Benefit – of the City Manager's Contract with the City of Conneaut is hereby amended, effective July 17, 2021, to read as follows:

"3.6 RETIREMENT BENEFIT. The City agrees to enroll the Manager into the applicable state or local retirement system and to make at least the same level of contributions for the Manager or on the Manager's behalf as the City does for its other administrative employees consistent with all Applicable Laws and Authorities. The City agrees to pay on behalf of the Manager, the percent (10%) of the employee contributions to OPERS."

SECTION 2. That Ordinance No. 46-21 is hereby repealed.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this Ordinance is declared to be an emergency measure in the interests of public peace, health and safety and, shall take effect immediately upon passage.
