

## ORDINANCE NO. 59-23

AN ORDINANCE AUTHORIZING THE FINANCE DIRECTOR TO CERTIFY  
A LIST OF DELINQUENT GRASS CUTTING BILLS TO THE COUNTY  
AUDITOR FOR REAL ESTATE ASSESSMENT, PURSUANT TO SECTION  
731.54 OF THE OHIO REVISED CODE AND SECTION 1377.07 OF THE  
CODIFIED ORDINANCES OF THE CITY OF CONNEAUT, AND  
DECLARING AN EMERGENCY

NOW, THEREFORE BE IT ORDAINED, by the City of Conneaut, County of Ashtabula  
and State of Ohio:

SECTION 1. The Finance Director is hereby authorized to certify to the Ashtabula County Auditor a list of landowners with delinquent grass cutting bills, attached hereto as Exhibit A, for real estate tax assessment, pursuant to Section 731.54 of the Ohio Revised Code and Section 1377.07 of the Codified Ordinances of the City of Conneaut. Each delinquency is to be assessed and paid within one (1) year.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is declared to be an emergency measure in the interests of public peace, health and safety and shall take effect immediately upon passage and signing by the President of Council.
