

RESOLUTION NO. 65-23

A RESOLUTION DECLARING THE NECESSITY OF A RENEWAL LEVY IN EXCESS OF THE TEN (10) MILL LIMITATION IN THE AMOUNT OF 1.90 MILLS FOR A FIVE-YEAR PERIOD COMMENCING WITH TAX YEAR 2024 TO BE COLLECTED IN 2025 AT THE GENERAL ELECTION TO BE HELD NOVEMBER 7, 2023 FOR THE BENEFIT OF THE CONNEAUT PUBLIC LIBRARY, AND REQUESTING THE ASHTABULA COUNTY AUDITOR TO CERTIFY THE TOTAL CURRENT TAX VALUATION OF THE CITY AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY THE RENEWAL LEVY, AND DECLARING AN EMERGENCY.

WHEREAS, on May 25, 2023, the Board of Trustees of the Conneaut Public Library, Ashtabula County, Ohio, a municipal library subject to the jurisdiction of the City of Conneaut, passed a resolution requesting that this legislative body, as a taxing authority for said library, to place a question of a one and ninety one-hundredths (1.90) mill tax renewal levy for operating expenses of the Conneaut Public Library on the ballot at the General Election on November 7, 2023; and

WHEREAS, in accordance with Division (B) of Section 5705.03 of the Ohio Revised Code, in order to submit the question of a tax levy pursuant to Sections 5705.19(D) and 5705.191 of the Ohio Revised Code, this Council is required to request that the Ashtabula County Auditor certify (i) the total current tax valuation of the City and (ii) the dollar amount of revenue that would be generated by said levy; and

WHEREAS, in accordance with Division (B) of Section 5705.03 of the Ohio Revised Code, upon receipt of a certified copy of a resolution of Council declaring the necessity of the tax, stating its purpose, whether it is an additional levy or a renewal or a replacement of an existing tax, and the Section of the Ohio Revised Code authorizing its submission to the electors, and requesting such certification, the Ashtabula County Auditor is to certify the total tax valuation of the City and the dollar amount of revenue that would be generated by the proposed renewal levy.

NOW, THEREFORE BE IT RESOLVED, by the City of Conneaut, County of Ashtabula and State of Ohio:

SECTION 1. That pursuant to Sections 5705.19(D) and 5705.191 of the Ohio Revised Code, the Council of the City of Conneaut has determined the need to authorize and direct the submission to the electors of the City at the General Election of November 7, 2023 a renewal levy for purpose of operating funds for the Conneaut Public Library at a rate not exceeding one and ninety one-hundredths (1.90) mills for each one thousand dollars (\$1,000.00) of assessed valuation, for a period of five (5) years to be collected commencing with the tax year of 2024 to be collected in 2025.


SECTION 2. That this Council requests the Ashtabula County Auditor to certify to it both (i) the total current tax valuation of the City and (ii) the dollar amount of revenue that would be generated by the 1.90 mill levy specified in Section 1.

SECTION 3. That the Clerk of Council is authorized and directed to deliver promptly to the Ashtabula County Auditor a certified copy of this Resolution.

SECTION 4. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


SECTION 5. That this Ordinance is declared to be an emergency measure in the interests of public peace, health and safety and to facilitate the placement of the levy on the November 7, 2023 General Election ballot.
