WAIVER SCHEDULE TRAFFIC AND CRIMINAL VIOLATIONS

Effective August 1, 2022

Any minor misdemeanor offense (**FIRST OFFENSE WITHIN ONE YEAR ONLY**) not listed below may be waived with a fine of \$150.00 in addition to court costs. No offense with a possible jail sentence may be waived.

A waiver is admitting your guilt by signing the statement on the reverse side of the ticket, submitting a check or money order for the amount due and forwarding to Conneaut Municipal Court. This may also be done in person at Conneaut Municipal Court.

Please call the Clerk's Office at (440) 593-7410 located at 290 Main Street, Conneaut, Ohio for waiver eligibility and amount due or see the waiver schedule below. **If a waiver amount is not listed, then the offense is not waivable and a court appearance is required.**
