Responsibilities: Any person that fails to complete jury service as directed may be jailed, fined, or both. Please read this summons carefully and follow all instructions.

Term of Service: You are summoned for jury service. The term of your service is listed on the back of this document, which is to be retained by you. Please read all information on the summons so that you will know how to proceed. Qualified Jurors will receive a reminder about one week prior to the start of their term of service.

Reporting Instructions: You can check your status and reporting instructions online via the Juror Access Website or via the automated jury phone. The call in procedure is as follows: call «Call In Phone» on the night before your term of service begins, after 6:00 p.m. and proceed as instructed.

NOTE: Idaho law provides that any prospective juror who fails to return this completed qualification questionnaire form as instructed shall be directed to appear before the clerk or the jury commissioner to complete the qualification questionnaire form. Prospective jurors who fail to appear as directed shall be ordered by the Court to appear and show cause for their failure to appear as directed, and may also be held in contempt of Court. Any person who willfully misrepresents a material fact on this qualification questionnaire for the purpose of avoiding or securing service as a juror is guilty of a misdemeanor.
