	<div>BALLOT MEASURES</div> <div>MIDDLETON FIRE DISTRICT</div> <div>MIDDLETON RURAL FIRE DISTRICT CANYON AND GEM COUNTIES, IDAHO PERMANENT TAX LEVY OVERRIDE</div> <div>Shall the Board of Commissioners of the Middleton Rural Fire District be authorized and empowered to permanently increase its annual property tax budget and levy beyond the amount the District is currently authorized to levy pursuant to Idaho Code § 63-802, by the sum of two million two hundred twenty five thousand dollars (\$2,225,000), commencing Districts Fiscal Year 2025, and which amount shall then be added to the Districts current established base budget amount for the purposes of Idaho Code § 63-802.</div> <div>The purpose of this tax increase is to defray its costs of staffing, equipping, and maintaining the Districts operations to provide protection of property against fire and the preservation of life, throughout the Fire District.</div> <div>STATEMENT: The levy will be used to fund District operations and will be a tax increase of approximately \$65.84 per \$100,000 of taxable assessed value, per year, based upon current conditions.</div> <div><input type="radio"/> YES, I am IN FAVOR of authorizing the permanent override levy not to exceed the sum of \$2,225,000 dollars per year beyond the amount authorized by Idaho Code Section 63-802 commencing Districts Fiscal Year 2025.</div> <div><input type="radio"/> NO, I am AGAINST authorizing the permanent override levy not to exceed the sum of \$2,225,000 dollars per year beyond the amount authorized by Idaho Code Section 63-802 commencing Districts Fiscal Year 2025.</div> <div>Note: Middleton Fire Ballot Measure will only be on ballots for voters within that district in the Letha Precinct.</div>
