

Regional Land Use Monitoring Report (2011)

UPWP Task #4220

Executive Summary

Project Purpose:

The Genesee Transportation Council (GTC) provides funding annually for the *Regional Land Use Monitoring Report* under its Unified Planning Work Program. This report provides information on the issuance of building permits in 2011 to identify areas of growth within the Genesee-Finger Lakes Region (G-FL Region) that might require transportation planning and service modifications.

The G-FL Region is comprised of Genesee, Livingston, Monroe, Ontario, Orleans, Seneca, Wayne, Wyoming, and Yates Counties. The report analyzes the number of permits issued, total square footage, and total value for buildings for each municipality within the region as well as the Transportation Management Area (TMA). The TMA covers Monroe County and the municipalities adjacent to Monroe County in Livingston, Ontario, and Wayne Counties, as well as the Town and City of Canandaigua. The analysis looks at the following categories and respective subcategories: “residential” (single-family, two-family, three or four-family, five-or- more family, mobile/manufactured homes); “industrial;” “commercial” (offices/banks, retail/service, service stations, hotels/motels); “community service” (hospitals/health facilities, schools/churches, public works/safety, utilities); and “not elsewhere classified.”

A three-year trend analysis is provided for permitted residential units in all nine counties; industrial, commercial, and community service building permits are analyzed over the three-year period as well. In addition, a time series (or historical trend) analysis is provided for residential, industrial, and commercial development, as well as subdivision approvals in the Transportation Management Area (TMA).

To provide further insight into municipal related information, municipalities were requested to provide the most recent updates related to zoning maps and ordinances as of 2011.

Project Methodology:

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties, these officials were, in most municipalities, the code or zoning enforcement officers. In some cases they were municipal clerks. In Seneca and Wyoming Counties building permit application approval and inspection are the responsibility of the respective county building departments. Those two departments provided the data for their counties. The Monroe County Planning and Development Department’s Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to the Genesee/Finger Lakes Regional Planning Council.

Surveys were distributed in January of 2012 asking for the requested data. The initial survey was followed up with a reminder e-mail along with a telephone reminder to those municipalities that had yet to respond. In some cases, several calls were made to the appropriate parties in an effort to acquire the requested information. Complete data was collected for all 191 municipalities in the nine-county G-FL Region.

Analysis Overview:

The highest number of residential permits in the G-FL Region in 2011 was in the City of Rochester (231) followed by Towns of Penfield (128), Greece (118), Henrietta (97), Webster (58) and Brighton (56). The City of Rochester permits issued totaled the largest number of units (328); The Towns of Greece and Penfield's permits issued totaled 179 and 161 units respectively. The highest number of residential permits issued by municipalities outside of Monroe County was in the Towns of Farmington, Victor and Canandaigua in Ontario County issuing 54, 39 and 37 permits respectively and the Towns of Macedon, Ontario and Sodus in Wayne County issuing 21, 18 and 18 respectively. The Town of Farmington's permits issued totaled 133 units.

The majority of industrial and commercial permits were issued in municipalities in the TMA.

Over the years (2001-2011), the majority of permits for residential units in the TMA have been in Monroe County. In the TMA outside of Monroe County, the Towns of Victor, Canandaigua, and Farmington in Ontario County, and the Towns of Ontario and Walworth in Wayne County issued permits for the largest number of residential units over the same eleven year time frame.

The data on permitted building activity and demolition tables are provided in appendices at the end of this report. Overall, the report serves as an information resource for the GTC and others to view and analyze permit activity in the G-FL Region to identify potential growth areas, and anticipate increased transportation needs.

Introduction

The Genesee Transportation Council (GTC) provides funding annually for the *Regional Land Use Monitoring Report* (LUMR) under its Unified Planning Work Program. The purpose of this report is to provide information for building permits by type, size, and value to identify areas of growth within the Genesee-Finger Lakes (G-FL) Region that may, as a result, require increased transportation planning and services.

The *Regional Land Use Monitoring Report* includes residential, industrial, commercial, and community service building permit data for all nine counties in the G-FL Region. The categories (and associated subcategories) for building permit data are as follows:

- Residential (single-family, two-family, three-or-four-family, five-or-more-family, and mobile/manufactured homes)
- Industrial
- Commercial (offices/banks, retail/service, service stations, hotels/motels)
- Community Service (hospitals, schools)
- Not Elsewhere Classified

A three-year trend analysis is provided for permitted residential units in all nine counties and industrial, commercial and community service building permits are analyzed over the three-year period. This time-series analysis is based on this year's and the two previous years' Land Use Monitoring Reports produced by the Genesee/Finger Lakes Regional Planning Council (G/FLRPC).

In addition, a time series (or historical trend) analysis is provided for residential, industrial, and commercial development and subdivision approvals in the Transportation Management Area (TMA).

The TMA includes Monroe County and the adjacent municipalities to the south and east as well as the City and Town of Canandaigua. Table 1 represents the municipalities that, along with Monroe County, comprise the Transportation Management Area.

An analysis of the collected data on the number, value, and size of buildings permitted in 2011 is provided for each county as well as the TMA.

Given that many conclusions can be drawn from the data on permitted building activity tables are provided in appendices at the end of this report for the reader to use for their own needs and analysis.

Methodology

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties these officials were, in most cases, the code or zoning enforcement officers; in some cases the municipal clerks. In Seneca and Wyoming Counties building permit application approval and inspection are the responsibility of the respective county building departments. Those two departments provided the data for their counties. The Monroe County Planning and Development Department's Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to G/FLRPC.

As noted above, each municipality other than Seneca and Wyoming Counties received a survey in January of 2011 asking for the requested data. The initial survey was followed up with a reminder postcard along with a telephone reminder to those municipalities that had yet to respond. In some cases, several calls were made to the appropriate parties in an effort to acquire the requested information. Overall, 100% of the data was collected from all 191 municipalities within the nine-county G-FL Region.

The survey requested information on the number of permits issued, total square footage and total value for buildings in the defined categories and associated subcategories. In addition, the same building permit information for buildings outside of these categories was requested along with a description of the type of building(s) in the "Other" category. This year the LUMR survey included an additional request

from municipalities. All analysis conducted in this report is based on data provided by each LUMR survey contact.

The instructions for completing the survey as printed on the first of the two-page document were as follows:

"Include only permits for the construction of buildings in 2011. Do not include additions, repairs, decks, in-ground pools, etc. or buildings used for storage such as sheds and pole barns. Do not include permits for construction that was completed in 2011 but permitted in a previous calendar year. If the responses below include a town and a village on the same sheet, please denote this by listing them separately on the same line (example: T - 8/ V - 12)."

For each of the nine counties, there is a discussion of permitted building activity in 2011 and county maps of residential units permitted in 2011 by municipality (Maps 1 - 9, Map 10 represents Permits for Residential Units for the nine-county G-FL Region). Data of industrial, commercial, and community service building permits issued in 2011 are presented on maps of the nine-county G-FL Region (Maps 11-13).

The information and data provided for permitted building activity in Monroe County and the remaining portion of the TMA follows the same format. Maps 14 through 17 present the number of permitted residential, industrial, commercial, and community service buildings in the TMA in 2011. Map 18 shows the distribution of residential building permits among the Transportation Analysis Zones (TAZ) within the TMA outside of Monroe County.

The residential data for TMA municipalities were used in a time series analysis of the number of residential units permitted by municipality for the years 2001 through 2011. The

number of permits issued for industrial and commercial buildings from 2001 to 2011 in the TMA outside of Monroe County is also presented and discussed in the same manner.

A three-year time series analysis of permits issued by municipalities in the G-FL Region that responded to the survey all three years are provided for permits that were issued for buildings across all categories. Data for Wyoming County between 2009 and 2011 are provided for all but industrial and community service buildings.

The data gathered on number of building permits issued, square footage, and value in each category/subcategory by municipality in and for the TMA outside Monroe County are presented in Appendices A through H. The Appendices are as follows:

2011 County Building Permit Analysis

Genesee County

Residential Permits:

- Twenty four (24) residential building permits were issued in Genesee County in 2011. The largest number of permits (6) was issued in the Town of Leroy; all for single-family homes. Permits issued totaled 9,964 square feet with a combined value of \$1,075,500. The Town of Batavia issued the second highest total of permits with five. Permits issued totaled 23,428 square feet with a combined value of \$864,857.
- The number of permits issued in Genesee County in 2011 for mobile/manufactured homes was seven.
- There were no permits issued for multi-units, down from seven that were issued in 2011.

Map 1 shows the number of residential unit permits in Genesee County in 2011.

Industrial Permits:

- There were two industrial building permits issued in 2011. Both in the City of Batavia, the total value for the permit issued were \$930,000.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2011.

Commercial Permits:

- No permits for commercial buildings were reported for Genesee County municipalities in 2011.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2011.

Community Service Permits:

- No permits for community service buildings were reported for Genesee County municipalities in 2011.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2011.

Not Elsewhere Classified Permits:

- Two (2) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

Demolition Permits:

- Five (5) residential demolitions were permitted in Genesee County in 2011.

Livingston County

Residential Permits:

- Sixty Two (62) residential permits, for 71 units, were issued in Livingston County in 2011. The largest number of permits issued was in the Towns Geneseo and Livonia (7). The second highest was in the Town of Caledonia with six permits. The Town of Springwater issued the next highest with five permits. The Village of Geneseo issued two permits including a multi-family permit totaling 8 units.

Map 2 shows the number of residential unit permits in Livingston County in 2011.

Industrial Permits:

- No permits for industrial buildings were reported for Livingston County municipalities in 2011.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2011.

Commercial Permits:

- One (1) permit was issued in the Town of Avon for commercial buildings.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2011.

Community Service Permits:

- No permits for community service buildings were reported for Livingston County municipalities in 2011.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2011.

Not Elsewhere Classified Permits:

- Eleven (11) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

Demolition Permits:

- Three (3) demolitions were permitted in Livingston County in 2011; all were issued for residential structures.

Monroe County

Residential Permits:

- Municipalities in Monroe County issued 934 residential building permits for a total of 1,288 residential units in 2011. The largest number of permits issued was in the City of Rochester (231) totaling 328 units, with a total value of \$44,600,206.

The Town of Penfield issued the next largest number of single-family unit permits (128) followed by the Town of Greece (118), the Town of Webster (58) and the Town of Brighton (56).

- A total of 145 multi-family unit permits were issued for 489 units in the county.
- Twelve (12) mobile/manufactured home permits were issued in the county with the Town of Hamlin issuing the highest amount of permits (8) valued at \$338,800.

Map 3 shows the number of residential unit permits in Monroe County in 2011.

Industrial Permits:

- Thirty nine (39) permits were issued in the entire County. The largest number of industrial permits was issued in the Town of Henrietta (33) followed by the Town of Webster with three.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2011.

Commercial Permits:

- In the category of commercial buildings, 34 permits with a total value of \$38,026,704 were issued in Monroe County. The Town of Penfield issued the highest with 11 permits.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2011.

Community Service Permits:

- One (1) permit was issued for community service buildings in Monroe County, with a total value of \$10,108,810. The permit was for a school.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2011.

Not Elsewhere Classified Permits:

- Five (5) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

Demolition Permits:

- Of all the counties in the G-FL Region, the most demolitions in 2011 were permitted in Monroe County. Three Hundred Sixty Four (364) demolition permits were issued. The City of Rochester issued the highest number of demolition permits with 250.

Ontario County

Residential Permits:

- Ontario County municipalities permitted 246 residential structures in 2011, for a total of 351 units. The Town of Farmington issued the most permits with 54, with total units at 133 units. The Town of Victor issued the second most permits with 39. The Town of Canandaigua issued 37 total permits totaling 53 units

Map 4 shows the number of residential unit permits in Ontario County in 2011.

Industrial Permits:

- There were five industrial building permits issued in Ontario County in 2011. The Town of Victor issued the most permits with three.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2011.

Commercial Permits:

- Thirty five (35) commercial building permits were issued in Ontario County. All permits issued where in the Town of Victor with a value of \$5,937,860.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2011.

Community Service Permits:

- There were no permits issued for community service buildings in Ontario County in 2011.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2011.

Not Elsewhere Classified Permits:

- Nine (9) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

Demolition Permits:

- Forty nine (49) residential demolitions were permitted in Ontario County in 2011.

Orleans County

Residential Permits:

- A total of 27 residential building permits were issued in Orleans County in 2011 consisting of 16 single-family structures and 12 mobile homes. The Towns of Clarendon and Carlton issued the largest number of permits in the County with seven and six respectively.

Map 5 shows the number of residential unit permits in Orleans County in 2011.

Industrial Permits:

- No industrial permits were reported for Orleans County in 2011.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2011.

Commercial Permits:

- One (1) commercial building permit was reported in 2011, in the Town of Murray.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2011.

Community Service Permits:

- No community service permits were reported for Orleans County in 2011.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2011.

Not Elsewhere Classified Permits:

- One (1) permit was issued that did not correspond to the above-described categories was included as not elsewhere classified.

Demolition Permits:

- Orleans County permitted nine residential demolitions in 2011. The Town of Murray issued the most permits with six followed by the Town of Albion with three.

Seneca County

Residential Permits:

- Thirty one (31) residential building permits were reported in Seneca County in 2011. The largest number of permits issued was in the Village of Seneca Falls with nine, followed by the Towns of Covert and Lodi with 10 each and the Village of Seneca Falls issuing nine.

Map 6 shows the number of residential unit permits in Seneca County in 2011.

Industrial Permits:

- No industrial building permits were issued in Seneca County in 2011.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2011.

Commercial Permits:

- Four (4) commercial building permits were issued in Seneca County in 2011. One permit each was issued in the Towns of Romulus, Seneca Falls, Waterloo and the Village of Seneca Falls.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2011.

Community Service Permits:

- No community service buildings were reported in Seneca County for 2011.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2011.

Not Elsewhere Classified Permits:

- One (1) permit was issued that did not correspond to the above-described categories was included as not elsewhere classified.

Demolition Permits:

- Twenty two (22) demolition permits were issued in Seneca County in 2011. The Town of Seneca Falls issued the highest with five.

Wayne County

Residential Permits:

- Municipalities in Wayne County issued 115 permits in 2011. The highest total of permits issued in the County was in the Town of Macedon (21) followed by the Towns of Ontario and Sodus (18). The Towns of Walworth and Wolcott issued 14 and 11 permits respectively. There were 22 permits issued for mobile/manufactured homes with the Towns of Wolcott and Macedon issuing eight and five permits respectively.

Map 7 shows the number of residential unit permits in Wayne County in 2011.

Industrial Permits:

- Four (4) permits were issued for industrial buildings in Wayne County in 2011 with a total value of \$175,000. The Town of Galen issued two permits covering 12,880 square feet.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2011.

Commercial Permits:

- No commercial buildings were reported in Wayne County for 2011.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2011.

Community Service Permits:

- No community service buildings were reported in Wayne County for 2011.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2011.

Not Elsewhere Classified Permits:

- Two (2) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

Demolition Permits:

- Eleven (11) demolition permits were reported in Wayne County in 2011.

Wyoming County

Residential Permits:

- In 2011, municipalities in Wyoming County issued 45 permits for residential structures. The Town of Arcade issued the most permits with eight. The Town of Bennington issued the second highest permits with five.

Map 8 shows the number of residential unit permits in Wyoming County in 2011.

Industrial Permits:

(Wyoming County does not categorize Industrial permits)

- The information reported by Wyoming County for permits issued does not correspond directly to the survey categories. Information related to industrial permits is not categorized by Wyoming County but it is categorized under commercial permits. Therefore, it is unclear how many permits were issued for industrial buildings in the County in 2011.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2011.

Commercial Permits:

- A total of 21 permits were issued for commercial buildings in the County in 2011.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2011.

Community Service Permits:

(Wyoming County does not categorize community service permits)

- The Information reported by Wyoming County for permits issued does not correspond directly to the survey categories. Information related to community service permits is not categorized by Wyoming County. Therefore, it is unclear how many permits were issued for community service buildings in the County in 2011.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2011.

Not Elsewhere Classified Permits:

(Wyoming County does not specify not elsewhere classified permits)

- The Information reported by Wyoming County for permits issued, does not correspond directly to the survey categories. Therefore, it is unclear how many permits were issued for not elsewhere classified in the County in 2011.

Demolition Permits:

- Twenty six (26) unspecified demolition permits were issued in Wyoming County in 2011.

Yates County

Residential Permits:

- Municipalities in Yates County issued 60 residential building permits in 2011. The Town of Jerusalem issued the most permits with 18 totaling 28 units. The Town of Milo issued the second most permits with 11.

Map 9 shows the number of residential unit permits in Yates County in 2011.

Industrial Permits:

- One (1) industrial building permit was issued in 2011 for a total value of \$1,250,000.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2011.

Commercial Permits:

- One (1) permit was reported for commercial buildings in Yates County for 2011 in the Town of Starkey covering 8,600 square feet with a total value of \$1,500,000.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2011.

Community Service Permits:

- No community service building permits were issued in Yates County in 2011.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2011.

Not Elsewhere Classified Permits:

- Five (5) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

Demolition Permits:

- Yates County permitted 14 residential demolitions in 2011.

3-Year Building Permit Analysis (2009 – 2011)

Genesee County

Residential Units:

- During the three-year period from 2009 through 2011, the total number of units permitted was 189. In 2009, 114 units were permitted. That number decreased to 51 in 2010 and again decreased to 24 in 2011.
- The City of Batavia permitted the most residential units in Genesee County with 81. The Town of Batavia issued the next highest number of units (31). The Towns of Leroy, Pembroke and Darien had the next highest number of units with 15, 13 and 12 respectively.

Industrial Units:

- A total of four units were permitted for industrial buildings in Genesee County from 2009 to 2011. The City of Batavia permitted two units in 2011. The Towns of Byron and Darien permitted one industrial unit each in 2010.
- Industrial building units permitted increased from zero in 2009 to two in 2010 and again with two units in 2011.

Commercial Units:

- Three (3) commercial units were permitted in Genesee County from 2009 to 2011. The Town of Batavia permitted two units, one each in 2009 and 2010, as well as the Town of Leroy permitting 1 unit in 2009.

Community Service Units:

- One (1) community service unit was permitted from 2009 to 2011, with the Town of Darien issuing the permit.

Livingston County

Residential Units:

- The number of residential units permitted in Livingston County has remained steady over the past three years from 83 in 2008, to 90 in 2009, and 71 in 2011.
- The Town of Geneseo issued permits for 36 residential units from 2009 to 2011, more than any other municipality in Livingston County. The Town of Livonia permitted the next largest number of residential units with 33, followed by the Town of Avon with 25.

Industrial Units:

- Nine (9) industrial permits were reported in Livingston County from 2009 to 2011. The Town of Groveland issued the most permits for industrial units with five and the Towns of Livonia, North Dansville and West Sparta and the Village of Caledonia each permitted a single industrial unit.
- The number of industrial units permitted in Livingston County has varied slightly over the last three years. In 2009 there were four industrial units permitted, followed by five units in 2010 and zero in 2011.

Commercial Units:

- Nine (9) commercial units were permitted from 2009 to 2011. The number of units permitted for commercial structures in Livingston County has been consistent with 3 industrial units in 2009 permitted, followed by five in 2010, then down to one in 2011.

- The Village of Geneseo permitted the largest number of commercial units with three.

Community Service Units:

- Ten (10) community service units were permitted in Livingston County from 2009-2011. The Town of York issued the largest number of units (4) followed by the Town of Groveland with two units permitted.
-

Monroe County

Residential Units:

- Three thousand five hundred sixteen (3,516) residential units were permitted in Monroe County between 2009 and 2011. Monroe County issued the most residential permits and totaled the most units in the region. The number of units permitted over the past three years went from 1,274 in 2009, to 954 in 2010, to 1,288 in 2011.
- The City of Rochester permitted the largest number of residential units (675) followed by the Towns of Henrietta (553), Webster (393), Greece (382), Penfield (380), Chili (174), Ogden (156), and Pittsford (110).

Industrial Units:

The Towns of Chili and Penfield do not categorize industrial and commercial permits.

- During the last three years, a total of 115 industrial units were permitted in Monroe County. The Town of Henrietta permitted the most (96). The number of industrial building units permitted in Monroe County increased from 27 in 2009, to 49 in 2010 but decreased with 39 in 2011.

Commercial Units:

The Towns of Chili and Penfield do not categorize industrial and commercial permits.

- A total of 86 commercial building permits were issued from 2009 to 2011. During the period from 2009-2011, the City of Rochester permitted the greatest number of commercial units with 22. The Town of Penfield issued 12, and the Town of Greece permitted 10.

Community Service Units:

- Fourteen (14) community service building units were permitted in Monroe County from 2009 to 2011. The Town of Perinton issued the most with four over the three year period, followed by the Town of Penfield with three and City of Rochester with two.
-

Ontario County

Residential Units:

- One thousand one hundred forty seven (1,147) residential units were permitted in Ontario County from 2009 to 2011. Ontario County issued the second most residential permits and totaled the second most units in the region.
- Residential units permitted have slightly declined over the past three years from 402 in 2009, to 394 in 2010, and to 351 in 2011.

Industrial Units:

- Ten (10) industrial units were permitted in Ontario County from 2009 to 2011. The Town of Victor permitted six of these units. The City of Geneva issued permits for two industrial units.

Commercial Units:

- Fifty three (53) commercial units were permitted in Ontario County from 2009 to 2011. Ontario County's commercial units permitted over the three-year period were as follows: 11 in 2009, to seven in 2010, and 35 in 2011.
- The Town of Victor permitted forty one units, the most of any municipality in Ontario County.

Community Service Units:

- Three (3) community service units were permitted in Ontario County. The Town of Hopewell issued the highest number of Community service units in the County with two.

Orleans County

Residential Units:

- Residential units permitted were steady during the last three years (2009 – 2011). In 2009, Orleans County municipalities permitted a total of 30 residential units, again 30 units in 2010 and then an increase to 36 in 2011.
- The Town of Clarendon permits issued totaled 24 units. The Town of Carlton permits totaled 17 units. The Town of Yates permitted 12 units over the three year period.

Industrial Units:

- Two (2) industrial units were permitted in the County from 2009-2011, both were reported in the Town of Gaines.

Commercial Units:

- A total of two commercial building units were permitted in Orleans County from 2009 to 2011. Both units were permitted in the Village of Lyndonville and the Town of Murray

Community Service Units:

- There was no community service buildings were permitted in Orleans County from 2009 to 2011.

Seneca County

Residential Units:

- One hundred fifty eight (158) residential units were permitted in Seneca County from 2009 to 2011. The Village of Seneca Falls permitted 21 residential units during this period, the most of any municipality in the County. The Towns of Ovid, Romulus, Waterloo and Lodi permitted 18, 18, 17, and 16 units respectively.
- The total number of residential units permitted in Seneca County has varied from 48 in 2009, to 80 in 2010 but experienced a decline with 30 in 2011.

Industrial Units:

- There were no industrial building permits reported in Seneca County from 2009 to 2011.

Commercial Units:

- There were a total of 27 commercial building units permitted from 2009 to 2011. The Town of Seneca Falls issued the most with six.
- The total number of units permitted for commercial buildings in Seneca County has varied with six units in 2009 to 17 in 2010 to four in 2011.

Community Service Units:

- Two (2) community service building units were permitted in Seneca County from 2009 to 2011.

Wayne County

Residential Units:

- Four hundred twenty four (424) residential units were permitted in Wayne County from 2009 to 2011.
- In 2009, the total number of residential units permitted was 157. That number decreased to 152 in 2009, and decreased again to 115 in 2011.
- The Town of Ontario permitted the most units (97). The Town of Macedon follows with 68 units permitted over the course of 2009-2011

Industrial Units:

- Twelve (12) industrial permits were issued in Wayne County from 2009 to 2011.

Commercial Units:

- Municipalities in Wayne County issued 11 commercial permits from 2009 to 2011. The Town of Arcadia issued the largest number of commercial units with four.
- The number of units permitted for commercial buildings in Wayne County has been on a decline over the past three years, from seven in 2009, to four in 2010 and zero in 2011.

Community Service Units:

- Five (5) community service building units were permitted in Wayne County from 2009 to 2011 among the municipalities that reported all three years.

Wyoming County

Residential Units:

- During the last three years (2009 – 2011), 171 residential units were permitted by Wyoming County municipalities. The County issued 66 in 2009, 60 in 2010 and 45 in 2011.
- The Town of Arcade permitted the largest number of residential units over the three year period with 28. The Town of Bennington permitted 21, the Towns of Castile, Java and Sheldon permitted 14, 10 and 10 units respectively.

Industrial Units:

Wyoming County does not categorize Industrial permits.

Commercial Units:

- From 2009 to 2011, Wyoming County municipalities permitted a total of 84 units. The Towns of Bennington and Sheldon led the way with permits issued totaling 19 and 10 units respectively.
 - The number of Wyoming County commercial units permitted decreased from 51 in 2009, then 12 in 2010, and then decreased to 21 in 2011.

Yates County

Residential Units:

- Two hundred twenty one (221) residential units were permitted in Yates County from 2009 to 2011. The Town of Jerusalem reported the largest number of residential units permitted with 65. The Town of Milo issued 37 and the Town of Barrington issued 35.
- Reported residential units permitted have remained steady in Yates County the past three years. The total number of units permitted was 84 in 2009, 67 in 2010 and 70 in 2011.

Industrial Units:

- Four (4) industrial units were permitted in Yates County.

Commercial Units:

- Two (2) commercial building permits were issued from 2009 through 2011. The Town of Starkey issued the most permits with two.

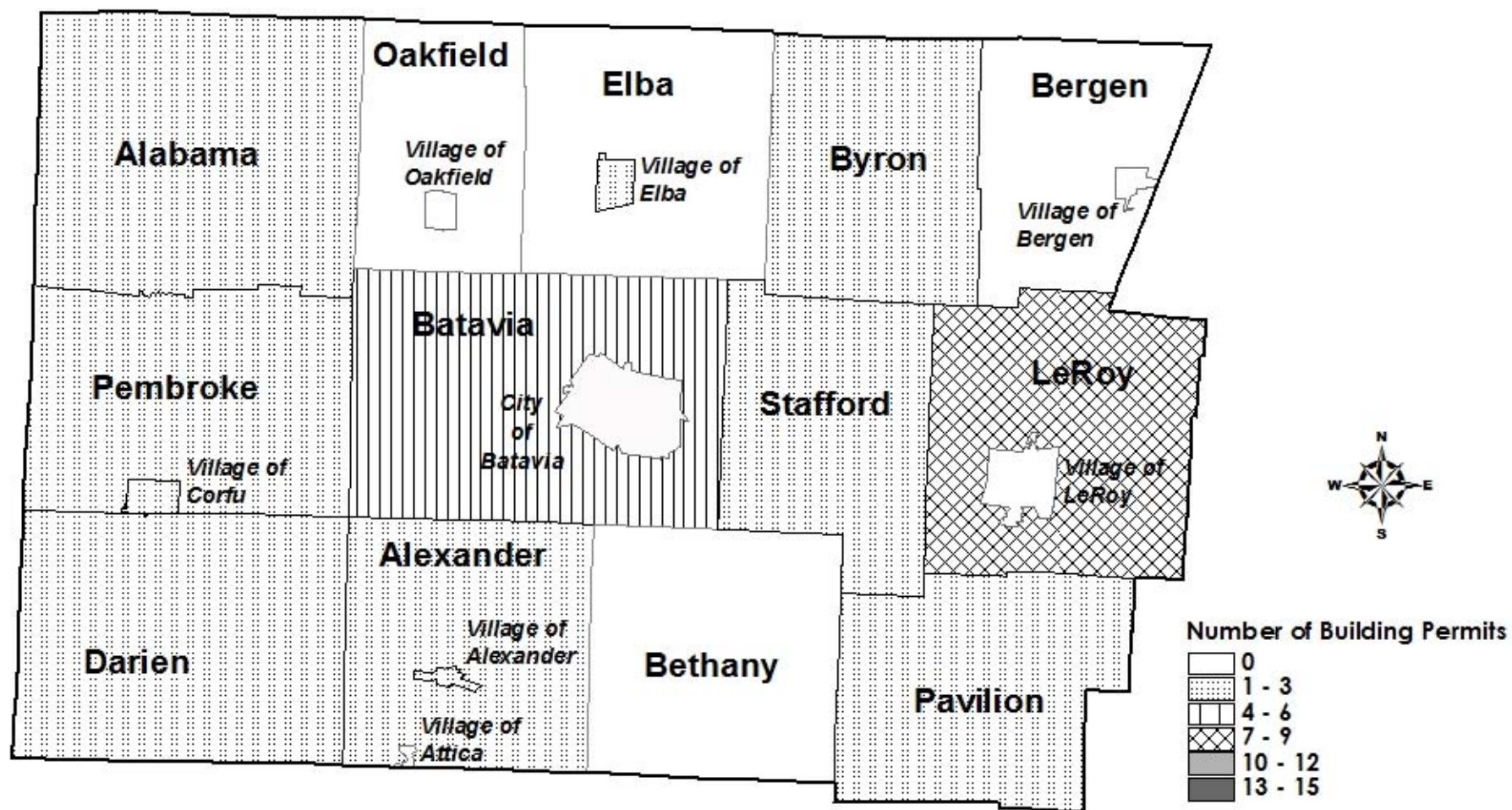

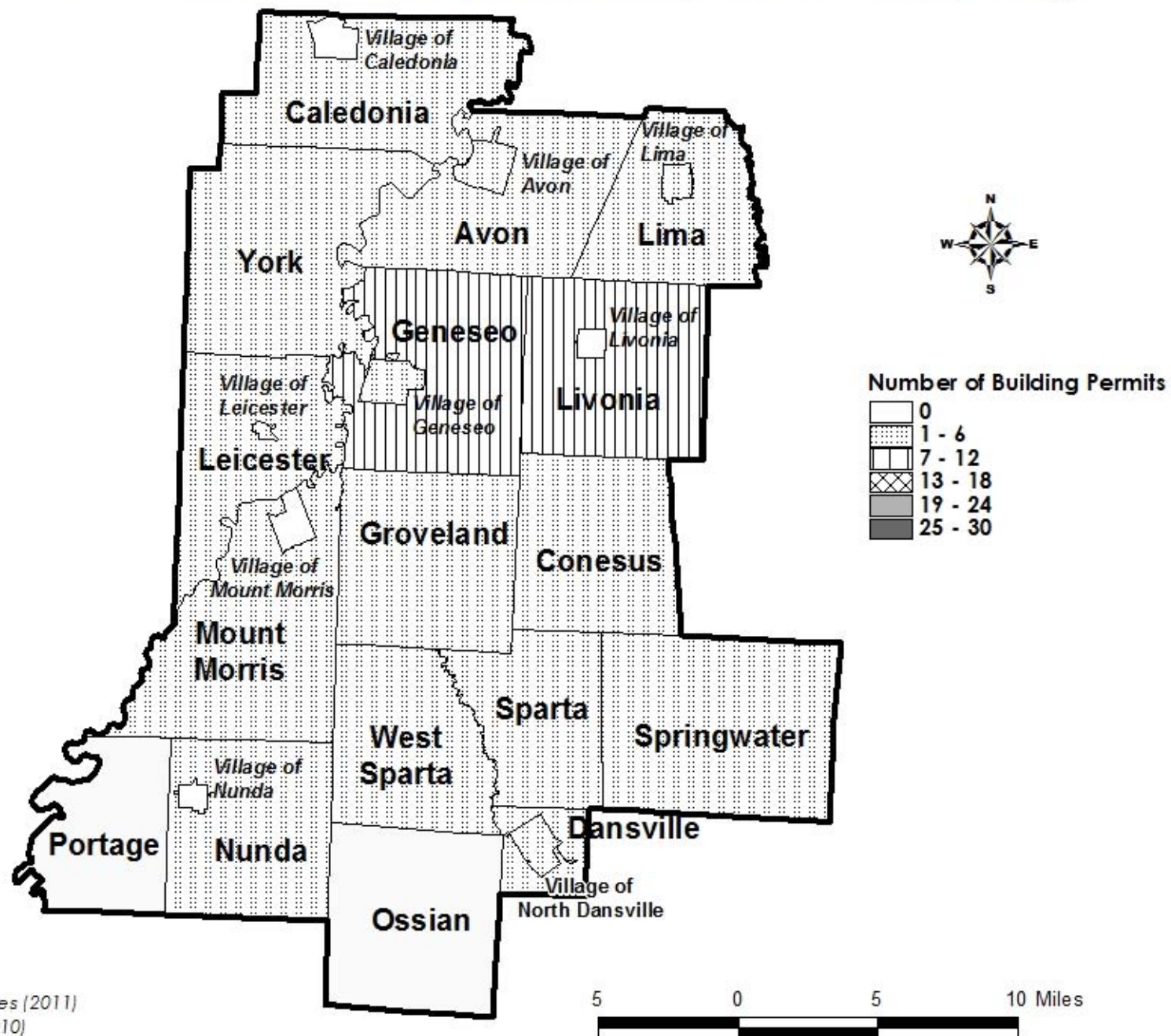

Number of Residential Unit Permits in Livingston County (2011)



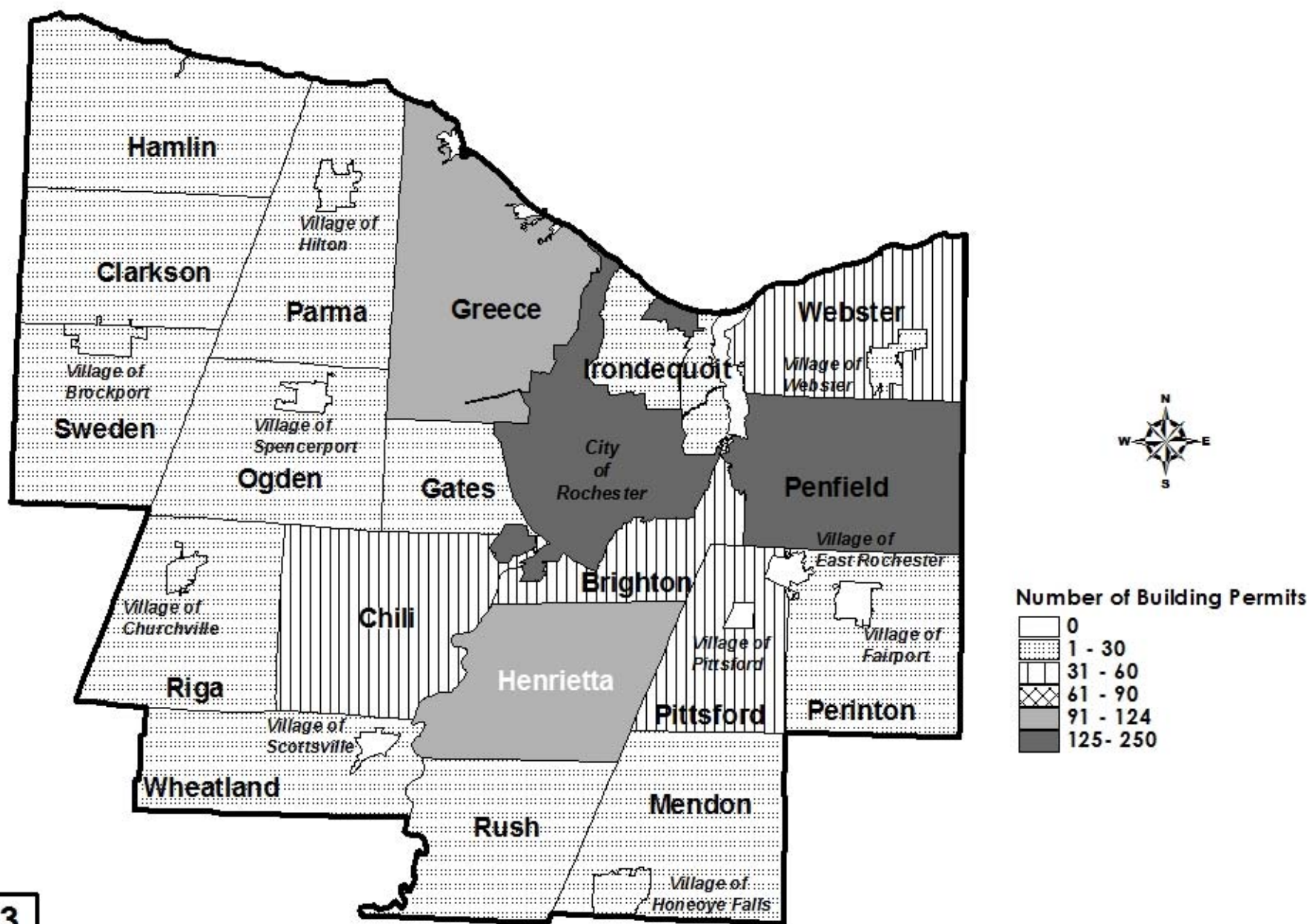

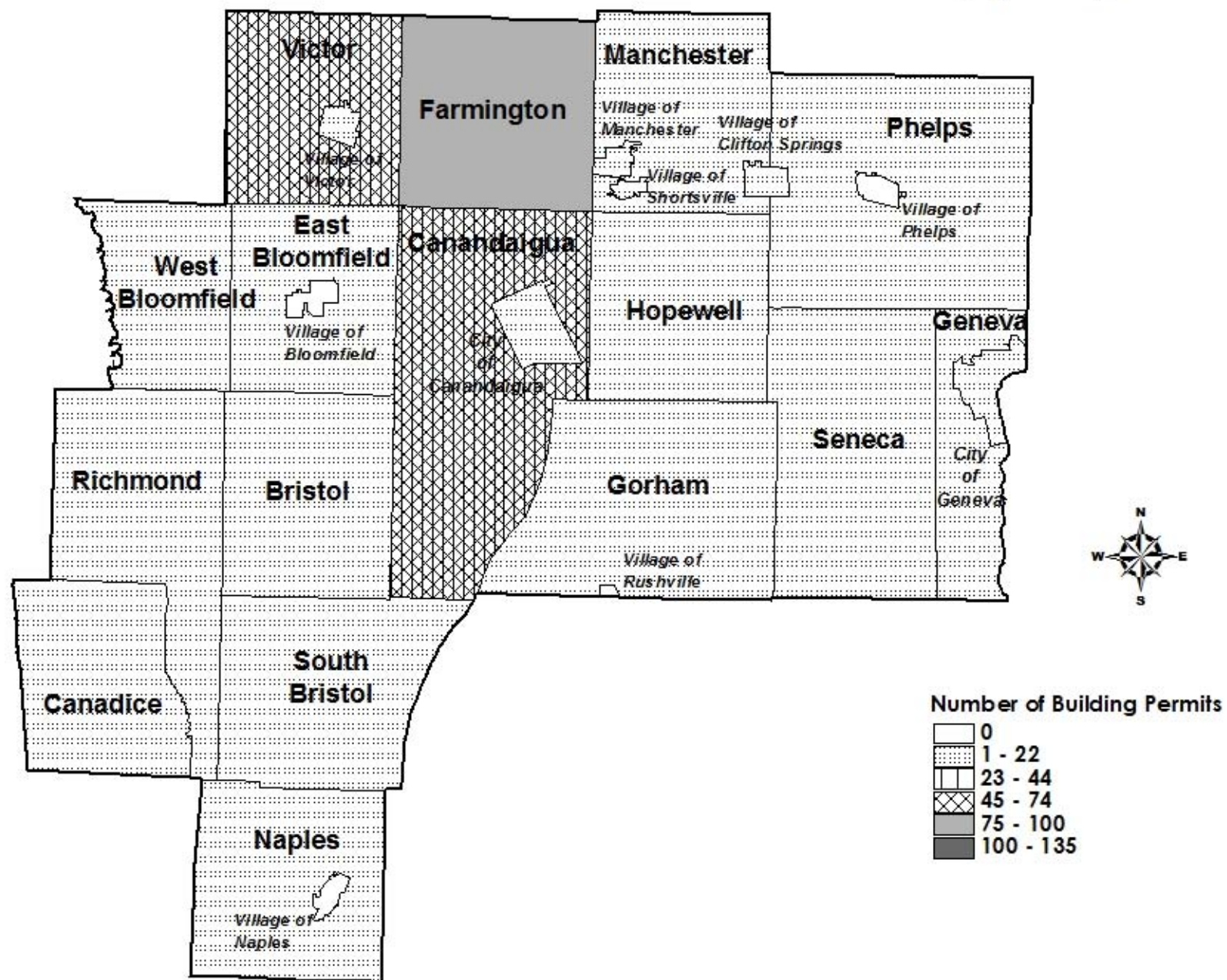

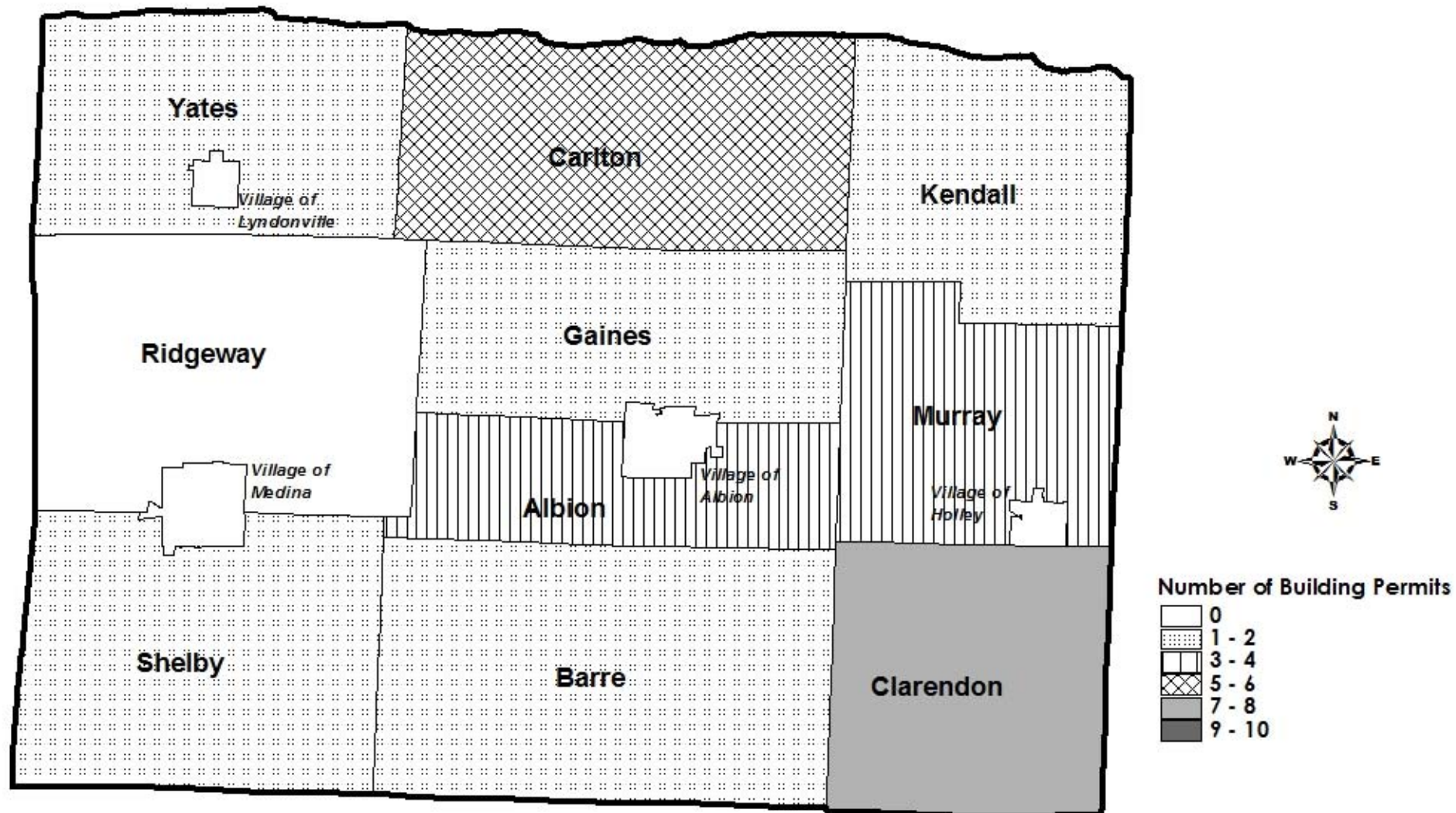

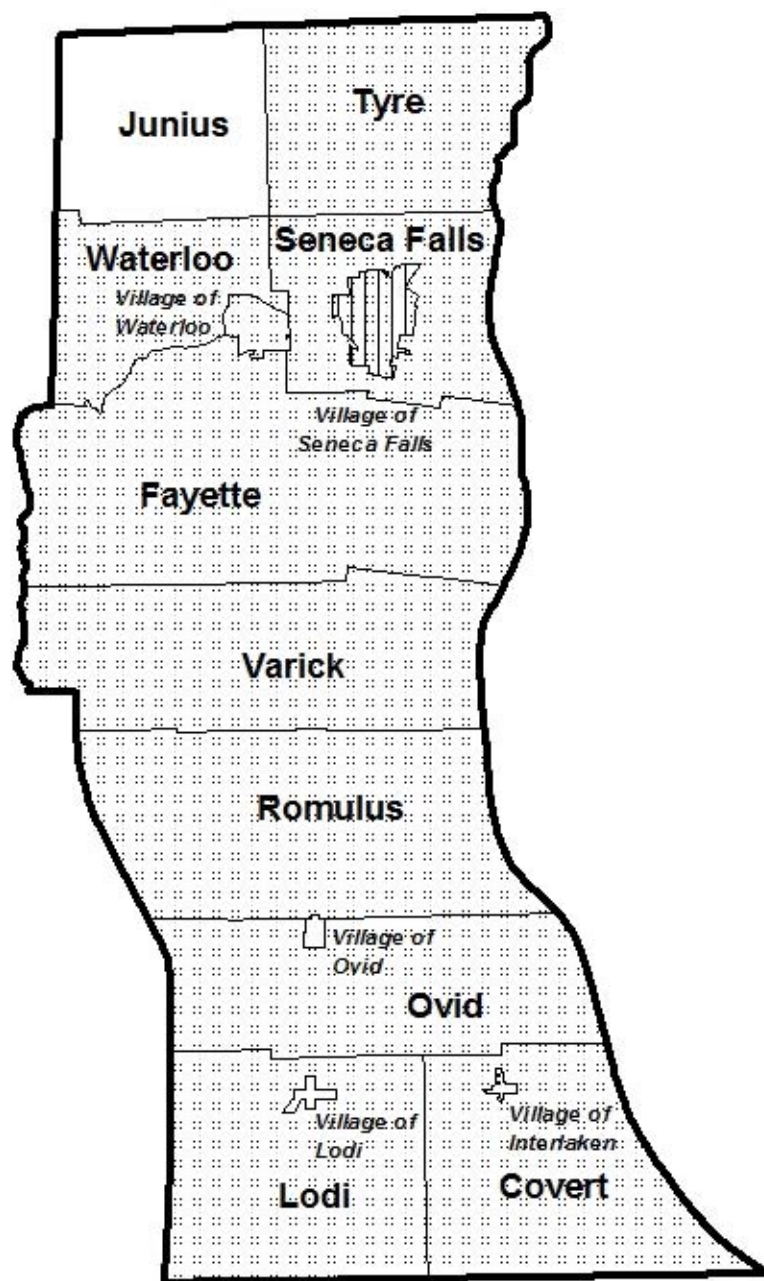

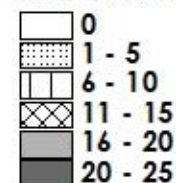

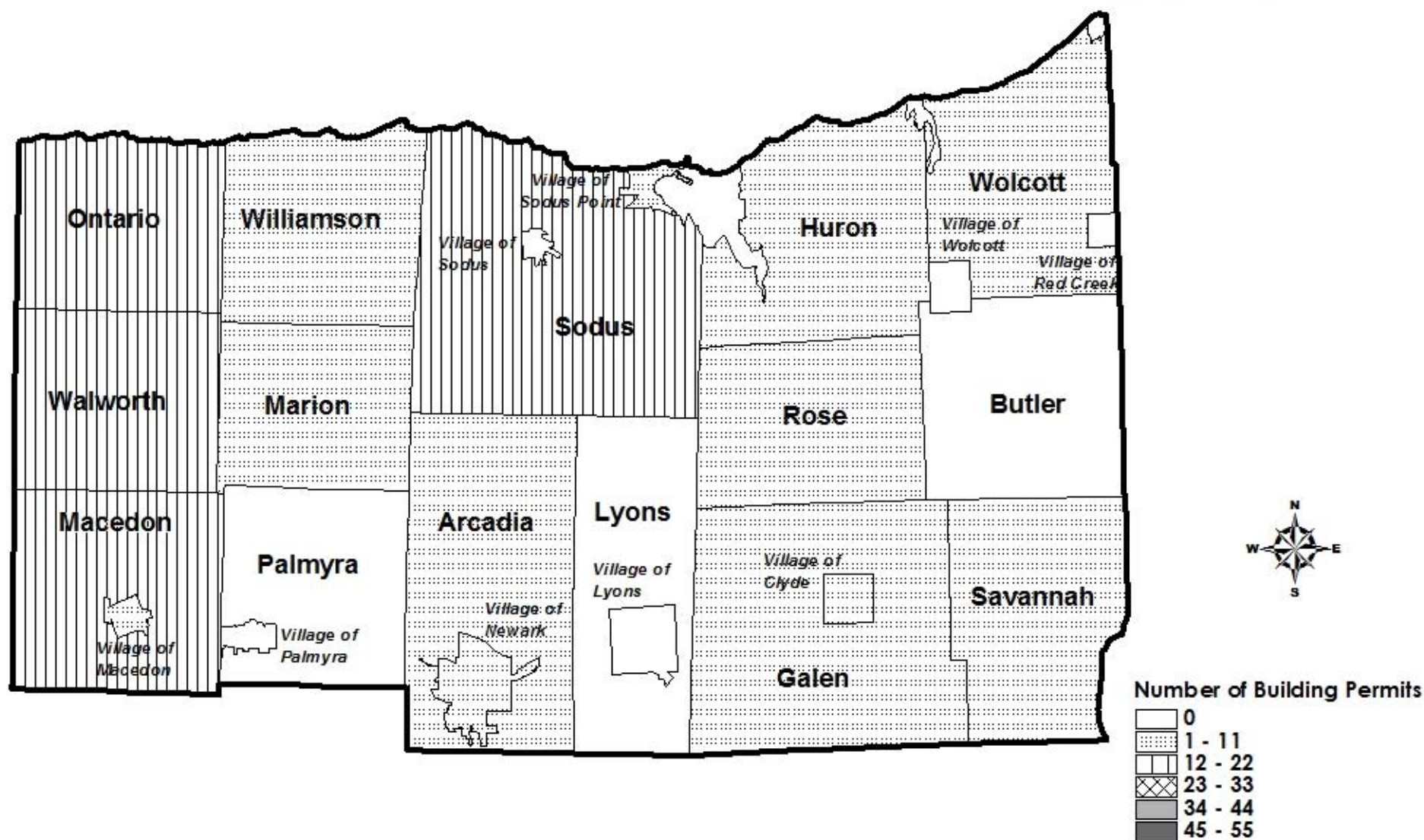

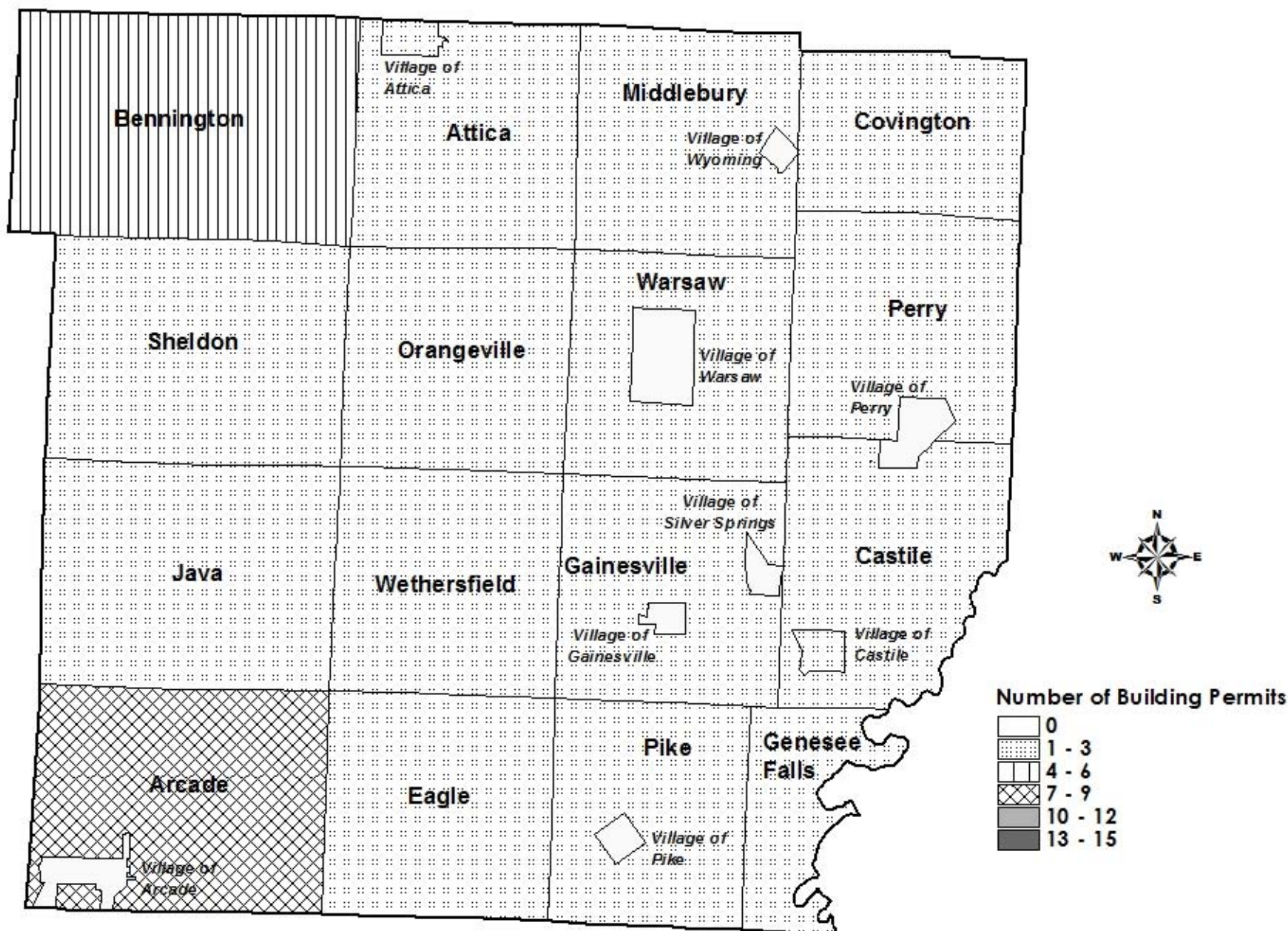

Number of Residential Unit Permits in Wyoming County (2011)



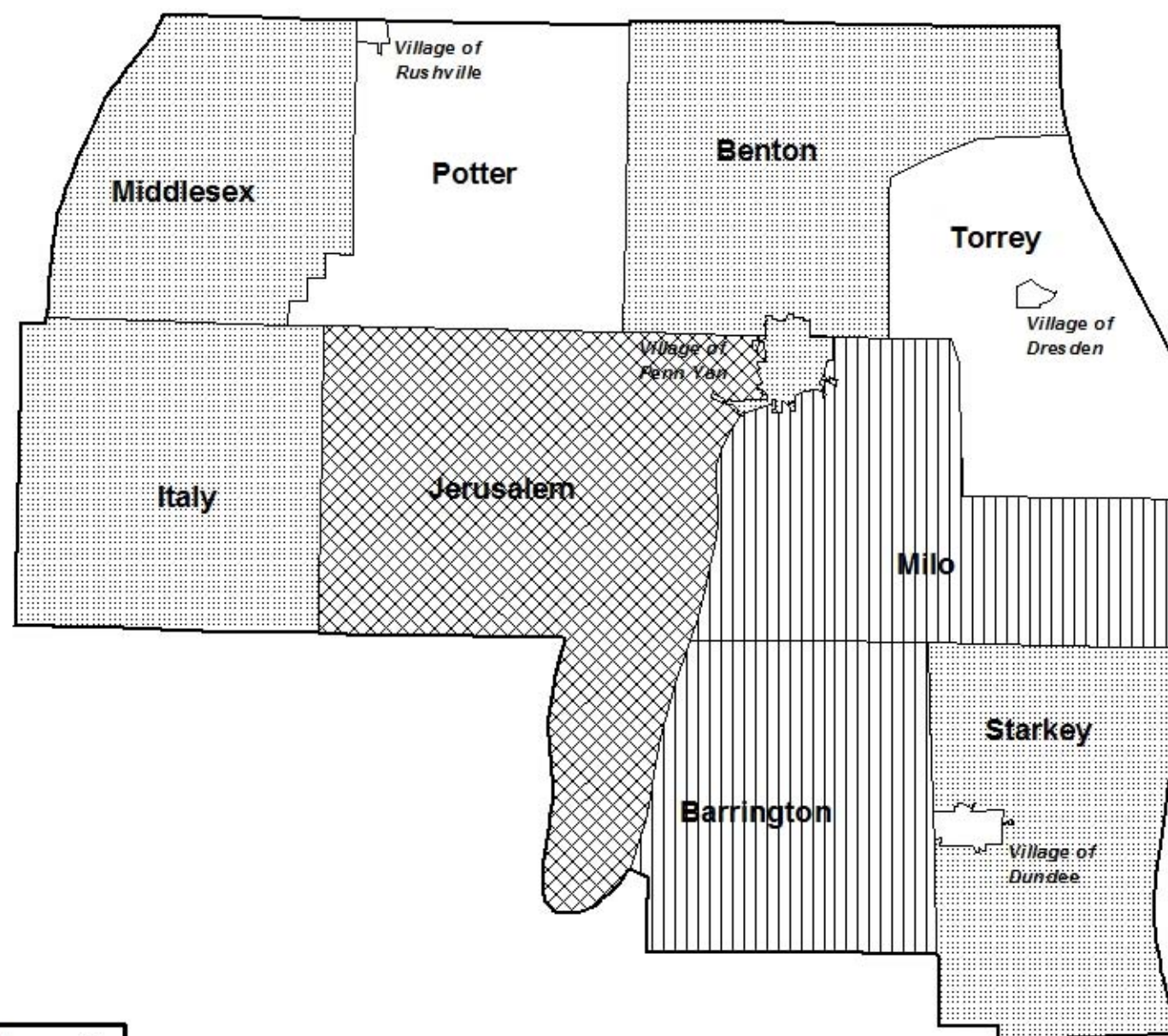

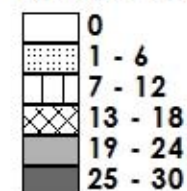

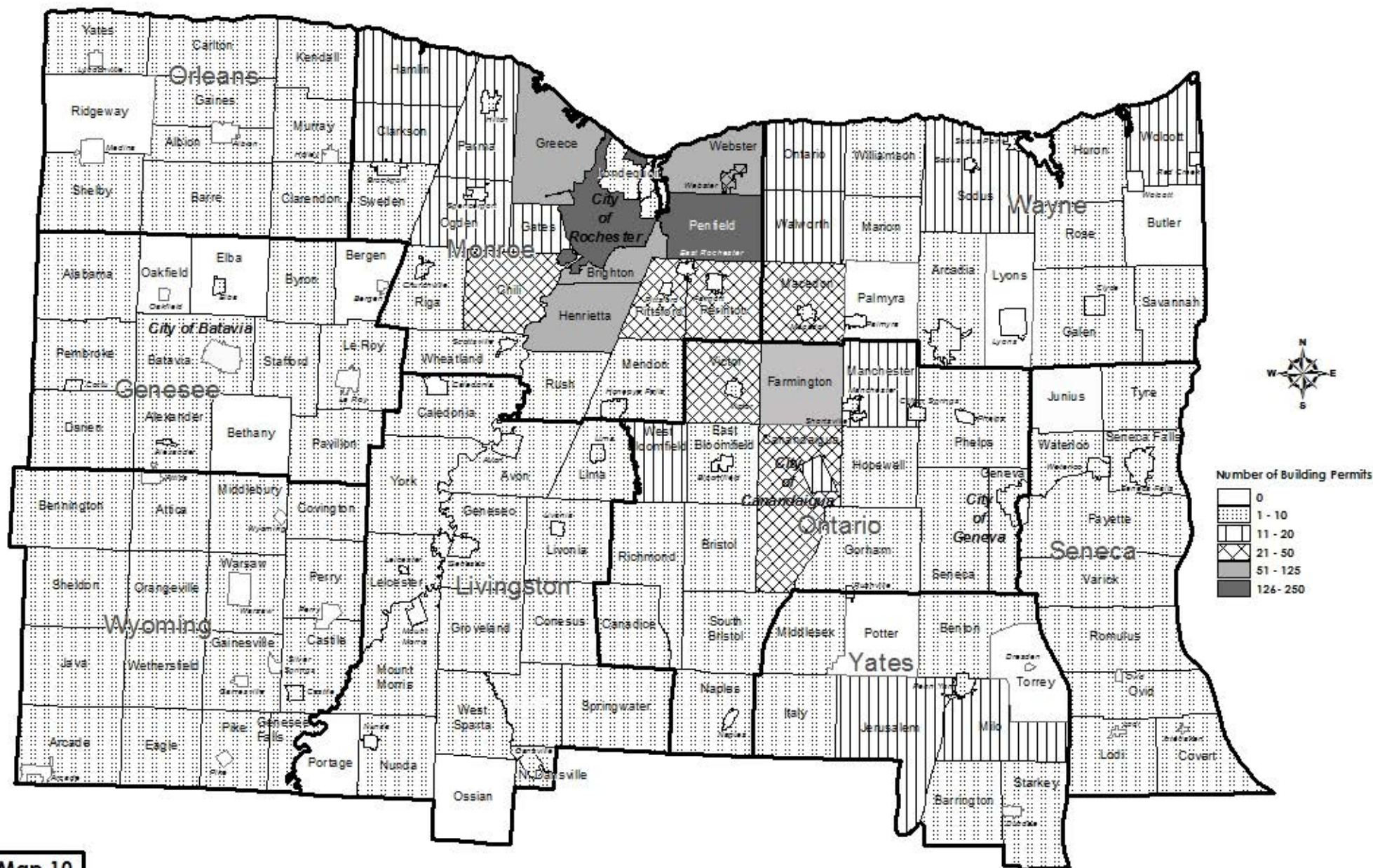

Number of Residential Unit Permits in the Genesee/Finger Lakes Region (2011)



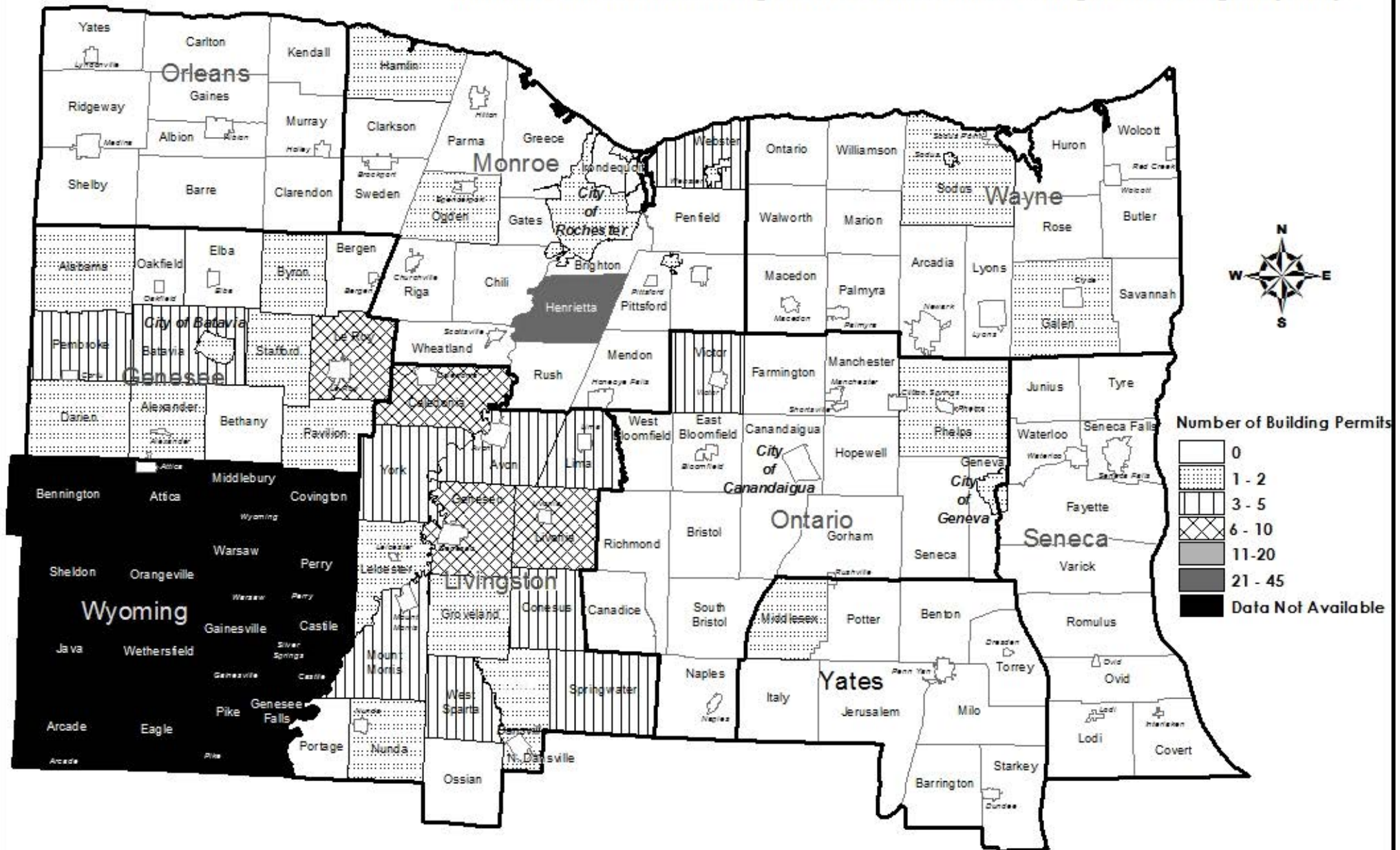

Number of Industrial Building Permits in the Genesee/Finger Lakes Region (2011)



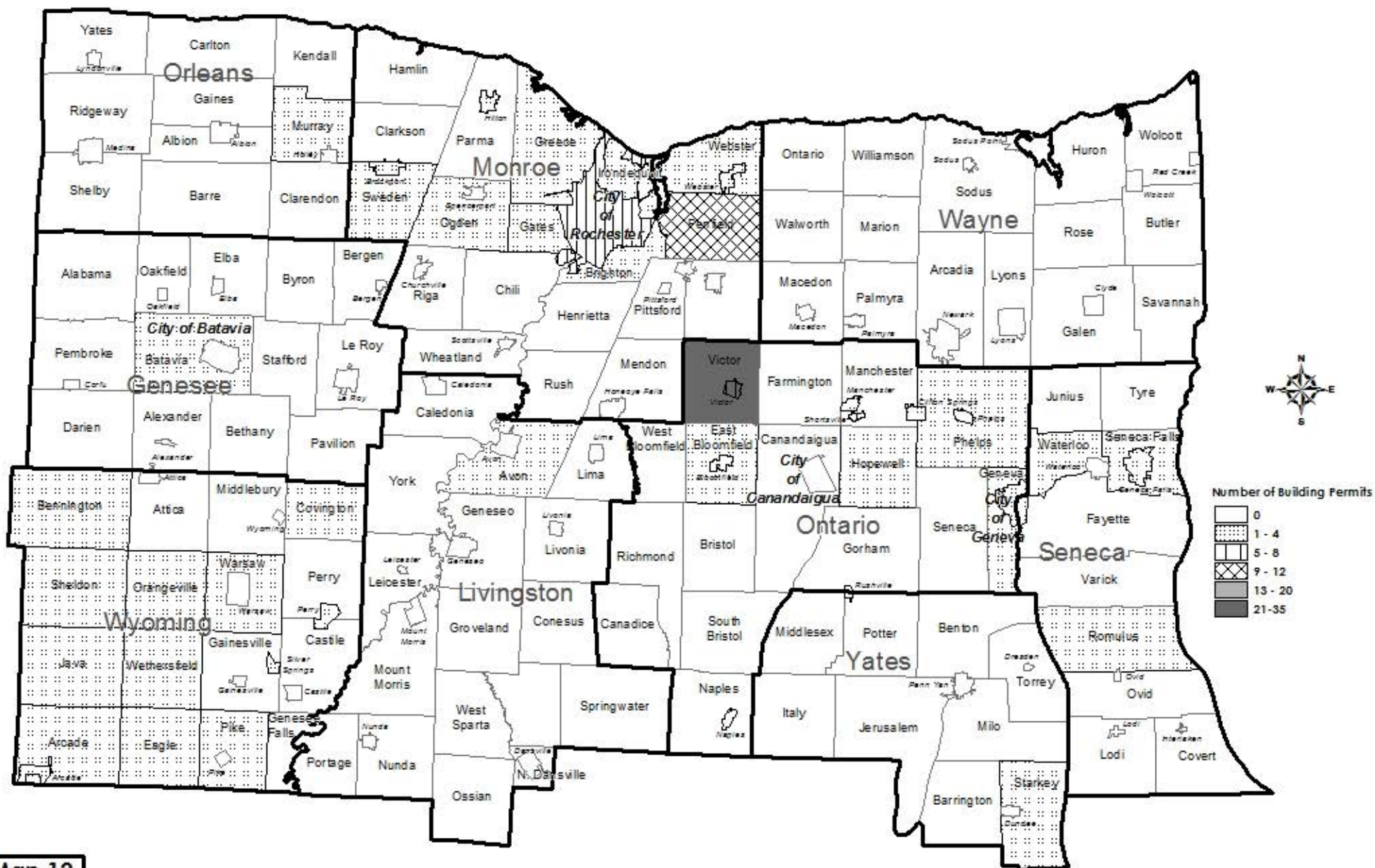

Number of Commercial Building Permits in the Genesee/Finger Lakes Region (2011)



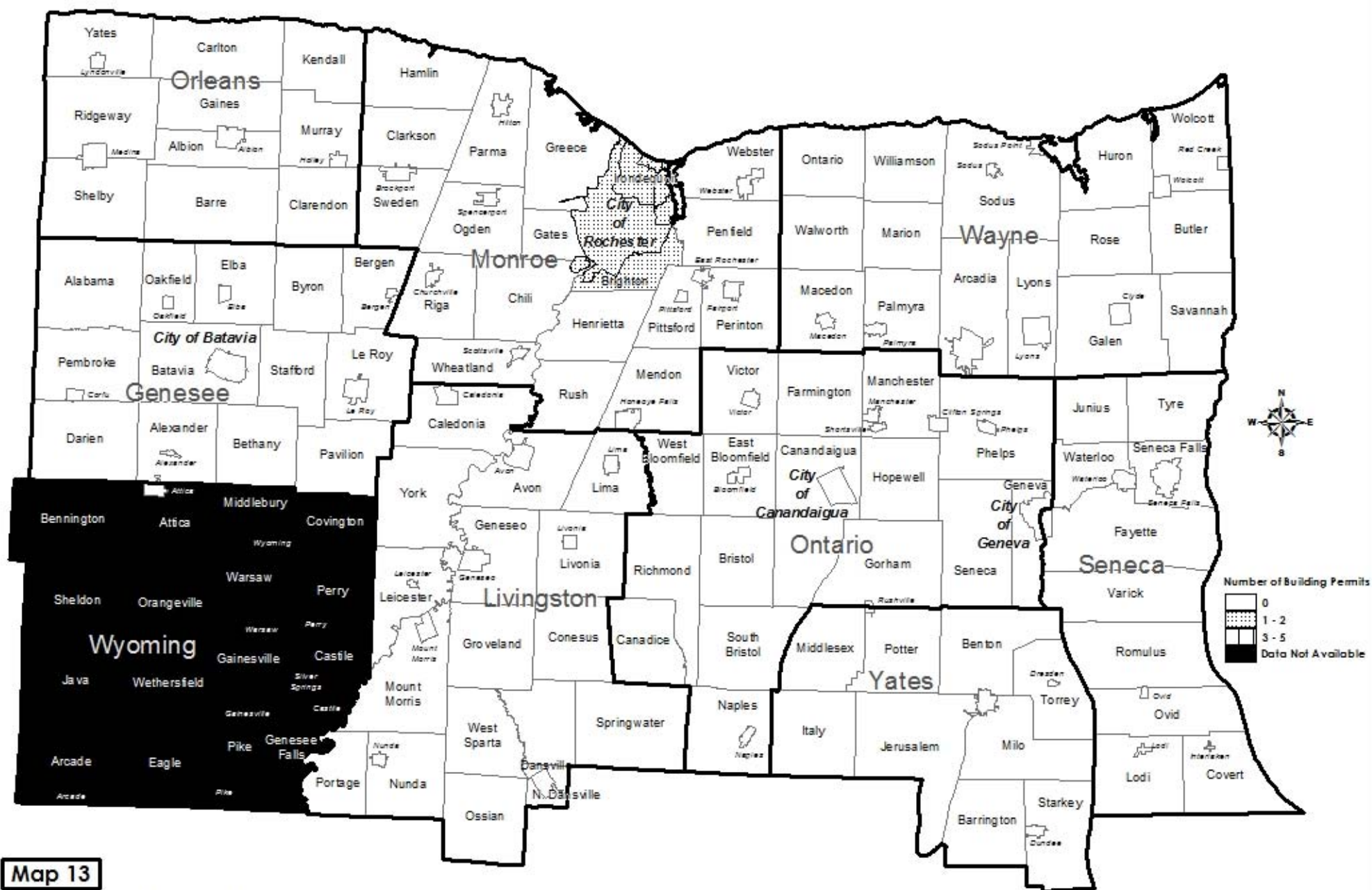

Number of Community Service Building Permits in the Genesee/Finger Lakes Region (2011)



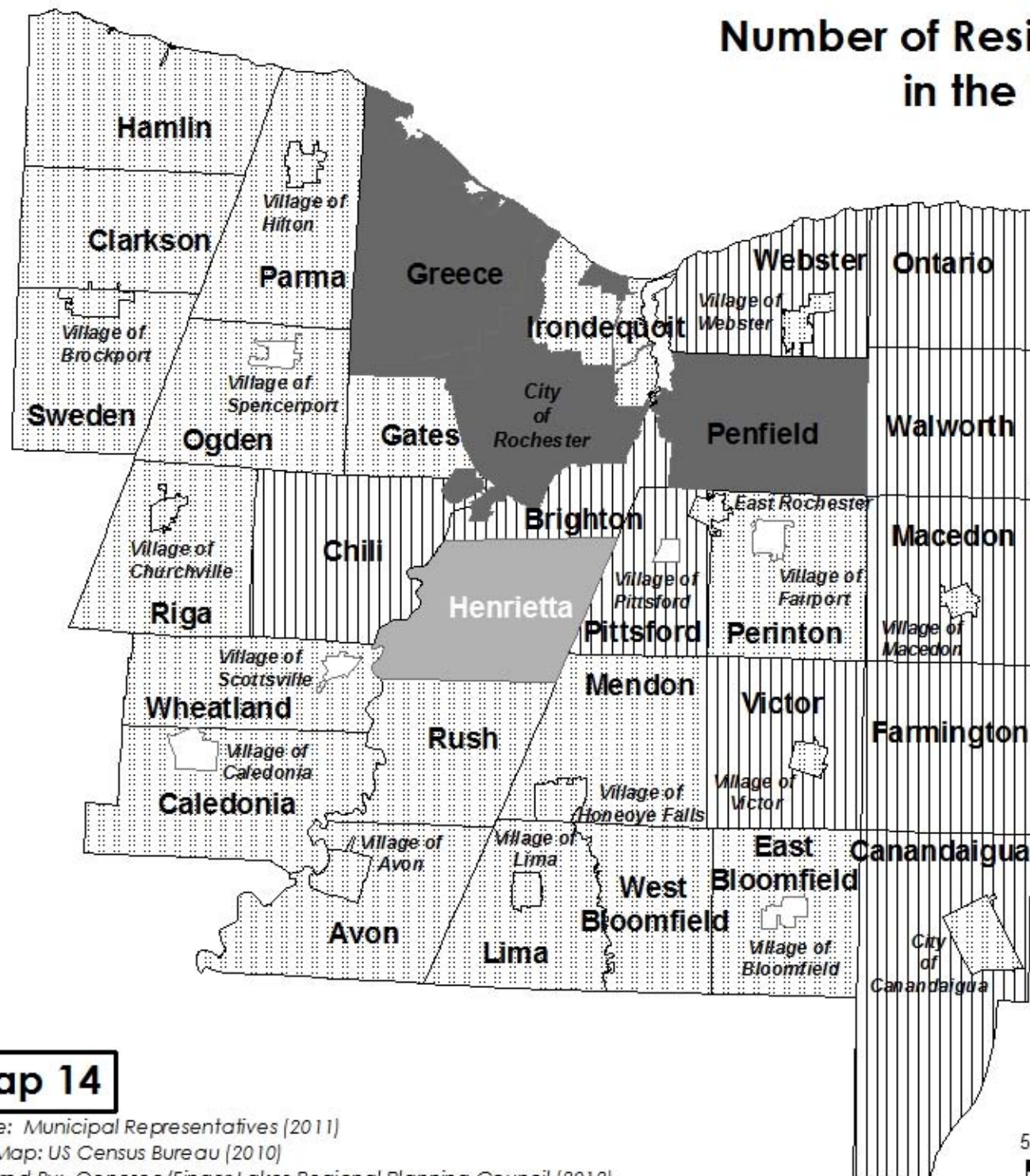

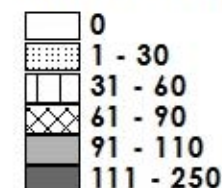

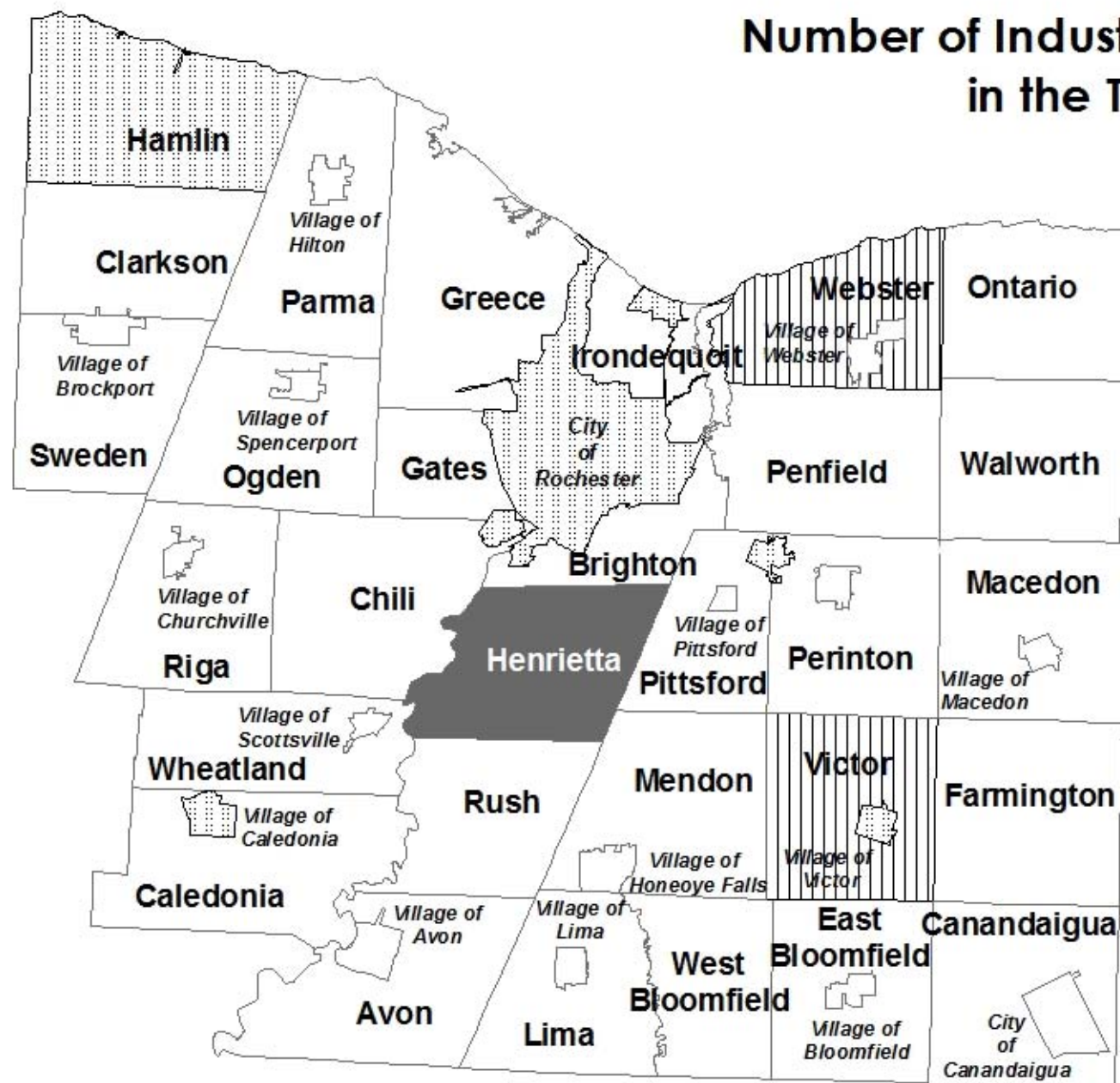

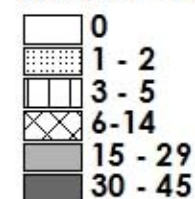

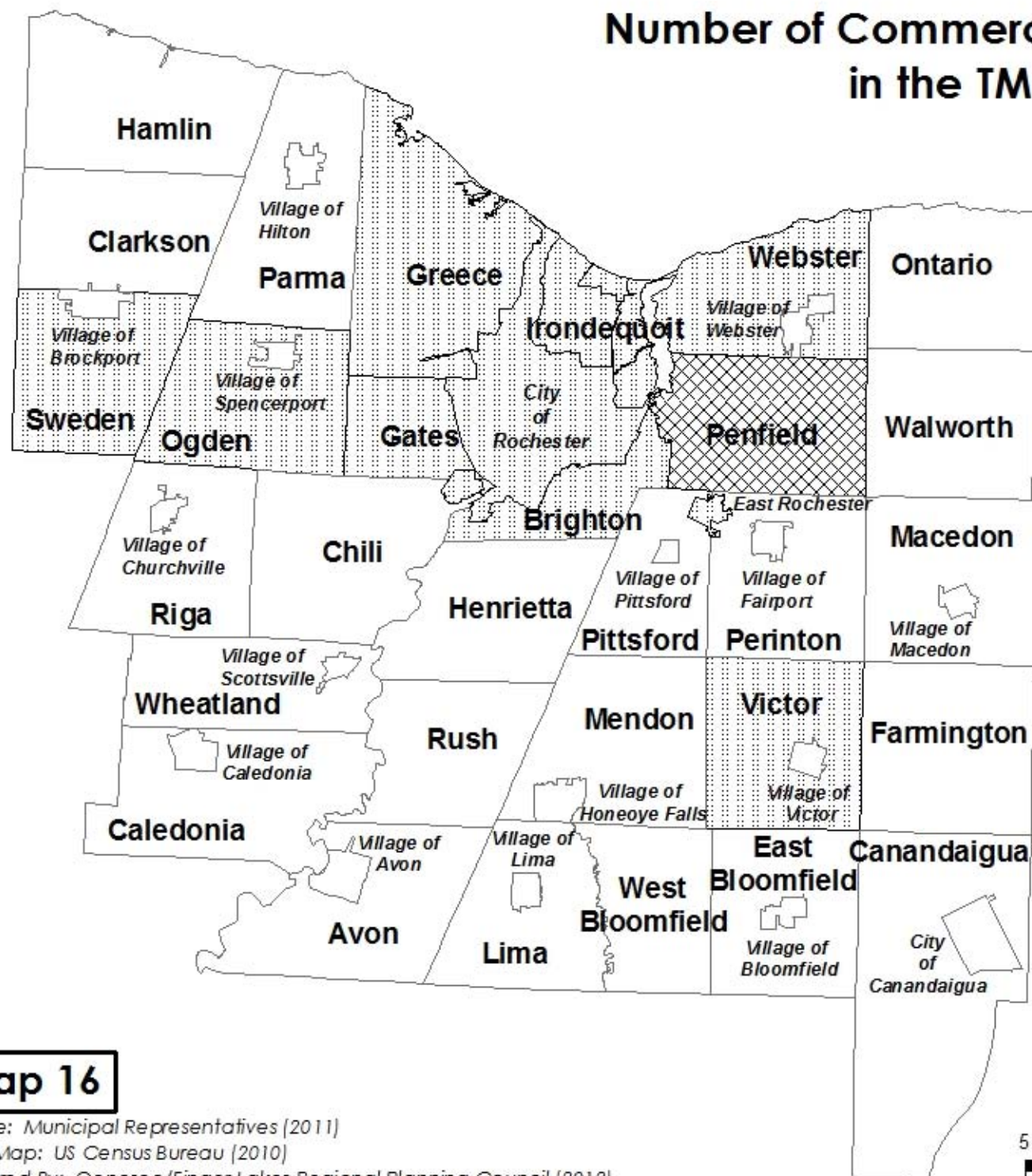

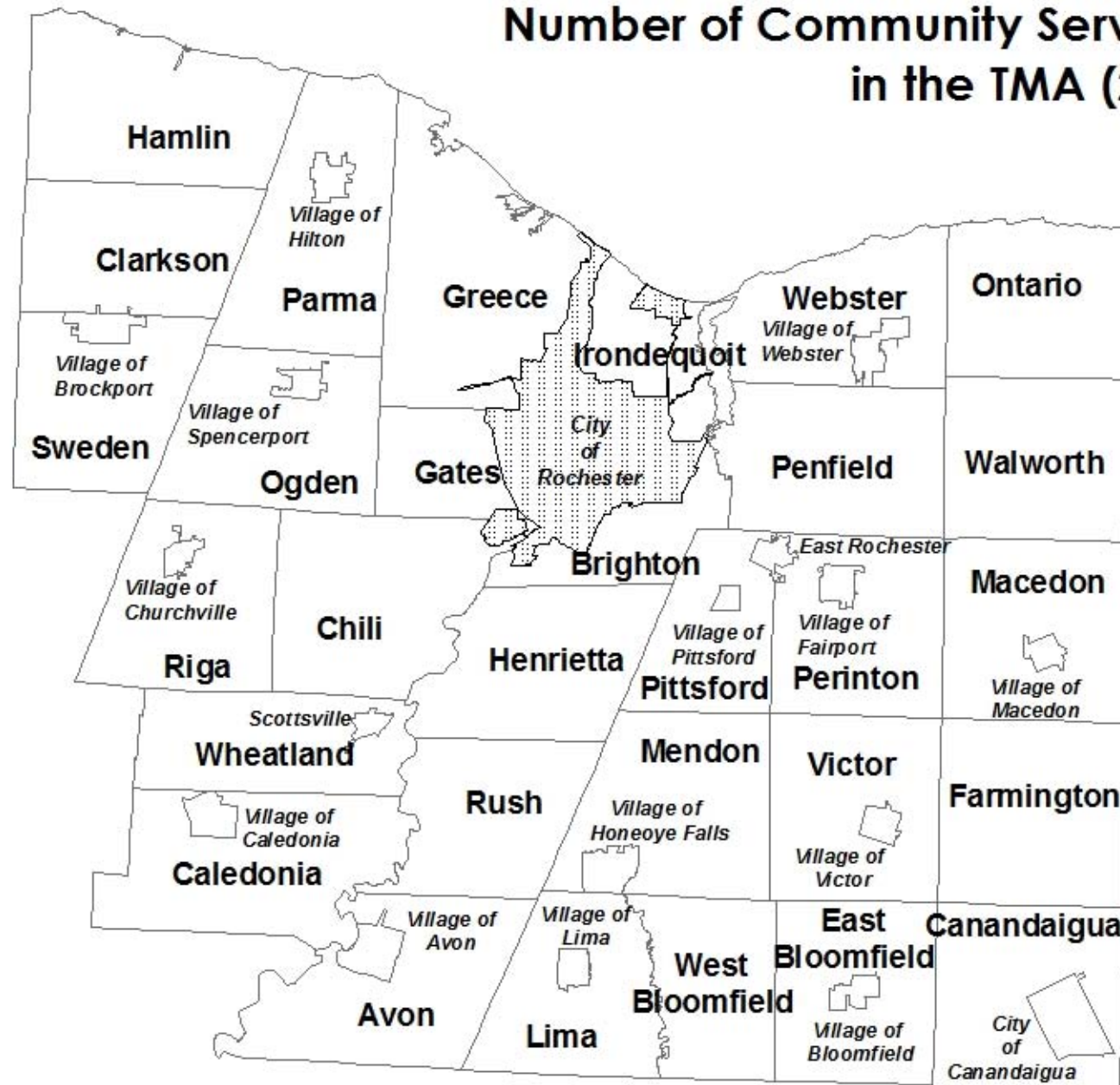

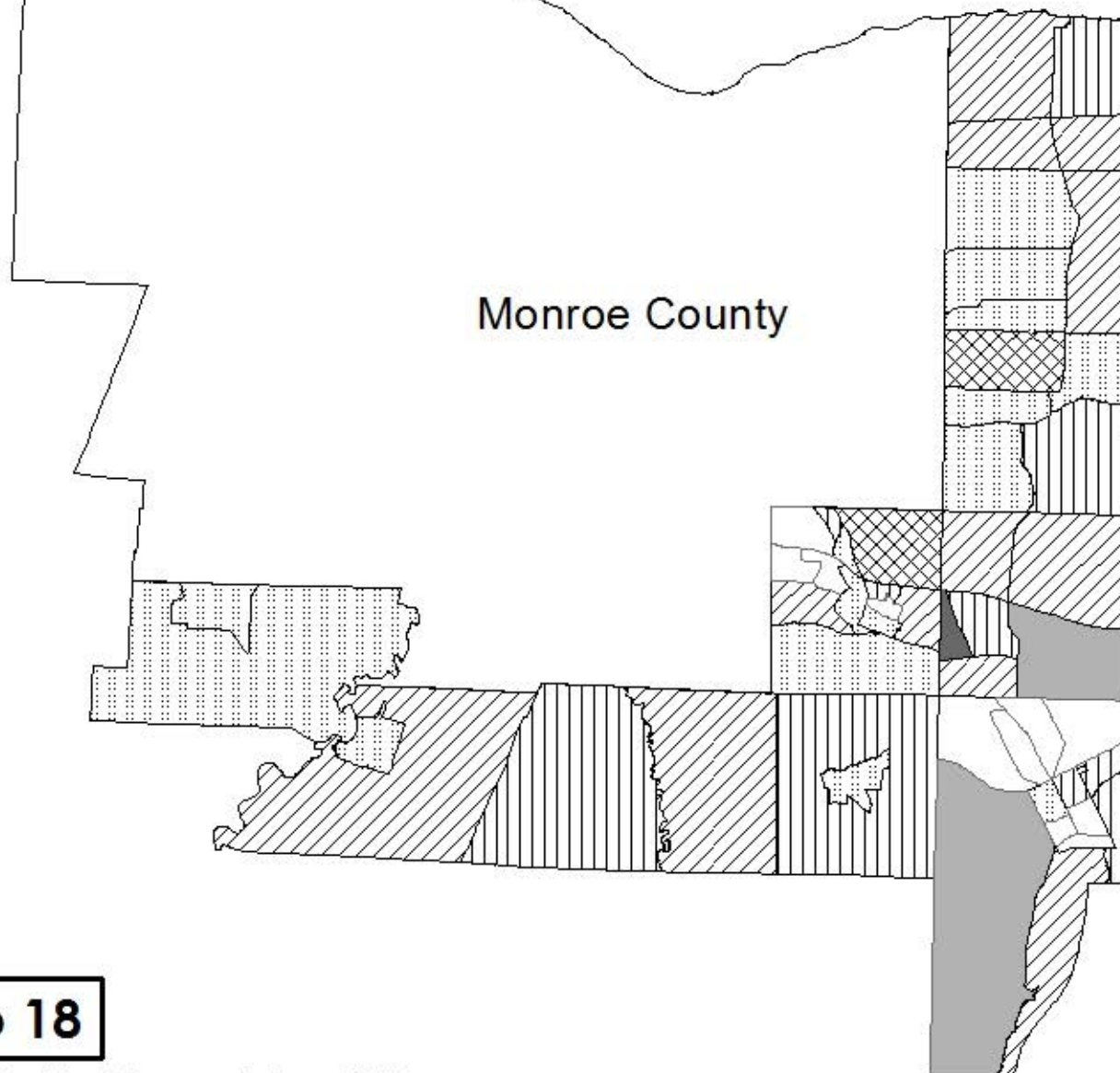

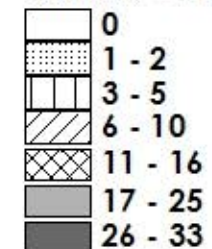

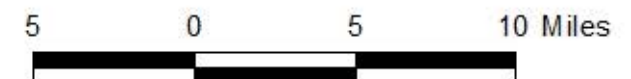
