

# Regional Land Use Monitoring Report (2012)

## UPWP Task #4220

### Executive Summary

#### **Project Purpose:**

The Genesee Transportation Council (GTC) provides funding annually for the *Regional Land Use Monitoring Report* under its Unified Planning Work Program. This report provides information on the issuance of building permits in 2012 to identify areas of growth within the Genesee-Finger Lakes Region (G-FL Region) that might require transportation planning and service modifications.

The G-FL Region is comprised of Genesee, Livingston, Monroe, Ontario, Orleans, Seneca, Wayne, Wyoming, and Yates Counties. The report analyzes the number of permits issued, total square footage, and total value for buildings for each municipality within the region as well as the Transportation Management Area (TMA). The TMA covers Monroe County and the municipalities adjacent to Monroe County in Livingston, Ontario, and Wayne Counties, as well as the Town and City of Canandaigua. The analysis looks at the following categories and respective subcategories: “residential” (single-family, two-family, three or four-family, five-or- more family, mobile/manufactured homes); “industrial;” “commercial” (offices/banks, retail/service, service stations, hotels/motels); “community service” (hospitals/health facilities, schools/churches, public works/safety, utilities); and “not elsewhere classified.”

A five-year trend analysis is provided for permitted residential units in all nine counties; industrial, commercial, and community service building permits are analyzed over the three-year period as well. In addition, a time series (or historical trend) analysis is provided for residential, industrial, and commercial development, as well as subdivision approvals in the Transportation Management Area (TMA).

To provide further insight into municipal related information, municipalities were requested to provide the most recent updates related to zoning maps and ordinances as of 2012.

#### **Project Methodology:**

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties, these officials were, in most municipalities, the code or zoning enforcement officers. In some cases they were municipal clerks. In Seneca and Wyoming Counties building permit application approval and inspection are the responsibility of the respective county building departments. Those two departments provided the data for their counties. The Monroe County Planning and Development Department’s Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to the Genesee/Finger Lakes Regional Planning Council.

Surveys were distributed in January of 2013 asking for the requested data. The initial survey was followed up with a reminder e-mail along with a telephone reminder to those municipalities that had yet to respond. In some cases, several calls were made to the appropriate parties in an effort to acquire the requested information. Complete data was collected for all 190 municipalities in the nine-county G-FL Region.

### **Analysis Overview:**

The highest number of residential permits in the G-FL Region in 2012 was in the Town of Greece (161) followed by Towns of Penfield (125), City of Rochester (108), Henrietta (106), Canandaigua (68) and Ogden (56). The Town of Greece permits issued totaled the largest number of units (199). The Towns of Webster and Brighton's permits issued totaled 166 and 149 units respectively.

The majority of industrial and commercial permits were issued in municipalities in the TMA.

Over the years (2003-2012), the majority of permits for residential units in the TMA have been in Monroe County. In the TMA outside of Monroe County, the Towns of Victor, Canandaigua, and Farmington in Ontario County, and the Towns of Ontario and Walworth in Wayne County issued permits for the largest number of residential units over the same ten year time frame.

The data on permitted building activity and demolition tables are provided in appendices at the end of this report. Overall, the report serves as an information resource for the GTC and others to view and analyze permit activity in the G-FL Region to identify potential growth areas, and anticipate increased transportation needs.

## Introduction

The Genesee Transportation Council (GTC) provides funding annually for the *Regional Land Use Monitoring Report* (LUMR) under its Unified Planning Work Program. The purpose of this report is to provide information for building permits by type, size, and value to identify areas of growth within the Genesee-Finger Lakes (G-FL) Region that may, as a result, require increased transportation planning and services.

The *Regional Land Use Monitoring Report* includes residential, industrial, commercial, and community service building permit data for all nine counties in the G-FL Region. The categories (and associated subcategories) for building permit data are as follows:

- Residential (single-family, two-family, three-or-four-family, five-or-more-family, and mobile/manufactured homes )
- Industrial
- Commercial (offices/banks, retail/service, service stations, hotels/motels)
- Community Service (hospitals, schools)
- Not Elsewhere Classified

A five-year trend analysis is provided for permitted residential units in all nine counties and industrial, commercial and community service building permits are analyzed over the five-year period. This time-series analysis is based on this year's and the four previous years' Land Use Monitoring Reports produced by the Genesee/Finger Lakes Regional Planning Council (G/FLRPC).

In addition, a time series (or historical trend) analysis is provided for residential, industrial, and commercial development and subdivision approvals in the Transportation Management Area (TMA).

The TMA includes Monroe County and the adjacent municipalities to the south and east as well as the City and Town of Canandaigua. Table 1 represents the municipalities that, along with Monroe County, comprise the Transportation Management Area.

An analysis of the collected data on the number, value, and size of buildings permitted in 2012 is provided for each county as well as the TMA.

Given that many conclusions can be drawn from the data on permitted building activity tables are provided in appendices at the end of this report for the reader to use for their own needs and analysis.



## **Methodology**

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties these officials were, in most cases, the code or zoning enforcement officers; in some cases the municipal clerks. In Seneca and Wyoming Counties building permit application approval and inspection are the responsibility of the respective county building departments. Those two departments provided the data for their counties. The Monroe County Planning and Development Department's Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to G/FLRPC.

As noted above, each municipality other than Seneca and Wyoming Counties received a survey in January of 2013 asking for the requested data. The initial survey was followed up with a reminder e-mail along with a telephone reminder to those municipalities that had yet to respond. In some cases, several calls or e-mails were made to the appropriate parties in an effort to acquire the requested information. Overall, 100% of the data was collected from all 190 municipalities within the nine-county G-FL Region.

The survey requested information on the number of permits issued, total square footage and total value for buildings in the defined categories and associated subcategories. In addition, the same building permit information for buildings outside of these categories was requested along with a description of the type of building(s) in the "Other" category. This year the LUMR survey included an additional request

from municipalities. All analysis conducted in this report is based on data provided by each LUMR survey contact.

The instructions for completing the survey as printed on the first of the two-page document were as follows:

*"Include only permits for the construction of buildings in 2012. Do not include additions, repairs, decks, in-ground pools, etc. or buildings used for storage such as sheds and pole barns. Do not include permits for construction that was completed in 2012 but permitted in a previous calendar year. If the responses below include a town and a village on the same sheet, please denote this by listing them separately on the same line (example: T – 8/V – 12)."*

For each of the nine counties, there is a discussion of permitted building activity in 2012 and county maps of residential units permitted in 2012 by municipality (Maps 1 – 9, Map 10 represents Permits for Residential Units for the nine-county G-FL Region). Data of industrial, commercial, and community service building permits issued in 2012 are presented on maps of the nine-county G-FL Region (Maps 11-13).

The information and data provided for permitted building activity in Monroe County and the remaining portion of the TMA follows the same format. Maps 14 through 17 present the number of permitted residential, industrial, commercial, and community service buildings in the TMA in 2012. Map 18 shows the distribution of residential building permits among the Transportation Analysis Zones (TAZ) within the TMA outside of Monroe County.

The residential data for TMA municipalities were used in a time series analysis of the number of residential units permitted by municipality for the years 2003 through 2012. The

number of permits issued for industrial and commercial buildings from 2003 to 2012 in the TMA outside of Monroe County is also presented and discussed in the same manner.

The data gathered on number of building permits issued, square footage, and value in each category/subcategory by municipality in and for the TMA outside Monroe County are presented in Appendices A through H. The Appendices are as follows:

## **2012 County Building Permit Analysis**

### **Genesee County**

#### ***Residential Permits:***

- Twenty two (22) residential building permits were issued in Genesee County in 2012. The largest number of permits (7) was issued in the Town of Pembroke. Permits issued totaled 12,403 square feet with a combined value of \$1,533,125. The Town of Batavia issued the second highest total of permits with five. Permits issued totaled 15,020 square feet with a combined value of \$6,115,137.

*Map 1 shows the number of residential unit permits in Genesee County in 2012.*

#### ***Industrial Permits:***

- There were two industrial building permits issued in 2012, both in the Town of Batavia. Permits issued totaled 371,000 square feet with a combined value of \$265,000,000.

*Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2012.*

#### ***Commercial Permits:***

- There were two commercial buildings permits issued in 2012, both in the Town of Batavia. Permits issued totaled 65,000 square feet with a combined value of \$2,900,000.

*Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2012.*

#### ***Community Service Permits:***

- There was one community service building permit issued in 2012, in the Town of Batavia. The permit issued totaled 6,200 square feet with a value of \$600,000.

*Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2012.*

#### ***Not Elsewhere Classified Permits:***

- No permits were reported that would be included as not elsewhere classified for Genesee County municipalities in 2012.

#### ***Demolition Permits:***

- Thirteen (13) residential demolitions were permitted in Genesee County in 2012.

## Livingston County

### **Residential Permits:**

- Eighty three (83) residential permits, were issued in Livingston County in 2012. The largest number of permits issued were in the Towns of Livonia (15) and West Sparta (13).

### **Industrial Permits:**

- There were three industrial building permits issued in 2012, two in the Town of Livonia and one in the Village of Nunda.

*Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2012.*

### **Commercial Permits:**

- No permits for industrial buildings were reported in Livingston County in 2012.

*Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2012.*

### **Community Service Permits:**

- One permit for community service building was reported in the Town of Lima.

*Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2012.*

### **Not Elsewhere Classified Permits:**

- Twenty (20) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

### **Demolition Permits:**

- Twelve (12) demolitions were permitted in Livingston County in 2012.

## Monroe County

### **Residential Permits:**

- Municipalities in Monroe County issued 766 residential building permits for a total of 1,146 residential units in 2012. The largest number of permits issued was in the Town of Greece (161) totaling 199 units, with a total value of \$23,748,900.

The Town of Penfield issued the next largest number of residential permits (125), followed by the City of Rochester (108), and the Town of Henrietta (106).

- A total of 54 multi-family unit permits were issued for 380 units in the county.

### **Industrial Permits:**

- There were three industrial building permits issued in the entire County, two in the Town of Clarkson and one in the City of Rochester.

*Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2012.*

### **Commercial Permits:**

- In the category of commercial buildings, 17 permits were issued in Monroe County. The Town of Henrietta issued the highest with 15 permits.

*Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2012.*

### **Community Service Permits:**

- One (1) permit was issued for a community service building in Monroe County, with a total value of \$6,064,391. The permit was for a school.

*Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2012.*

### **Not Elsewhere Classified Permits:**

- Ten (10) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

### **Demolition Permits:**

- Of all the counties in the G-FL Region, the most demolitions in 2012 were permitted in Monroe County. There were 244 demolition permits issued. The City of Rochester issued the highest number of demolition permits with 198.

## Ontario County

### **Residential Permits:**

- Ontario County municipalities permitted 265 residential structures in 2012, for a total of 287 units. The Town of Canandaigua issued the most permits with 68, with total units at 89. The Town of Victor issued the second most permits with 50. The Towns of Farmington and Manchester issued 30 permits each.

### **Industrial Permits:**

- There was one industrial building permit issued in Ontario County in 2012.

### **Commercial Permits:**

- Thirteen (13) commercial building permits were issued in Ontario County.

*Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2012.*

- There were no permits reported for community service buildings in Ontario County in 2012.

*Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2012.*

### **Not Elsewhere Classified Permits:**

- Four (4) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

### **Demolition Permits:**

- Twenty three (23) demolitions were permitted in Ontario County in 2012.

## Orleans County

### **Residential Permits:**

- A total of 27 residential building permits were issued in Orleans County in 2012. The Towns of Ridgeway and Carlton issued the largest number of permits in the County with seven and four respectively.

### **Industrial Permits:**

- No industrial permits were reported for Orleans County in 2012.

## Seneca County

### **Residential Permits:**

- Fifty six (56) residential building permits were reported in Seneca County in 2012. The largest number of permits issued was in the Town of Waterloo (14), followed by the Towns of Junius and Seneca Falls with seven each.

### **Industrial Permits:**

- No industrial building permits were reported in Seneca County in 2012.

*Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2012.*

### **Commercial Permits:**

- No commercial building permits were reported in Seneca County in 2012.

*Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2012.*

### **Community Service Permits:**

- No community service buildings were reported in Seneca County for 2012.

### **Not Elsewhere Classified Permits:**

- No permits were reported that would be included as not elsewhere classified for Seneca County municipalities.

### **Demolition Permits:**

- Twelve (12) demolition permits were issued in Seneca County in 2012.

## Wayne County

### **Residential Permits:**

- Municipalities in Wayne County issued 85 permits in 2012. The highest total of permits issued in the County was in the in the Town of Ontario (20) followed by the Town of Walworth (15) and Galen (11).

### **Industrial Permits:**

- Four (4) permits were issued for industrial buildings in Wayne County in 2012.

*Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2012.*

- One commercial building permit was reported in Wayne County for 2012.

*Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2012.*

### **Community Service Permits:**

- No community service buildings were reported in Wayne County for 2012.

*Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2012.*

### **Not Elsewhere Classified Permits:**

- One (1) permit was issued that did not correspond to the above-described categories and is included as not elsewhere classified.

### **Demolition Permits:**

- Twenty five (25) demolition permits were reported in Wayne County in 2012.

## Wyoming County

### **Residential Permits:**

- In 2012, municipalities in Wyoming County issued 39 permits for residential structures. The Town of Arcade issued the most permits with seven. The Town of Orangeville issued the second highest permits with six.

**Map 8 shows the number of residential unit permits in Wyoming County in 2012.**

### **Industrial Permits:**

*(Wyoming County does not categorize Industrial permits)*

- The information reported by Wyoming County for permits issued does not correspond directly to the survey categories. Information related to industrial permits is not categorized by Wyoming County but it is categorized under commercial permits. Therefore, it is unclear how many permits were issued for industrial buildings in the County in 2012.

**Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2012.**

### **Commercial Permits:**

- A total of 17 permits were issued for commercial buildings in the County in 2012.

**Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2012.**

### **Community Service Permits:**

*(Wyoming County does not categorize community service permits)*

- The Information reported by Wyoming County for permits issued does not correspond directly to the survey categories. Information related to community service permits is not categorized by Wyoming County. Therefore, it is unclear how many permits were issued for community service buildings in the County in 2012.

**Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2012.**

### **Not Elsewhere Classified Permits:**

*(Wyoming County does not specify not elsewhere classified permits)*

- The Information reported by Wyoming County for permits issued, does not correspond directly to the survey categories. Therefore, it is unclear how many permits were issued for not elsewhere classified in the County in 2012.

### **Demolition Permits:**

- Twenty three (23) unspecified demolition permits were issued in Wyoming County in 2012.

## Yates County

### **Residential Permits:**

- Municipalities in Yates County issued 67 residential building permits in 2012. The Town of Jerusalem issued the most permits with 16. The Town of Milo issued the second most permits with 11.

### **Industrial Permits:**

- One (1) industrial building permit was issued in 2012.

## **5-Year Building Permit Analysis (2008 – 2012)**

### **Genesee County**

#### ***Residential Units:***

- During the five-year period from 2008 through 2012, the total number of units permitted was 264 in Genesee County.
- The City of Batavia permitted the most residential units in Genesee County with 82. The Town of Batavia issued the next highest number of units (49). The Towns of Pembroke, Darien and LeRoy had the next highest number of units with 27, 19 and 18 respectively.

#### ***Industrial Units:***

- A total of eight units were permitted for industrial buildings in Genesee County from 2008 to 2012.

#### ***Commercial Units:***

- Thirteen (13) commercial units were permitted in Genesee County from 2008 to 2012.

#### ***Community Service Units:***

- Six (6) community service units were permitted from 2008 to 2012.

## **Livingston County**

### ***Residential Units:***

- During the five-year period from 2008 through 2012, the total number of units permitted was 415 in Livingston County.
- The Town of Livonia reported the highest number residential units (61) from 2008 to 2012, more than any other municipality in Livingston County. The Town Geneseo permitted the next largest number of residential units with 46, followed by the Town of Avon with 38.

### ***Industrial Units:***

- Eighteen (18) industrial units were permitted in Livingston County from 2008 to 2012. The Towns of Groveland and Livonia issued the most permits for industrial units with five each.

### ***Commercial Units:***

- Twenty one (21) commercial units were permitted from 2008 to 2012. The Village of Geneseo permitted the largest number of commercial units with five.

### ***Community Service Units:***

- Twelve (12) community service units were permitted in Livingston County from 2008-2012.
-

## Monroe County

### **Residential Units:**

- During the five-year period from 2008 through 2012, the total number of units permitted was 5,729. Monroe County issued the most residential permits and totaled the most units in the region.
- The City of Rochester permitted the largest number of residential units (849) followed by the Towns of Henrietta (776), Greece (723), Webster (676), and Penfield (640).

### **Industrial Units:**

*The Towns of Chili and Penfield do not categorize industrial and commercial permits.*

- A total of 193 industrial units were permitted in Monroe County. The Town of Henrietta permitted the most (111).

### **Commercial Units:**

*The Towns of Chili and Penfield do not categorize industrial and commercial permits.*

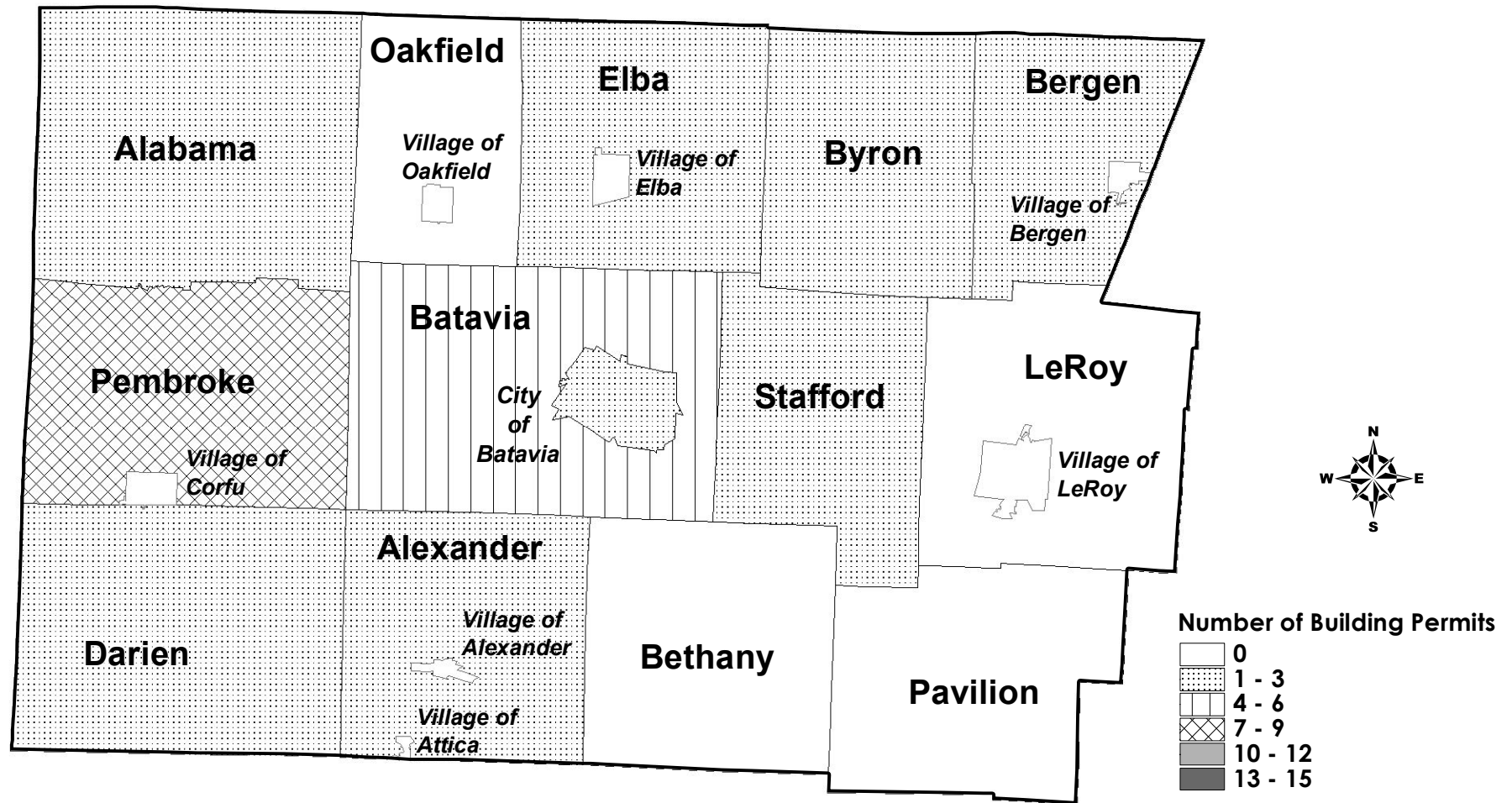

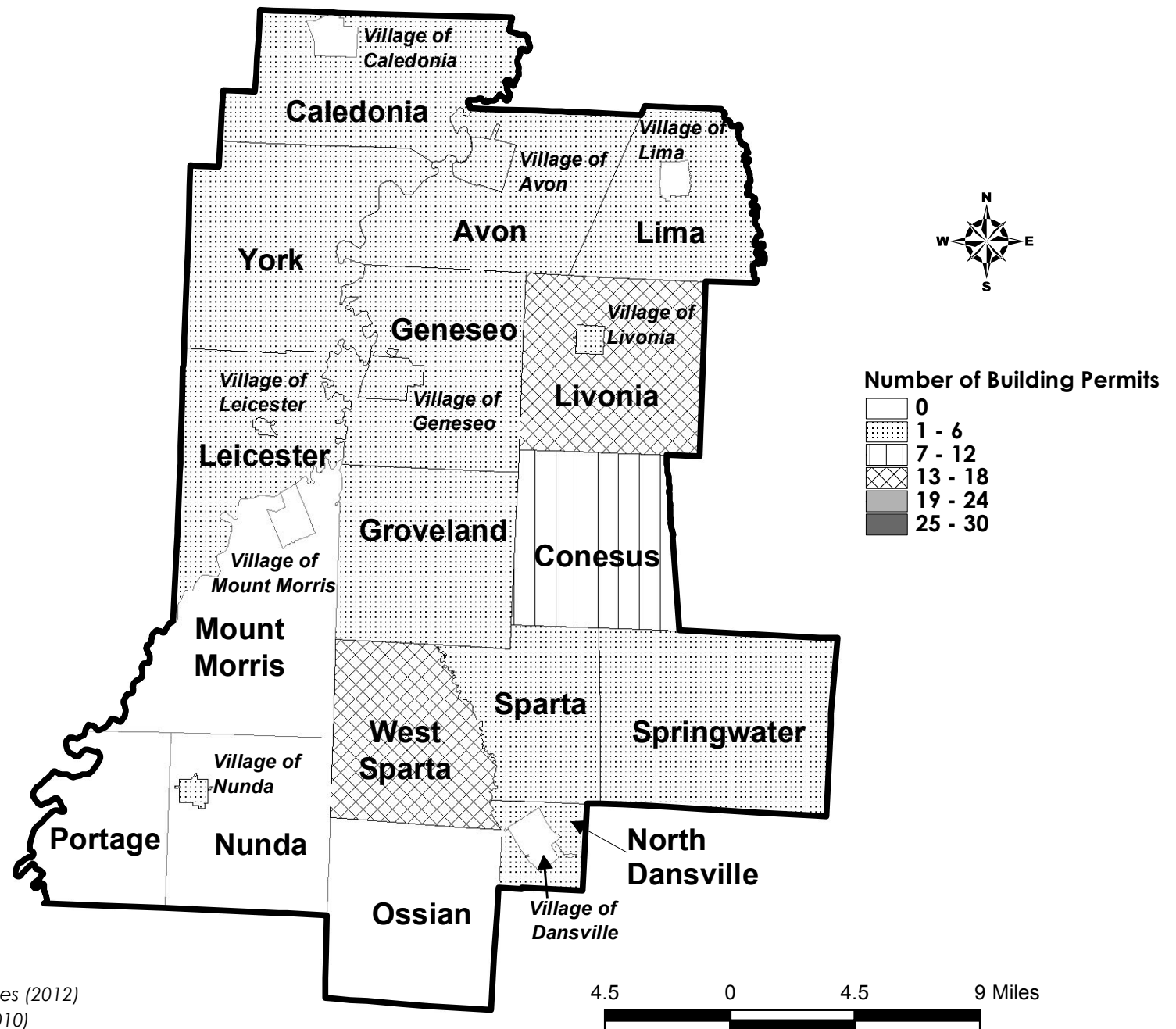

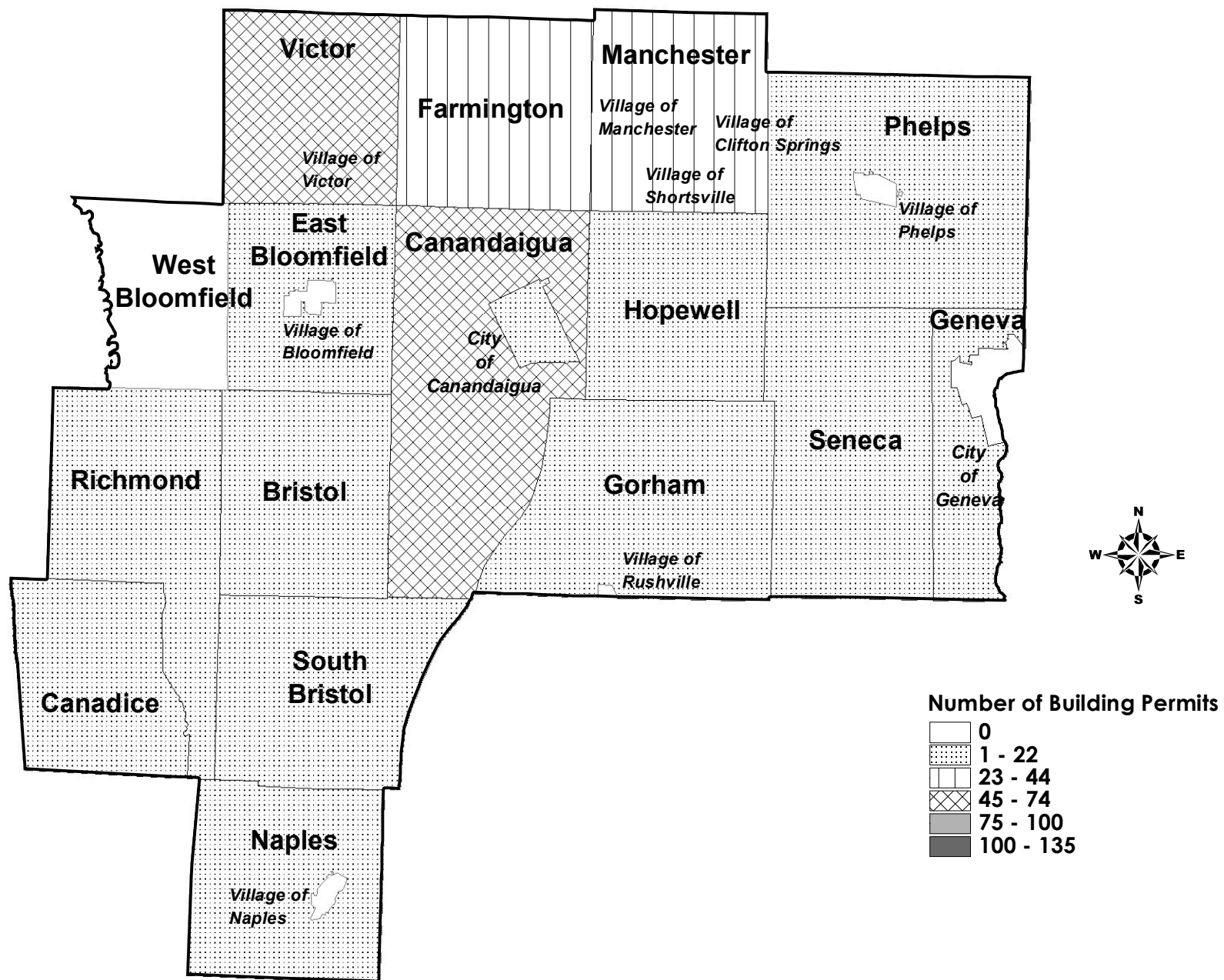

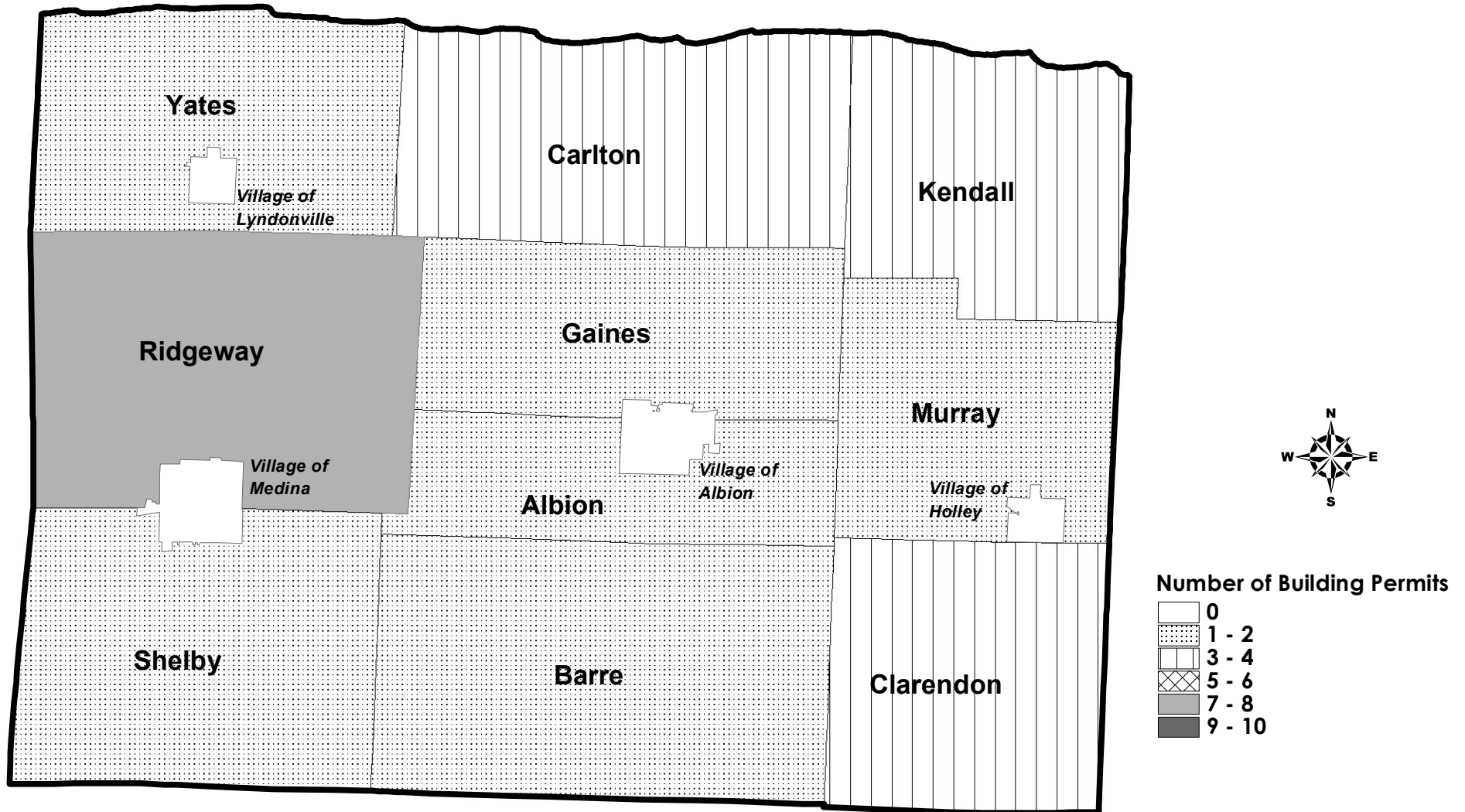

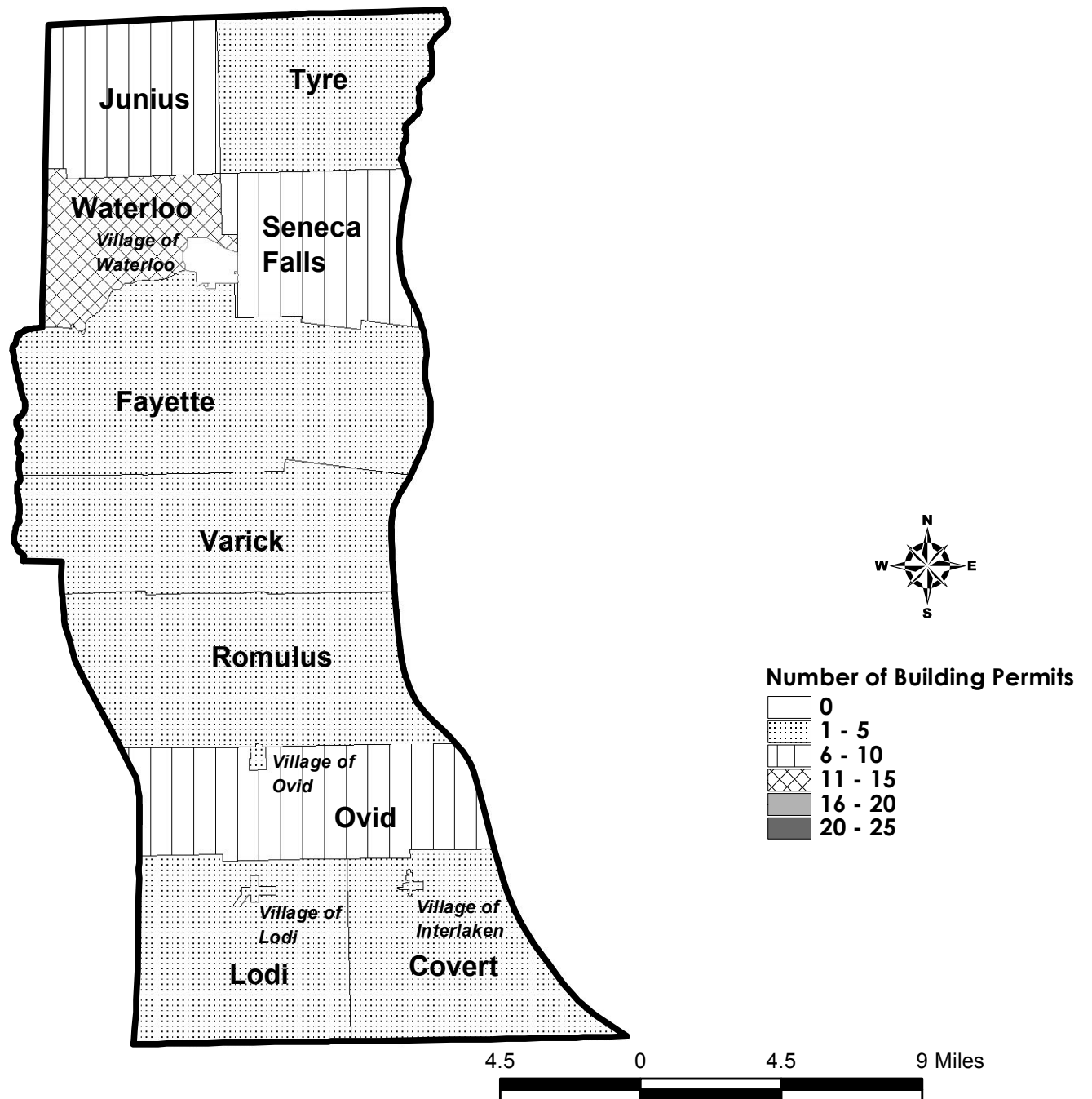

# Number of Residential Unit Permits in Wyoming County (2012)

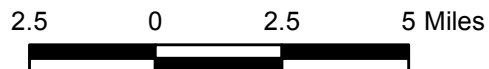

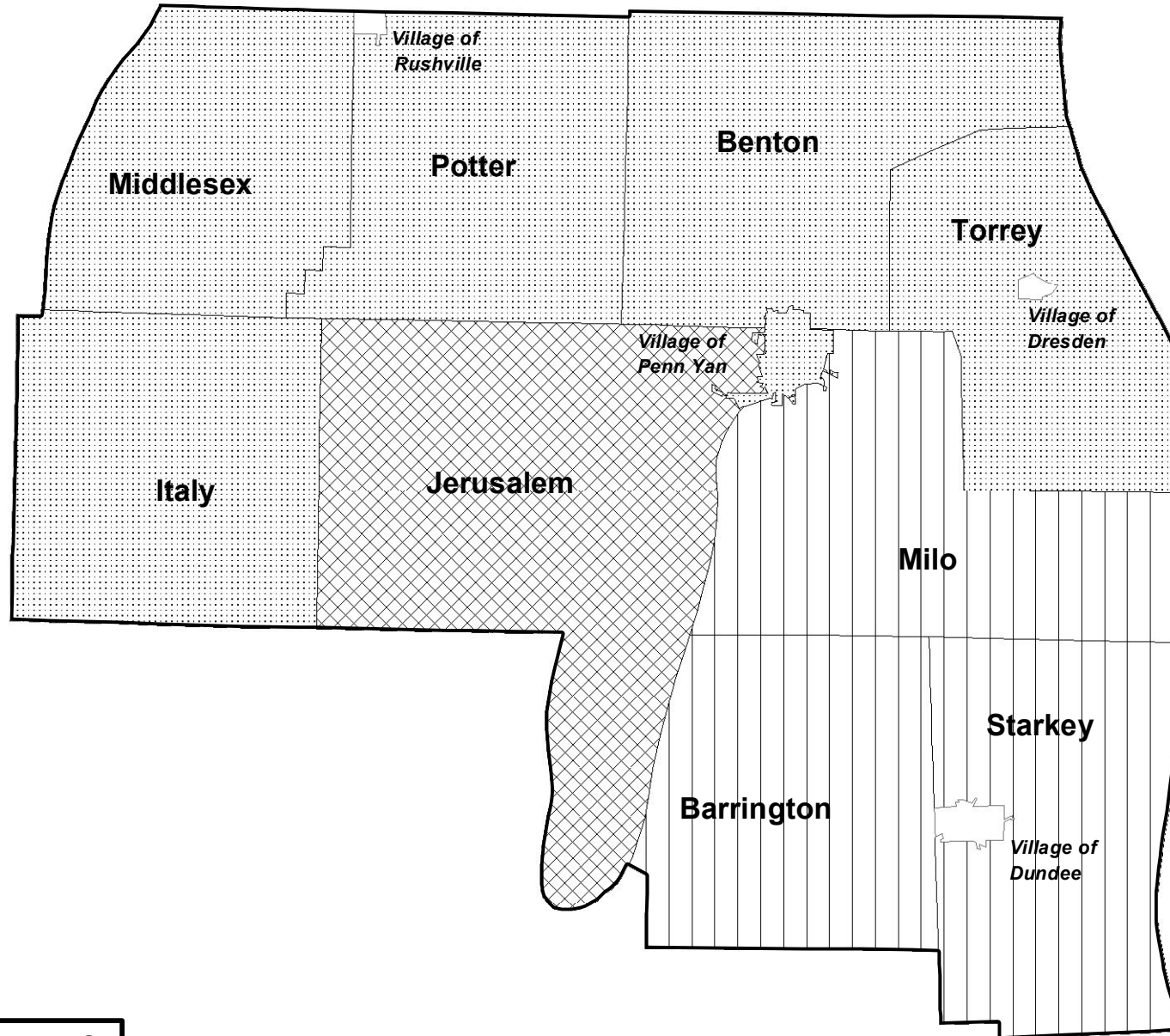

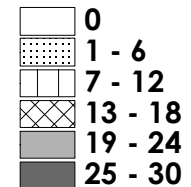




# Number of Residential Unit Permits in Yates County (2012)

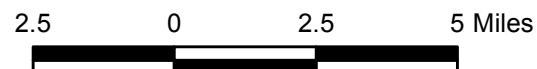

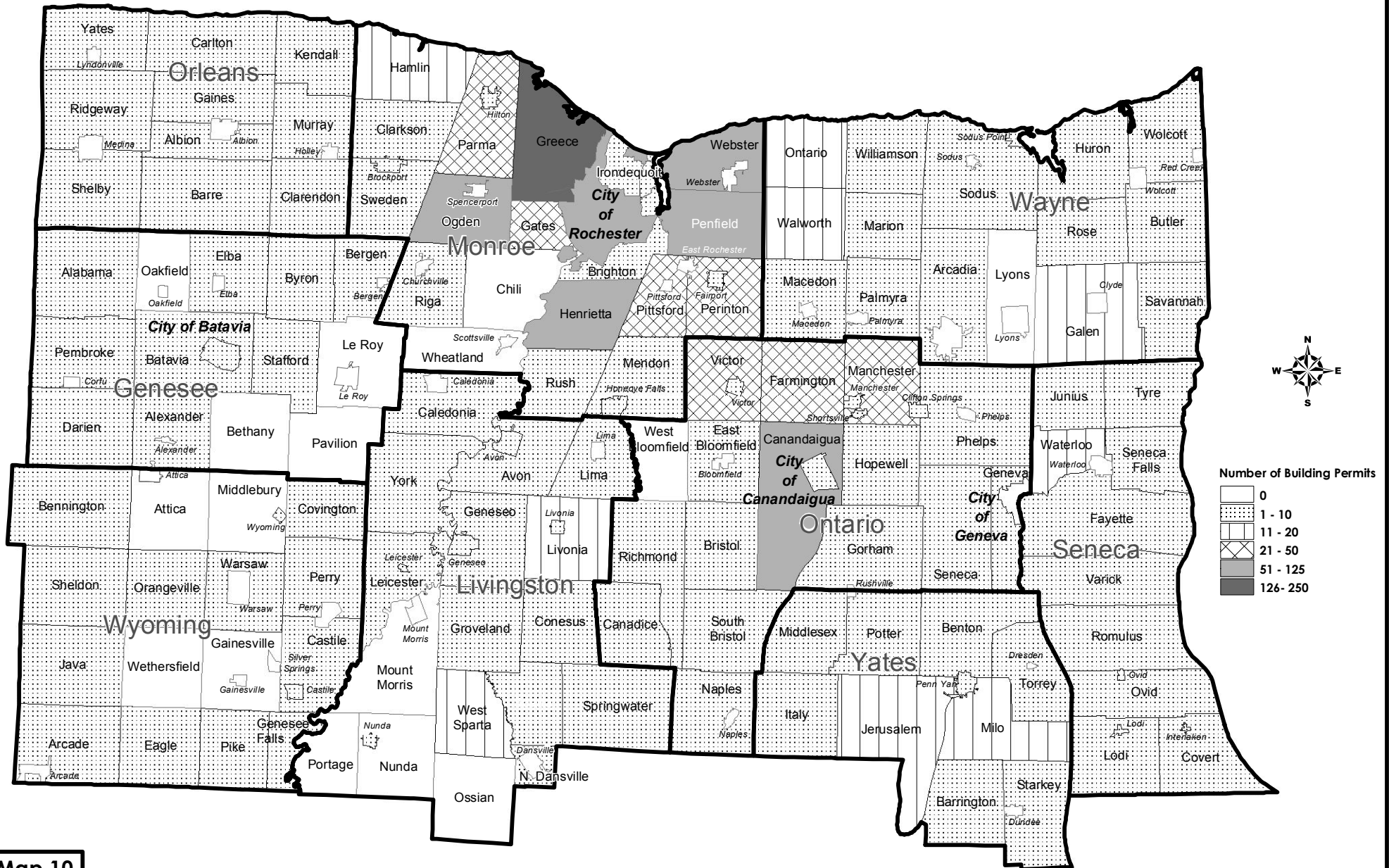

## Number of Residential Unit Permits in the Genesee/Finger Lakes Region (2012)



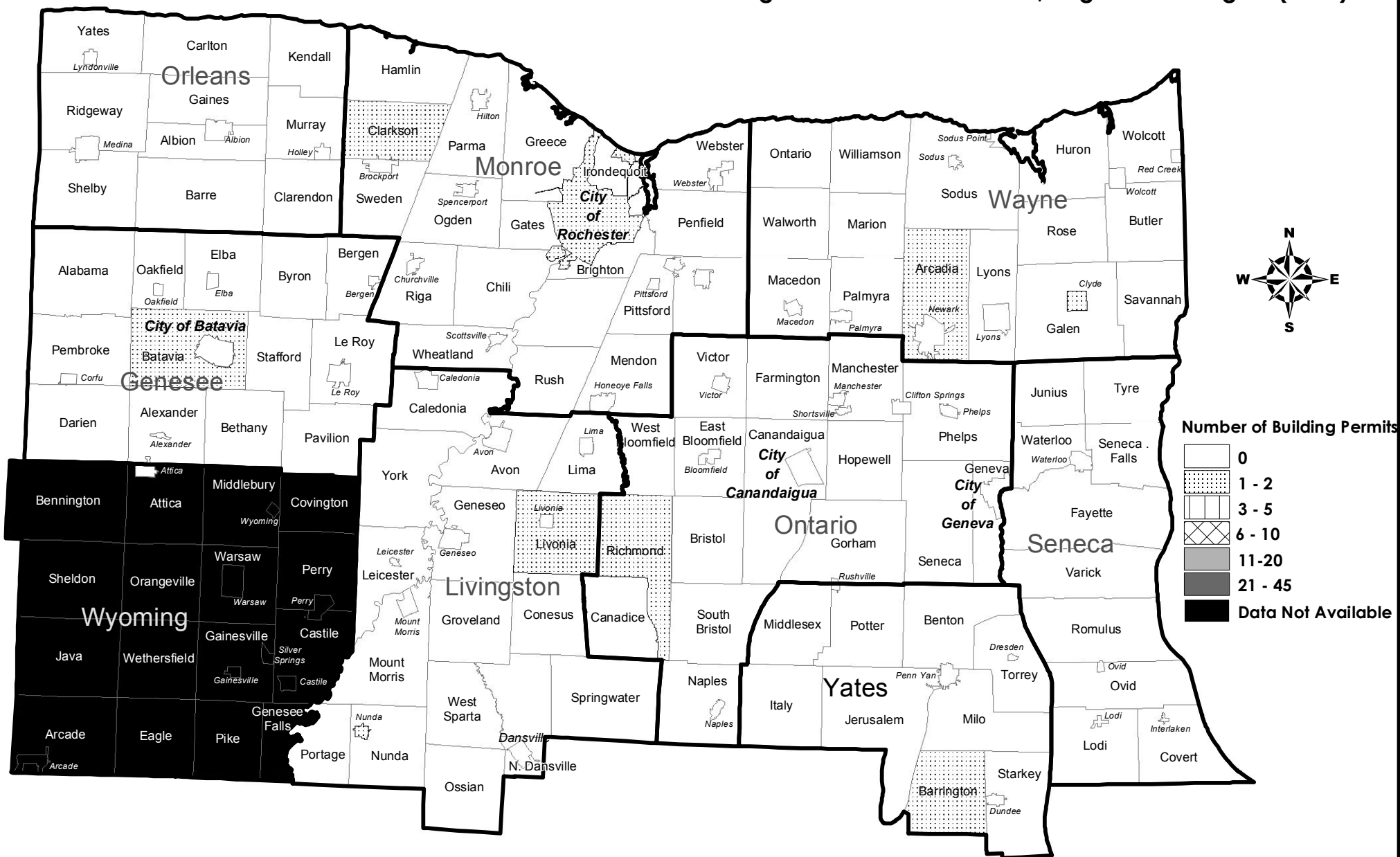

# Number of Industrial Building Permits in the Genesee/Finger Lakes Region (2012)



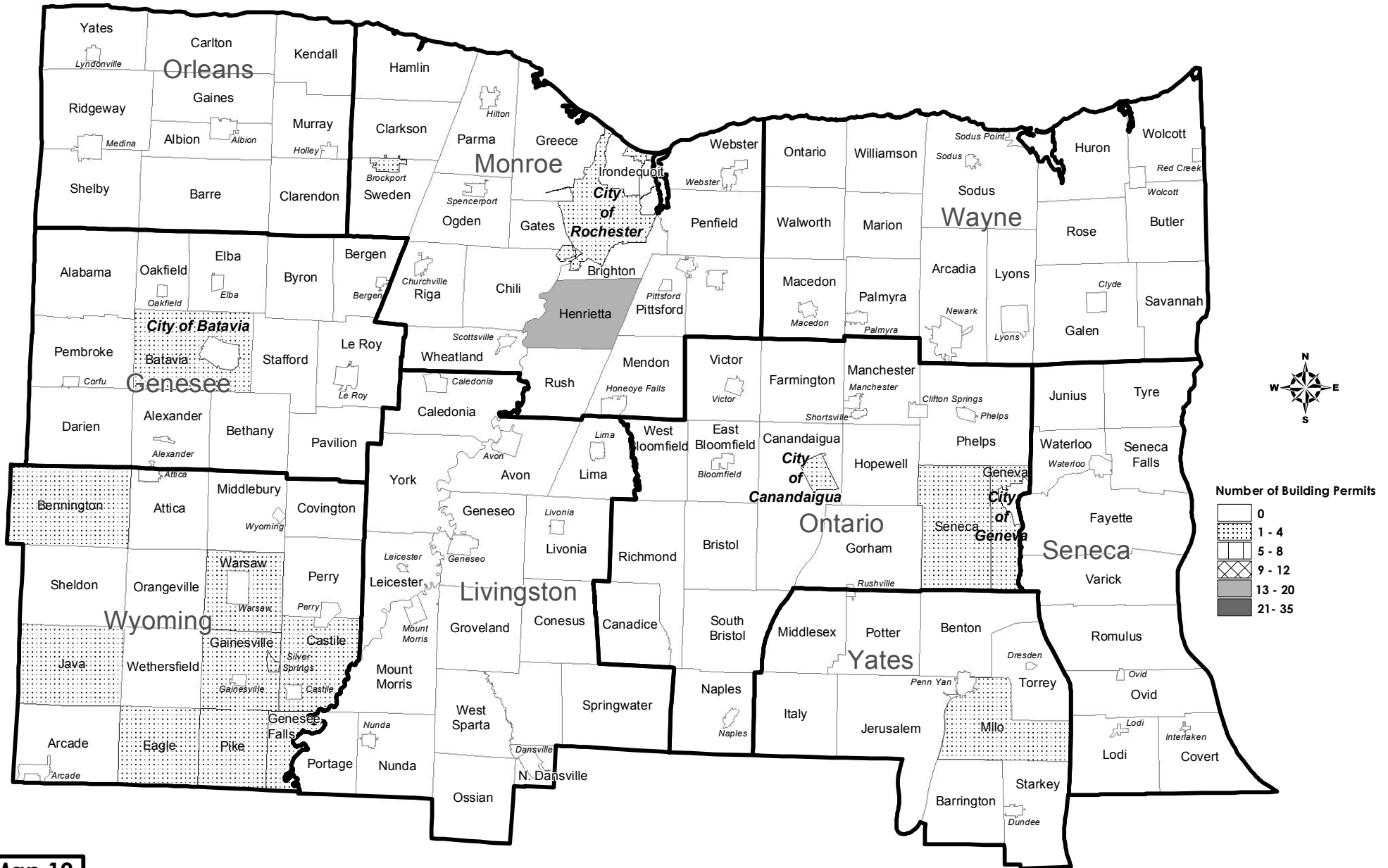

# Number of Commercial Building Permits in the Genesee/Finger Lakes Region (2012)



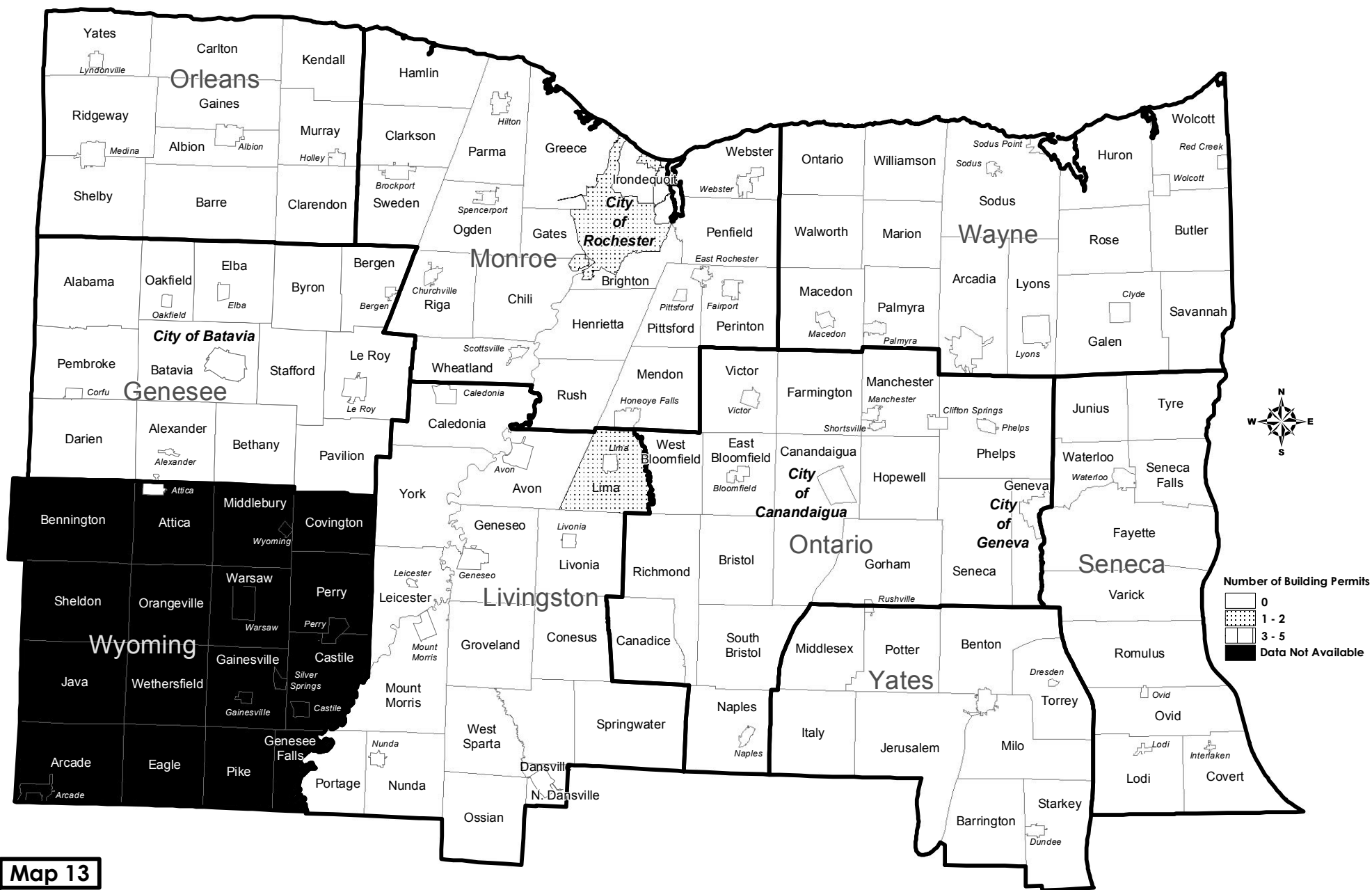

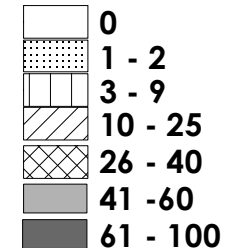




# Number of Residential Building Permits in the TMA Transportation Analysis Zones outside of Monroe County (2012)

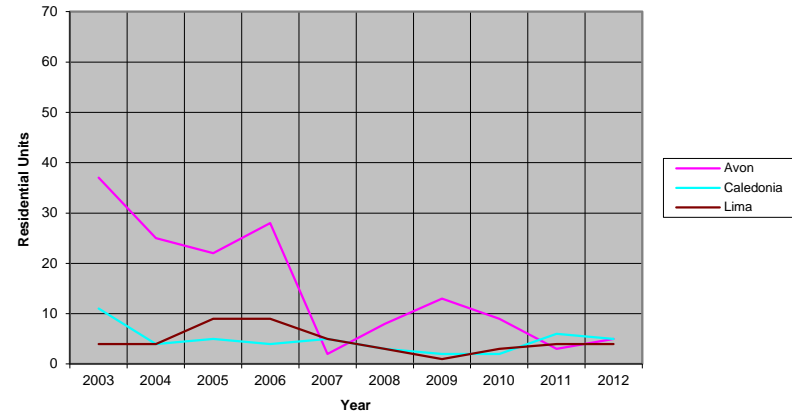

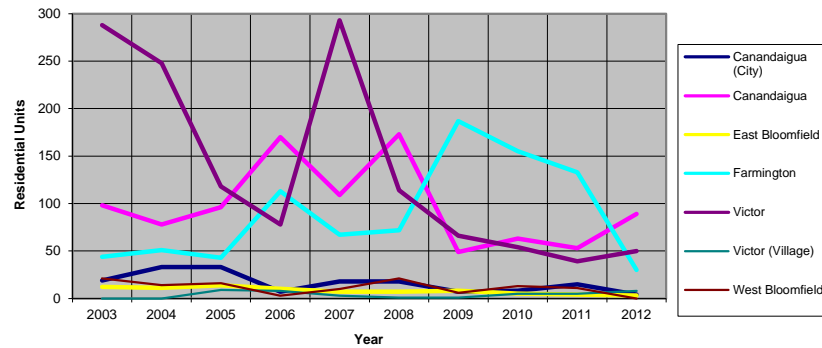
**Towns with the Largest Numbers of Permitted Residential Units in Monroe County (2003 - 2012)**



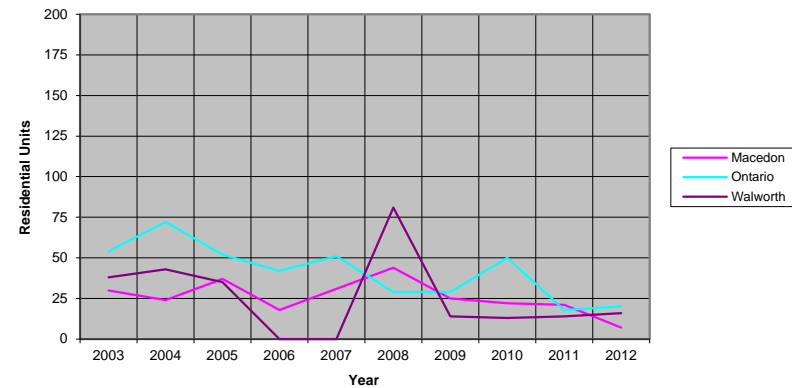
**Number of Permitted Residential Units in Livingston County TMA Towns (2003 - 2012)**

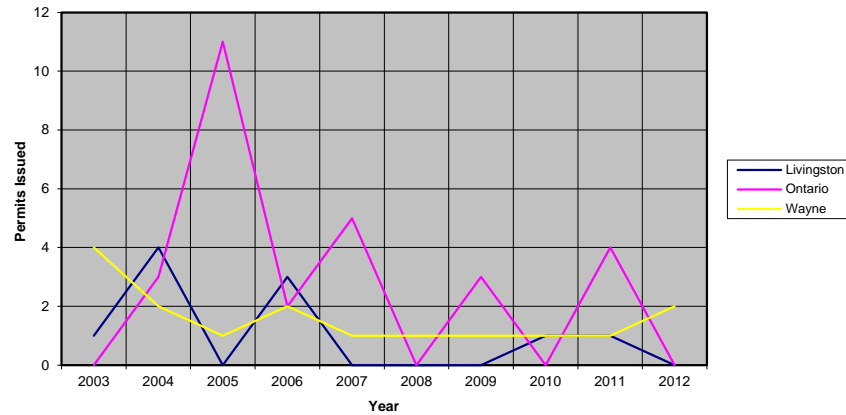

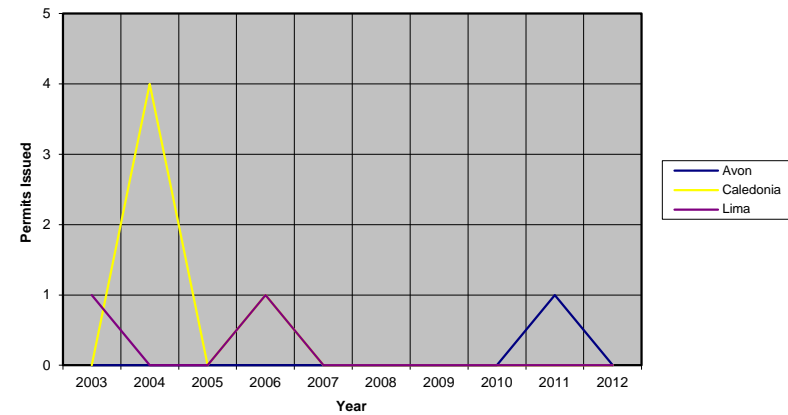

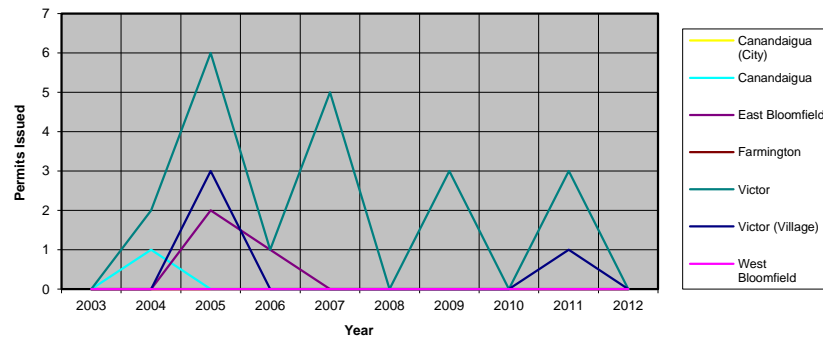
**Permits Issued for Industrial Buildings in TMA (outside Monroe County)  
Towns by County (2003 - 2012)**



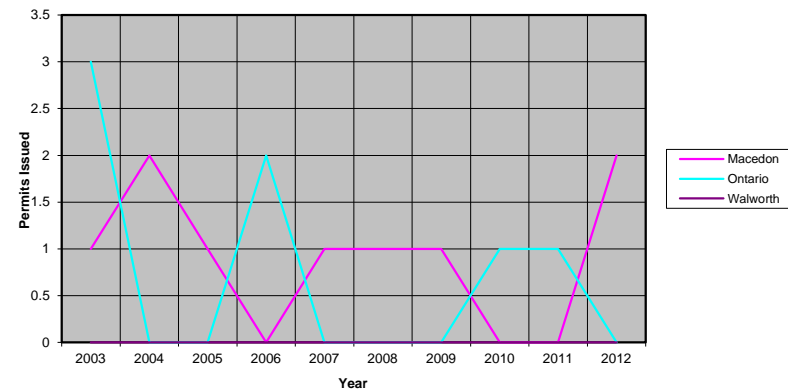
**Permits Issued for Industrial Buildings in Livingston County

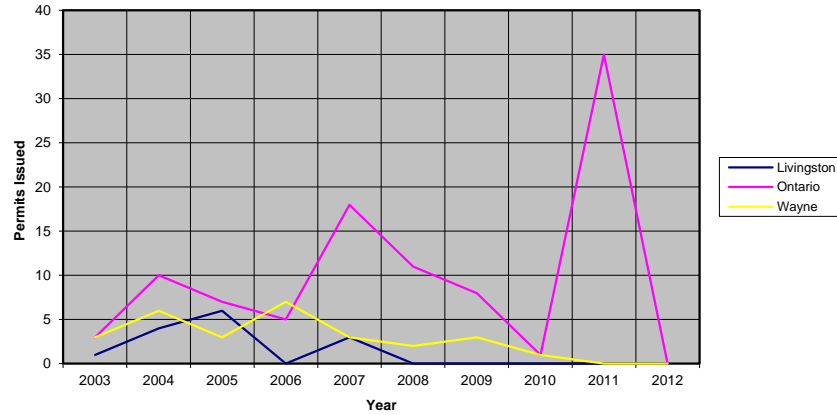

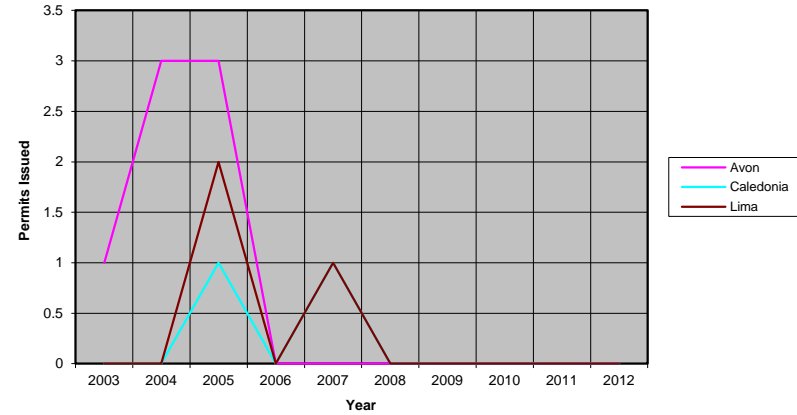

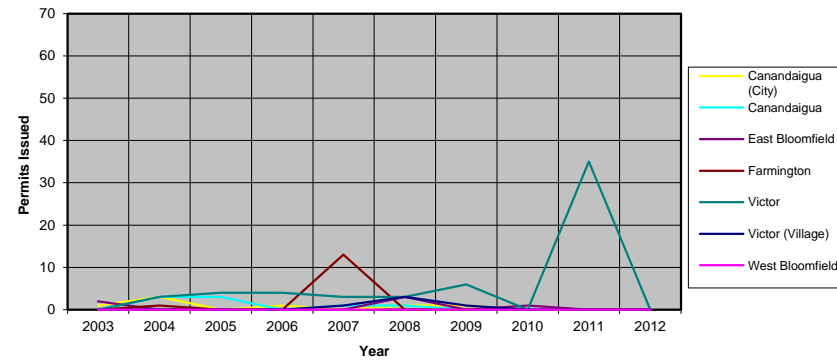
**Permits Issued for Commercial Buildings in TMA (outside Monroe County)
