

Regional Land Use Monitoring Report (2013)

UPWP Task #4220

Executive Summary

Project Purpose:

The Genesee Transportation Council (GTC) provides funding annually for the *Regional Land Use Monitoring Report* under its Unified Planning Work Program. This report provides information on the issuance of building permits in 2013 to identify areas of growth within the Genesee-Finger Lakes Region (G-FL Region) that might require transportation planning and service modifications.

The G-FL Region is comprised of Genesee, Livingston, Monroe, Ontario, Orleans, Seneca, Wayne, Wyoming, and Yates Counties. The report analyzes the number of permits issued, total square footage, and total value for buildings for each municipality within the region as well as the Transportation Management Area (TMA). The TMA covers Monroe County and the municipalities adjacent to Monroe County in Livingston, Ontario, and Wayne Counties, as well as the Town and City of Canandaigua. The analysis looks at the following categories and respective subcategories: “residential” (single-family, two-family, three or four-family, five-or- more family, mobile/manufactured homes); “industrial;” “commercial” (offices/banks, retail/service, service stations, hotels/motels); “community service” (hospitals/health facilities, schools/churches, public works/safety, utilities); and “not elsewhere classified.”

A five-year trend analysis is provided for permitted residential units in all nine counties; industrial, commercial, and community service building permits are analyzed over the three-year period as well. In addition, a time series (or historical trend) analysis is provided for residential, industrial, and commercial development, as well as subdivision approvals in the Transportation Management Area (TMA).

To provide further insight into municipal related information, municipalities were requested to provide the most recent updates related to zoning maps and ordinances as of 2013.

Project Methodology:

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties, these officials were, in most municipalities, the code or zoning enforcement officers. In some cases they were municipal clerks. In Seneca and Wyoming Counties building permit application approval and inspection are the responsibility of the respective county building departments. Those two departments provided the data for their counties. The Monroe County Planning and Development Department’s Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to the Genesee/Finger Lakes Regional Planning Council.

Surveys were distributed in January of 2013 asking for the requested data. The initial survey was followed up with a reminder e-mail along with a telephone reminder to those municipalities that had yet to respond. In some cases, several calls were made to the appropriate parties in an effort to acquire the requested information. Complete data was collected for all 190 municipalities in the nine-county G-FL Region.

Analysis Overview:

The highest number of residential permits in the G-FL Region in 2013 was in the Towns of Greece and Penfield (120) each and followed by Town of Gates (80). The Town of Greece permits issued totaled the largest number of units (148). The City of Rochester issued 16 permits totaling 85 units.

Over the years (2004-2012), the majority of permits for residential units in the TMA have been in Monroe County. In the TMA outside of Monroe County, the Towns of Victor, Canandaigua, and Farmington in Ontario County, and the Towns of Ontario and Walworth in Wayne County issued permits for the largest number of residential units over the same ten year time frame.

The data on permitted building activity and demolition tables are provided in appendices at the end of this report. Overall, the report serves as an information resource for the GTC and others to view and analyze permit activity in the G-FL Region to identify potential growth areas, and anticipate increased transportation needs.

Introduction

The Genesee Transportation Council (GTC) provides funding annually for the *Regional Land Use Monitoring Report* (LUMR) under its Unified Planning Work Program. The purpose of this report is to provide information for building permits by type, size, and value to identify areas of growth within the Genesee-Finger Lakes (G-FL) Region that may, as a result, require increased transportation planning and services.

The *Regional Land Use Monitoring Report* includes residential, industrial, commercial, and community service building permit data for all nine counties in the G-FL Region. The categories (and associated subcategories) for building permit data are as follows:

- Residential (single-family, two-family, three-or-four-family, five-or-more-family, and mobile/manufactured homes)
- Industrial
- Commercial (offices/banks, retail/service, service stations, hotels/motels)
- Community Service (hospitals, schools)
- Not Elsewhere Classified

A five-year trend analysis is provided for permitted residential units in all nine counties and industrial, commercial and community service building permits are analyzed over the five-year period. This time-series analysis is based on this year's and the four previous years' Land Use Monitoring Reports produced by the Genesee/Finger Lakes Regional Planning Council (G/FLRPC).

In addition, a time series (or historical trend) analysis is provided for residential, industrial, and commercial development and subdivision approvals in the Transportation Management Area (TMA).

The TMA includes Monroe County and the adjacent municipalities to the south and east as well as the City and Town of Canandaigua. Table 1 represents the municipalities that, along with Monroe County, comprise the Transportation Management Area.

An analysis of the collected data on the number, value, and size of buildings permitted in 2013 is provided for each county as well as the TMA.

Given that many conclusions can be drawn from the data on permitted building activity tables are provided in appendices at the end of this report for the reader to use for their own needs and analysis.

Methodology

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties these officials were, in most cases, the code or zoning enforcement officers; in some cases the municipal clerks. In Seneca and Wyoming Counties building permit application approval and inspection are the responsibility of the respective county building departments. Those two departments provided the data for their counties. The Monroe County Planning and Development Department's Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to G/FLRPC.

As noted above, each municipality other than Seneca and Wyoming Counties received a survey in January of 2014 asking for the requested data. The initial survey was followed up with a reminder e-mail along with a telephone reminder to those municipalities that had yet to respond. In some cases, several calls or e-mails were made to the appropriate parties in an effort to acquire the requested information. Overall, 100% of the data was collected from all 190 municipalities within the nine-county G-FL Region.

The survey requested information on the number of permits issued, total square footage and total value for buildings in the defined categories and associated subcategories. In addition, the same building permit information for buildings outside of these categories was requested along with a description of the type of building(s) in the "Other" category. This year the LUMR survey included an additional request

from municipalities. All analysis conducted in this report is based on data provided by each LUMR survey contact.

The instructions for completing the survey as printed on the first of the two-page document were as follows:

"Include only permits for the construction of buildings in 2013. Do not include additions, repairs, decks, in-ground pools, etc. or buildings used for storage such as sheds and pole barns. Do not include permits for construction that was completed in 2013 but permitted in a previous calendar year. If the responses below include a town and a village on the same sheet, please denote this by listing them separately on the same line (example: T – 8/V – 12)."

For each of the nine counties, there is a discussion of permitted building activity in 2013 and county maps of residential units permitted in 2013 by municipality (Maps 1 – 9, Map 10 represents Permits for Residential Units for the nine-county G-FL Region). Data of industrial, commercial, and community service building permits issued in 2013 are presented on maps of the nine-county G-FL Region (Maps 11-13).

The information and data provided for permitted building activity in Monroe County and the remaining portion of the TMA follows the same format. Maps 14 through 17 present the number of permitted residential, industrial, commercial, and community service buildings in the TMA in 2013. Map 18 shows the distribution of residential building permits among the Transportation Analysis Zones (TAZ) within the TMA outside of Monroe County.

The residential data for TMA municipalities were used in a time series analysis of the number of residential units permitted by municipality for the years 2004 through 2013. The

number of permits issued for industrial and commercial buildings from 2004 to 2013 in the TMA outside of Monroe County is also presented and discussed in the same manner.

The data gathered on number of building permits issued, square footage, and value in each category/subcategory by municipality in and for the TMA outside Monroe County are presented in Appendices A through H. The Appendices are as follows:

2013 County Building Permit Analysis

Genesee County

Residential Permits:

- Thirty one (31) residential building permits were issued in Genesee County in 2013. The largest number of permits (6) was issued in the Town of Pembroke. Permits issued totaled 9,864 square feet with a combined value of \$1,233,000. The Towns of Batavia and Pavilion issued the second highest total of permits with five each.

Map 1 shows the number of residential unit permits in Genesee County in 2013.

Industrial Permits:

- No industrial building permits were reported in 2013.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2013.

Commercial Permits:

- There were five commercial buildings permits issued in 2013, one each in the Towns of Batavia, Bergen, Darien and Leroy and in the Village of Bergen. Permits issued totaled 27,700 square feet with a combined value of \$1,330,600.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2013.

Community Service Permits:

- No community service building permit was reported in 2013.

Not Elsewhere Classified Permits:

- No permits were reported that would be included as not elsewhere classified for Genesee County municipalities in 2013.

Demolition Permits:

- Twelve (12) residential demolitions were permitted in Genesee County in 2013.

Livingston County

Residential Permits:

- Fifty (50) residential building permits were issued in Livingston County in 2013. The largest amount of permits issued were in the Village of Geneseo (8) and the Towns of Geneseo and West Sparta (6).

Map 2 shows the number of residential unit permits in Livingston County in 2013.

Industrial Permits:

- There were two industrial building permits issued in 2013, one in the Village of Dansville and one in the Town of North Dansville.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2013.

Commercial Permits:

- There was one commercial building permit reported in Livingston County in 2013, in the Village of Dansville.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2013.

Community Service Permits:

- One permit for community service building was reported in the Town of Mount Morris.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2013.

Not Elsewhere Classified Permits:

- Sixteen (16) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

Demolition Permits:

- Nine (9) residential demolitions were permitted in Livingston County in 2013.

Monroe County

Residential Permits:

- Municipalities in Monroe County issued 727 residential building permits for a total of 886 residential units in 2013. The largest number of permits issued was in the Town of Greece and Penfield (120).

The Town of Henrietta issued the next largest number of residential permits (81), followed by the Town of Gates (80), and the Town of Webster (58).

- A total of 52 multi-family unit permits were issued for 211 units in the county.

Map 3 shows the number of residential unit permits in Monroe County in 2013.

Industrial Permits:

- There were five industrial building permits issued in the entire County, three in the City of Rochester and two in the Town of Webster.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2013.

Commercial Permits:

- In the category of commercial buildings, 59 permits were issued in Monroe County. The Town of Henrietta issued the highest with 35 permits.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2013.

Community Service Permits:

- Two (2) permits were issued for community service buildings in Monroe County, with a total value of \$31,295,00.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2013.

Not Elsewhere Classified Permits:

- Eighteen (18) permits were issued that did not correspond to the above-described categories were included as not elsewhere classified.

Demolition Permits:

- Of all the counties in the G-FL Region, the most demolitions in 2013 were permitted in Monroe County. There were 84 residential demolitions permits issued.

Ontario County

Residential Permits:

- Ontario County municipalities permitted 275 residential structures in 2013, for a total of 339 units. The Town of Victor issued the most permits with 85, totaling 92 units. The Town of Farmington issued the second most permits with 70.

Industrial Permits:

- There were 37 industrial building permit issued in Ontario County in 2013. The Town of Victor issued the most with 31.

Commercial Permits:

- Fifty five (55) commercial building permits were issued in Ontario County. The Town of Victor issued the most with 44.

- There were no permits reported for community service buildings in Ontario County in 2013.

- Thirty 30 residential building permits were issued in Orleans County in 2013. The Towns of Carlton and Kendall issued the largest number of permits in the County with five each.

- No industrial permits were reported for Orleans County in 2013.

Seneca County

Residential Permits:

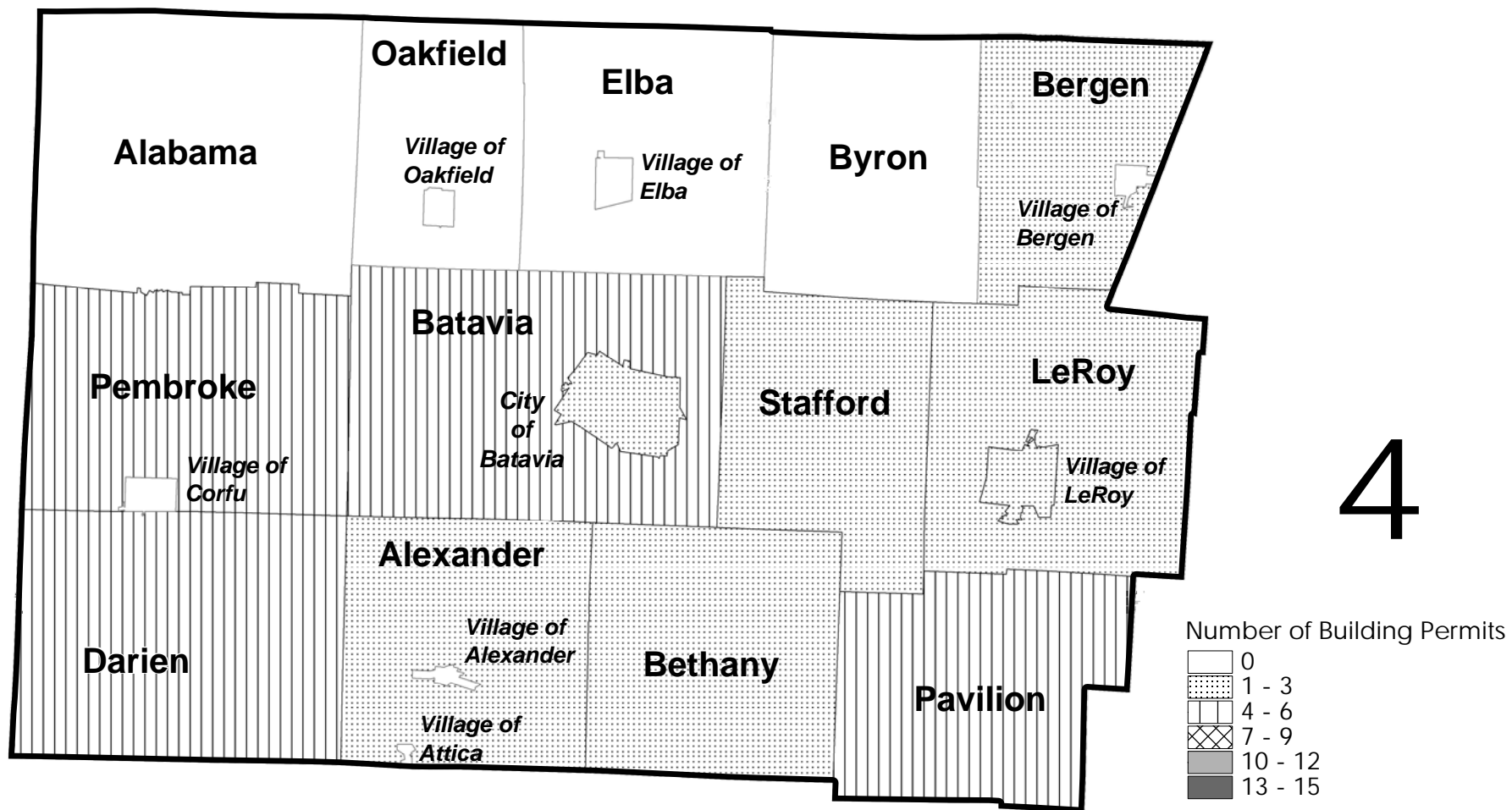

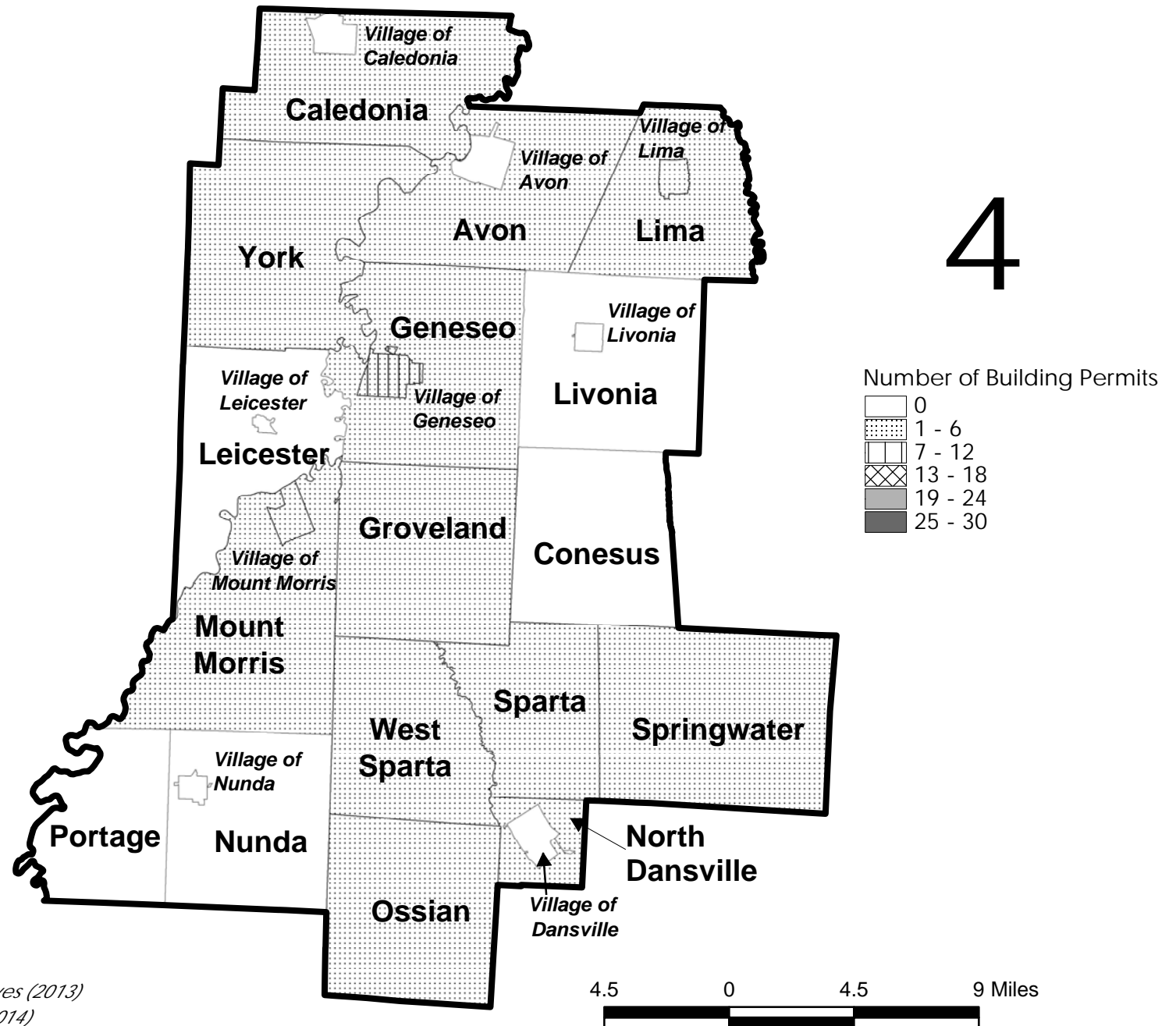

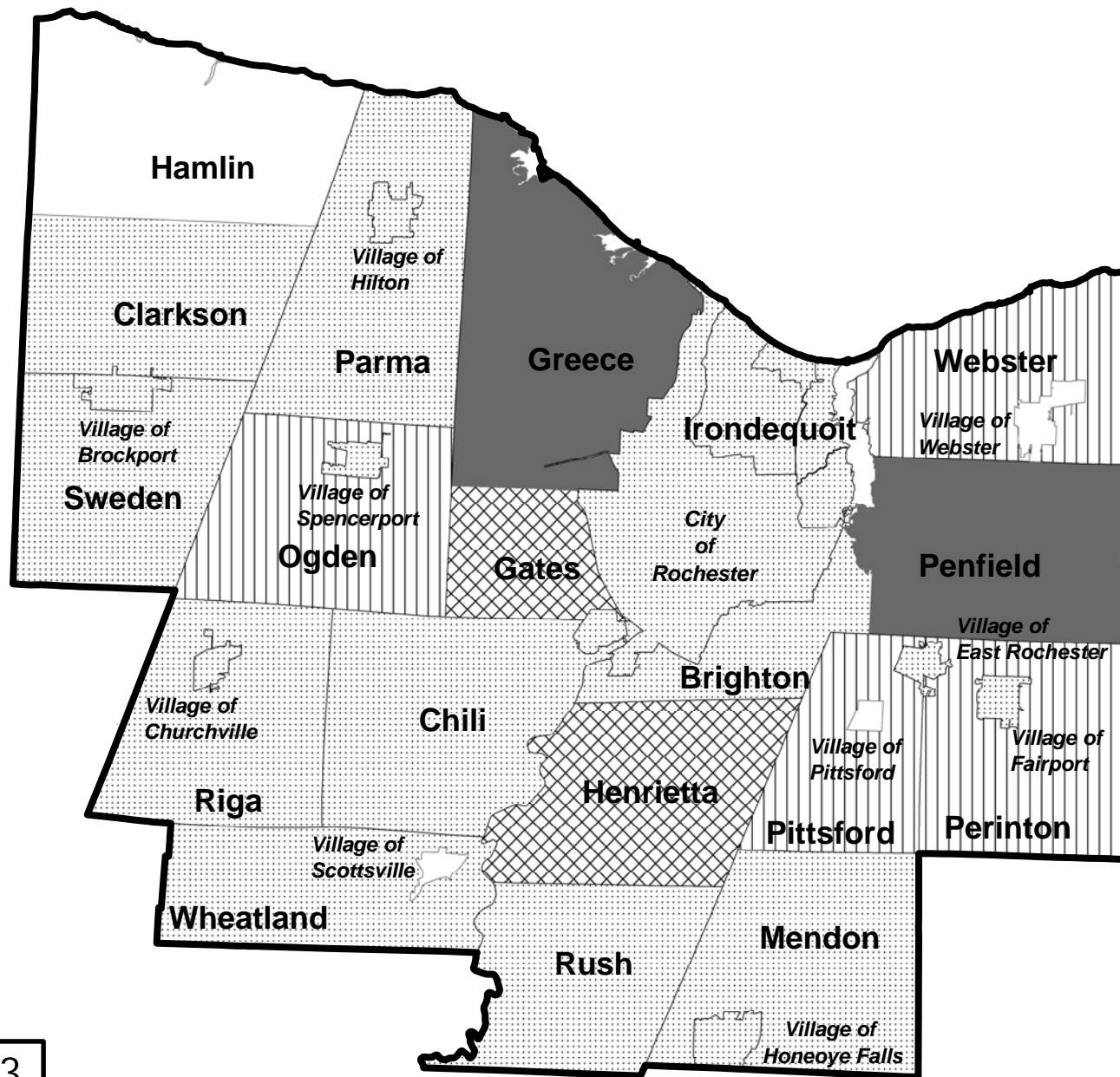


Number of Residential Unit Permits in Livingston County (2013)



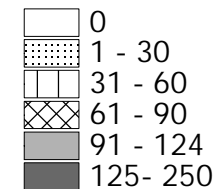

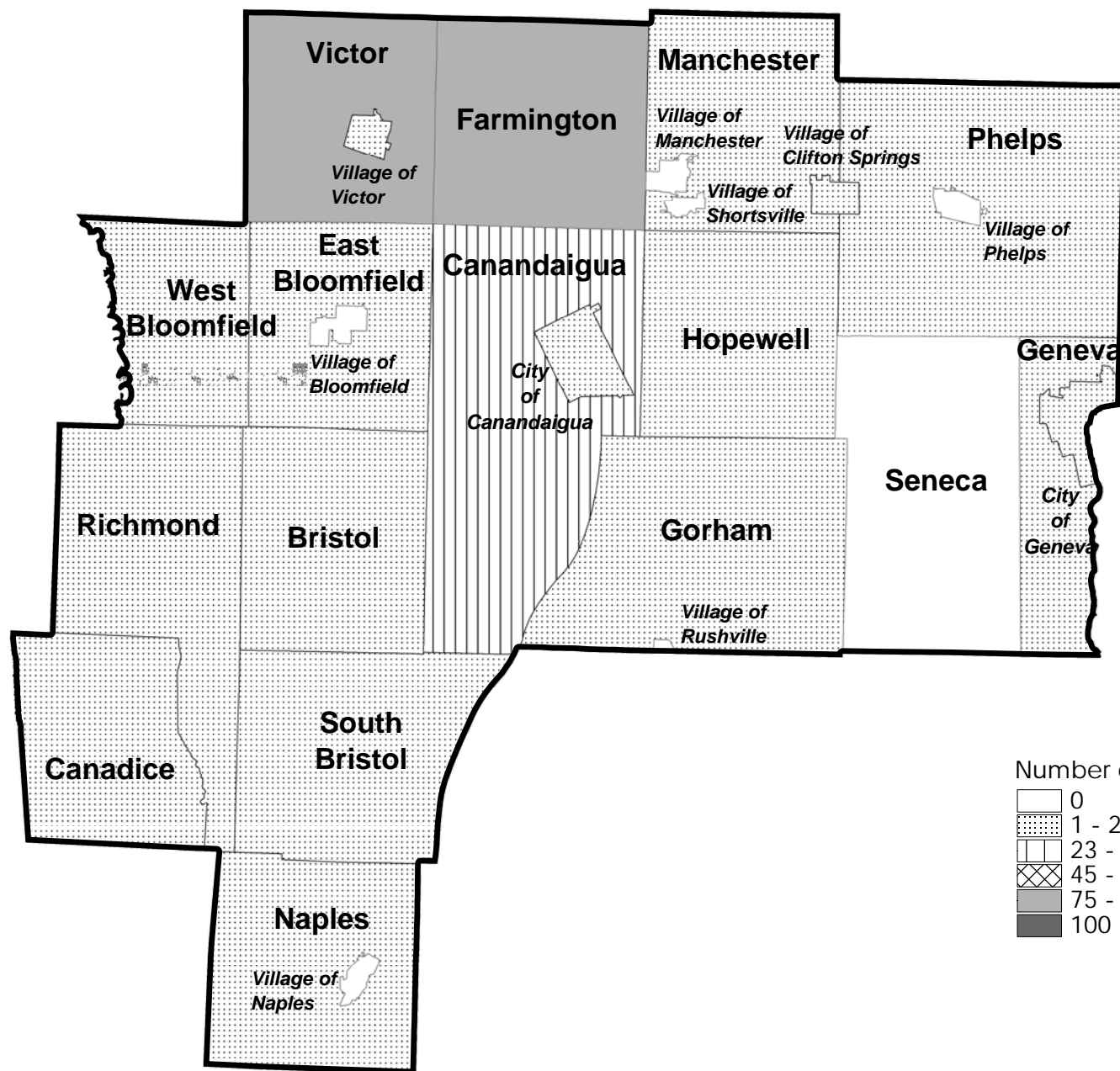

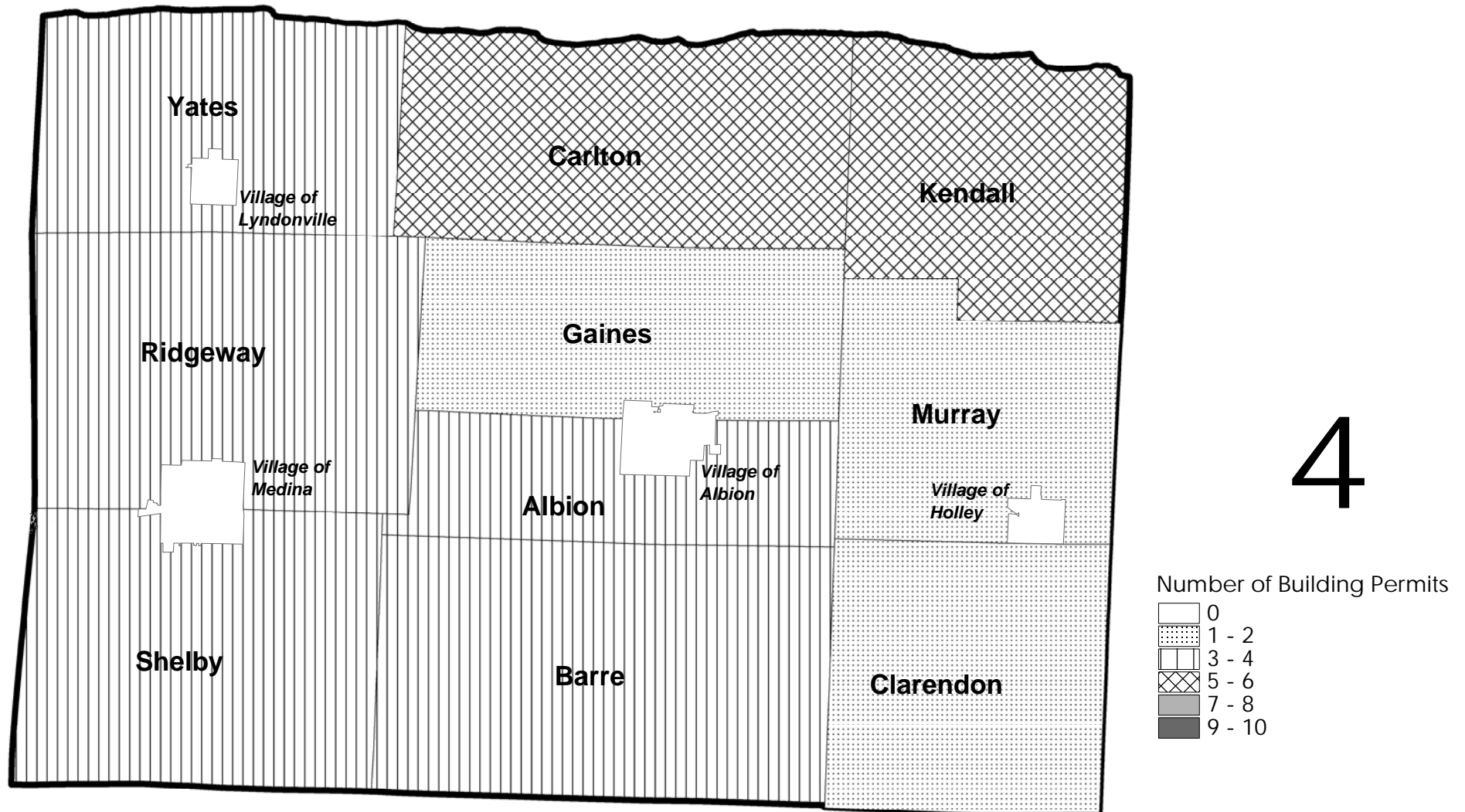

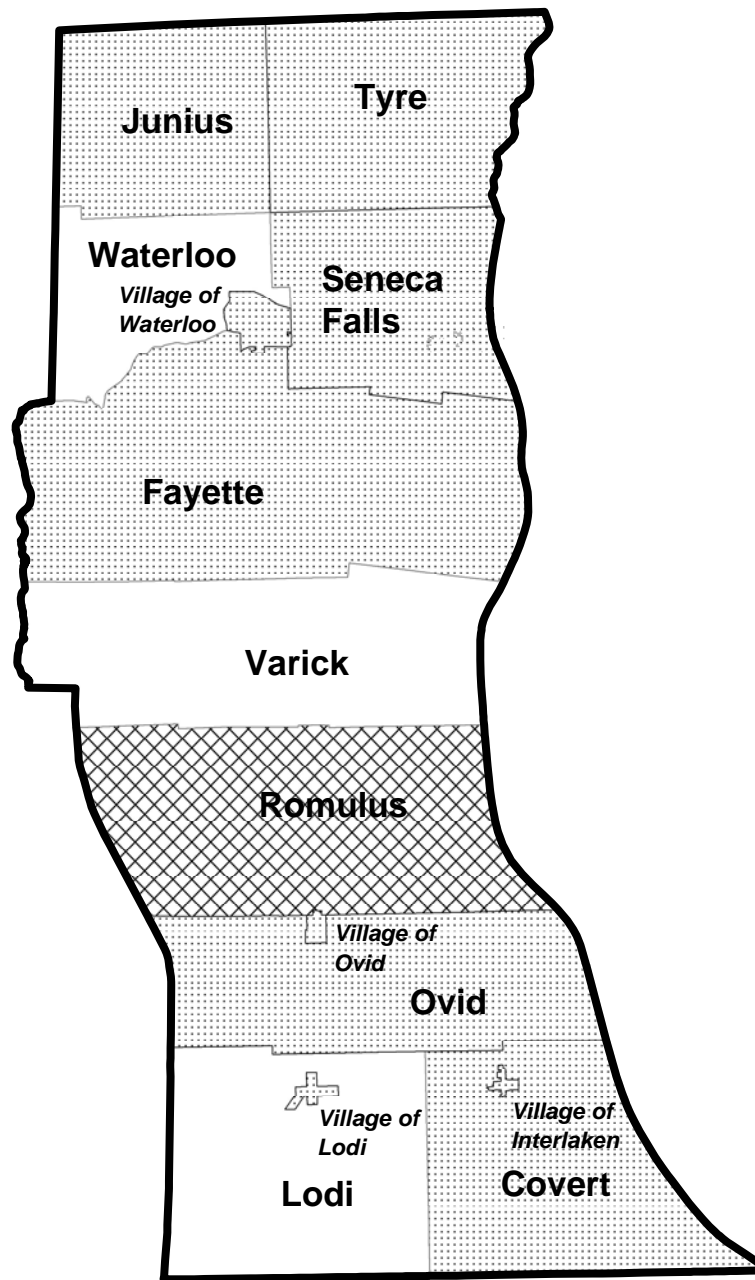

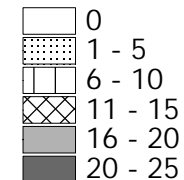


Number of Residential Unit Permits in Seneca County (2013)

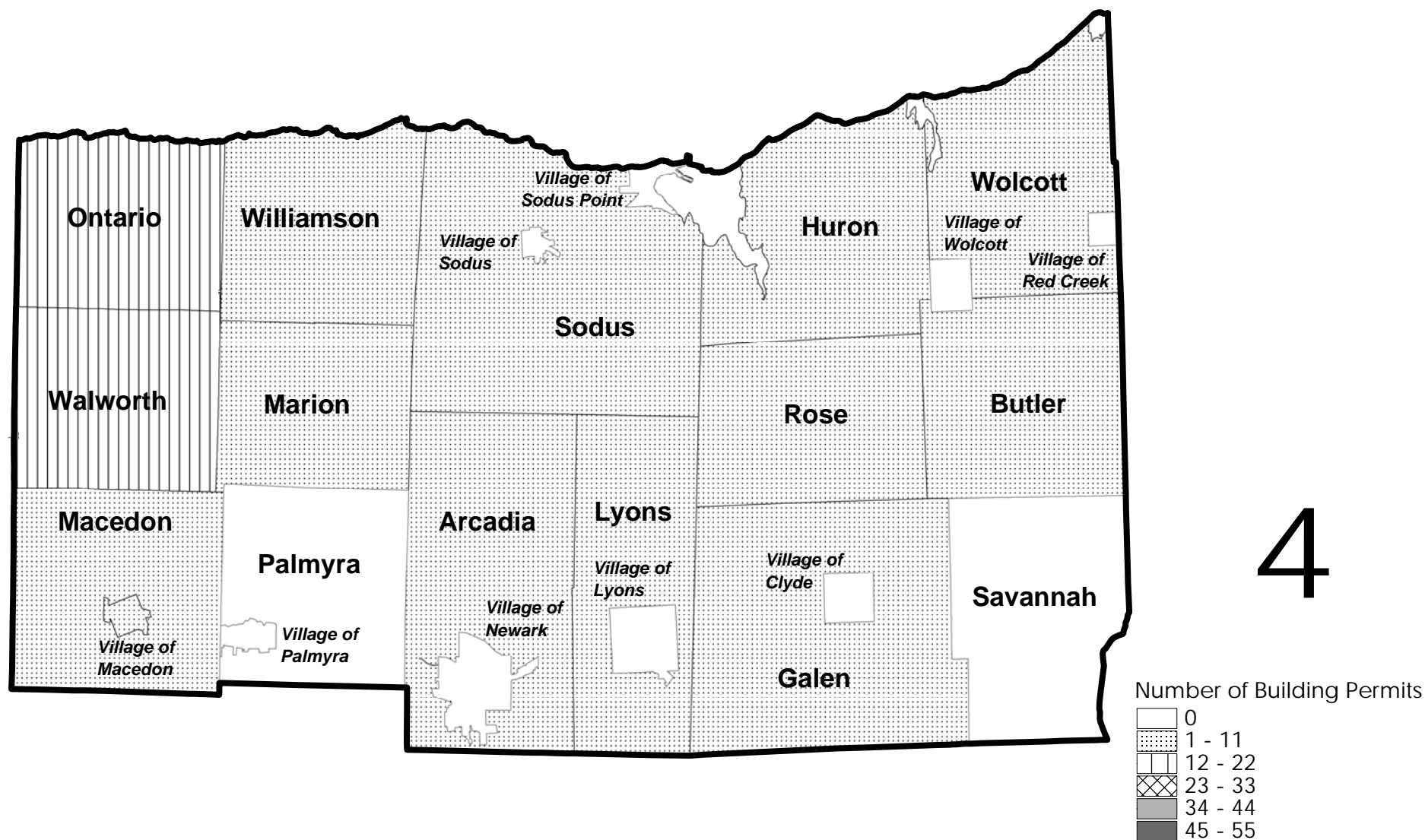

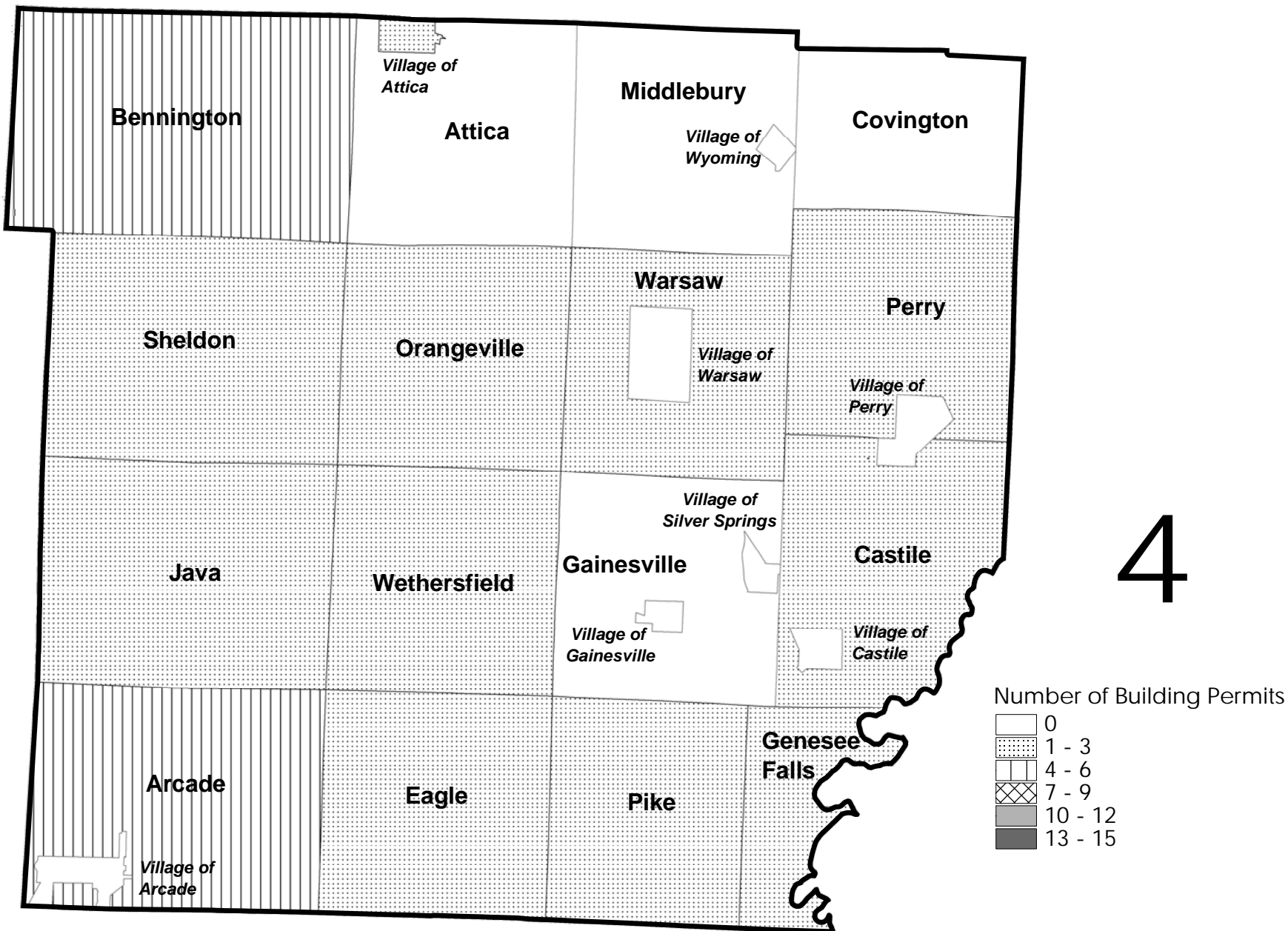

Number of Residential Unit Permits in Wyoming County (2013)

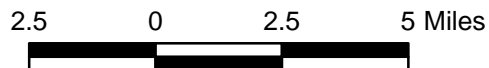

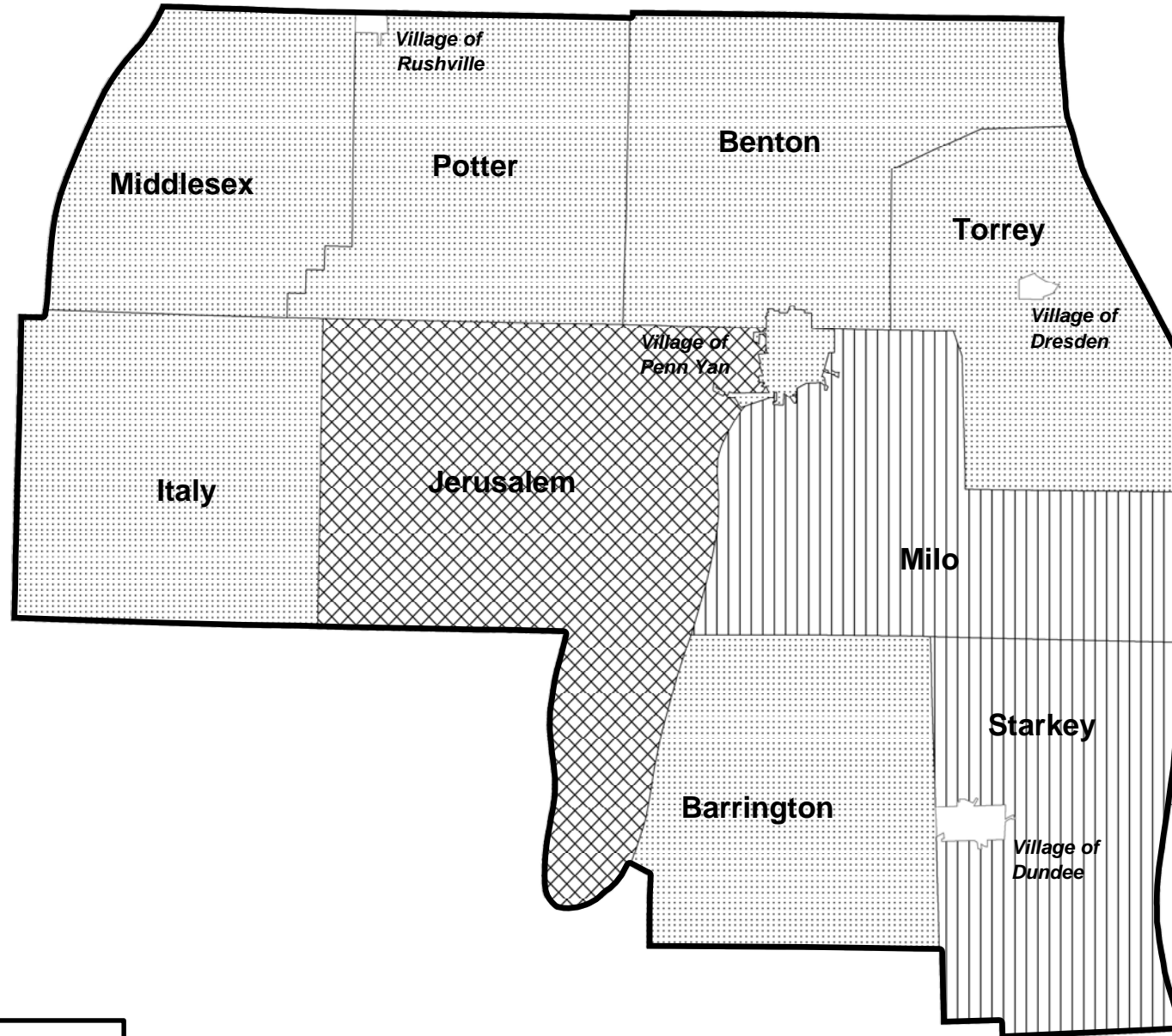

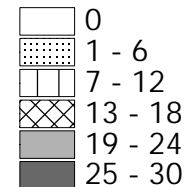


Number of Residential Unit Permits in Yates County (2013)

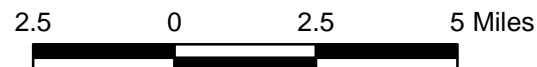

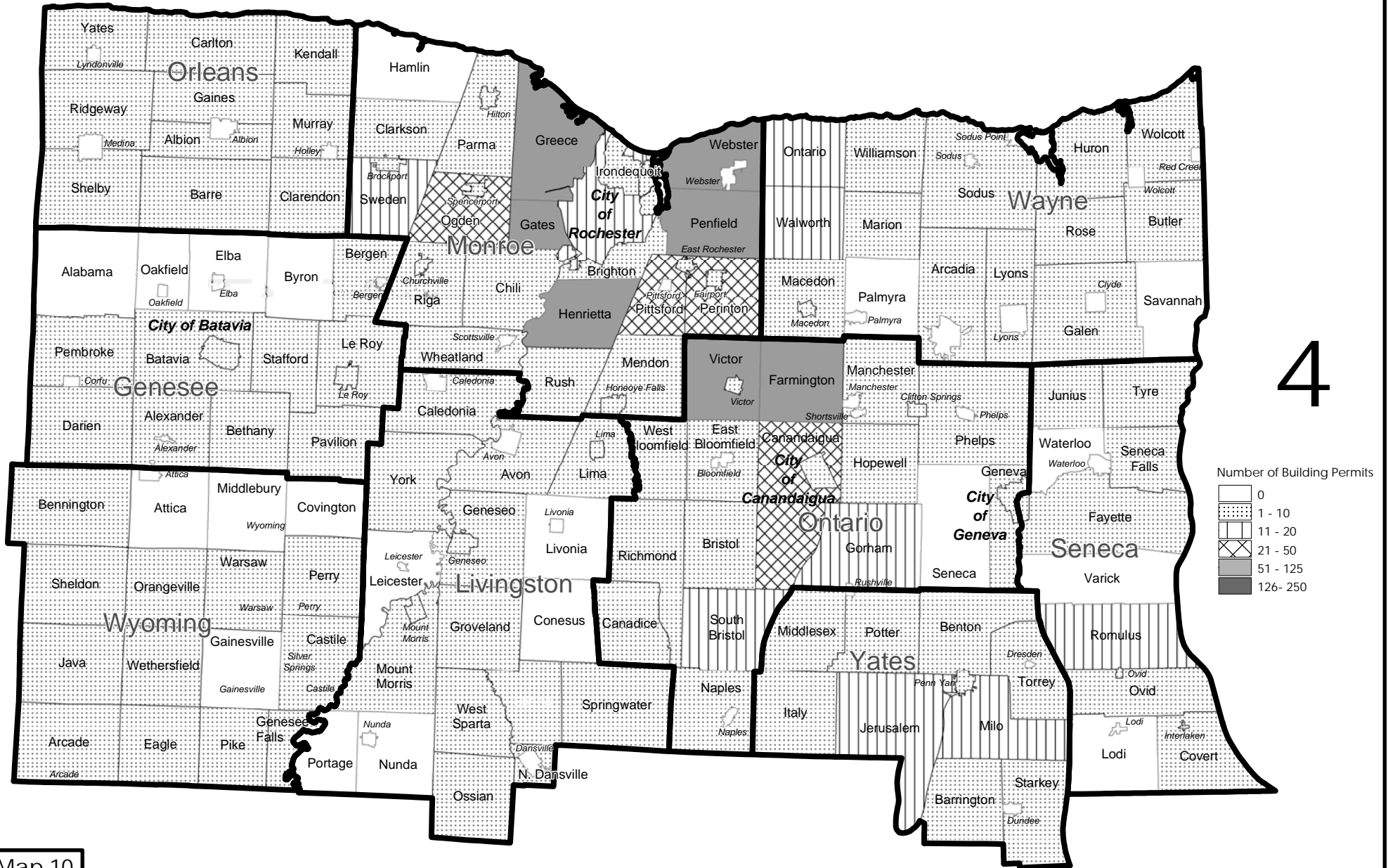

Number of Residential Unit Permits in the Genesee/Finger Lakes Region (2013)



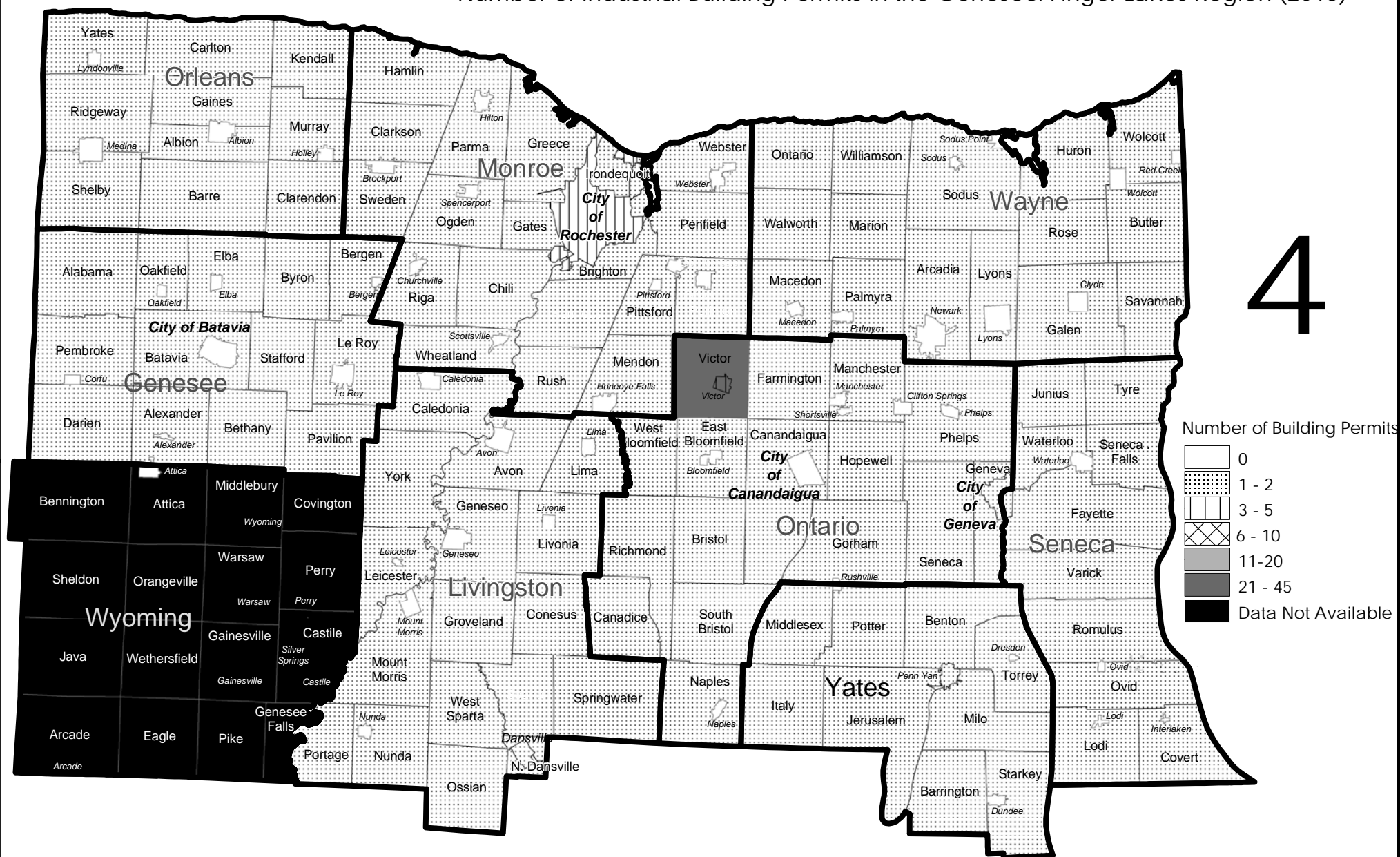

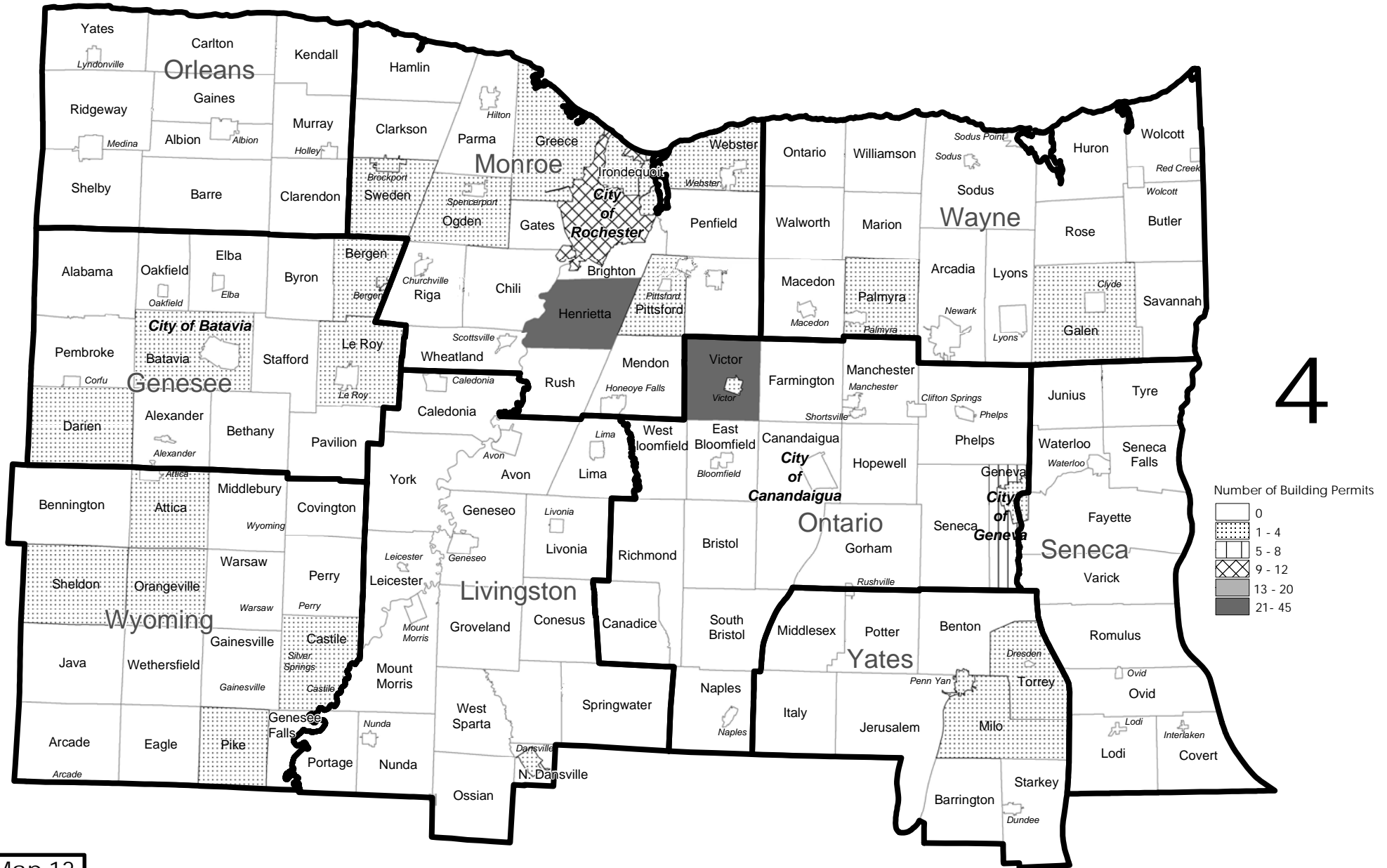

Number of Commercial Building Permits in the Genesee/Finger Lakes Region (2013)



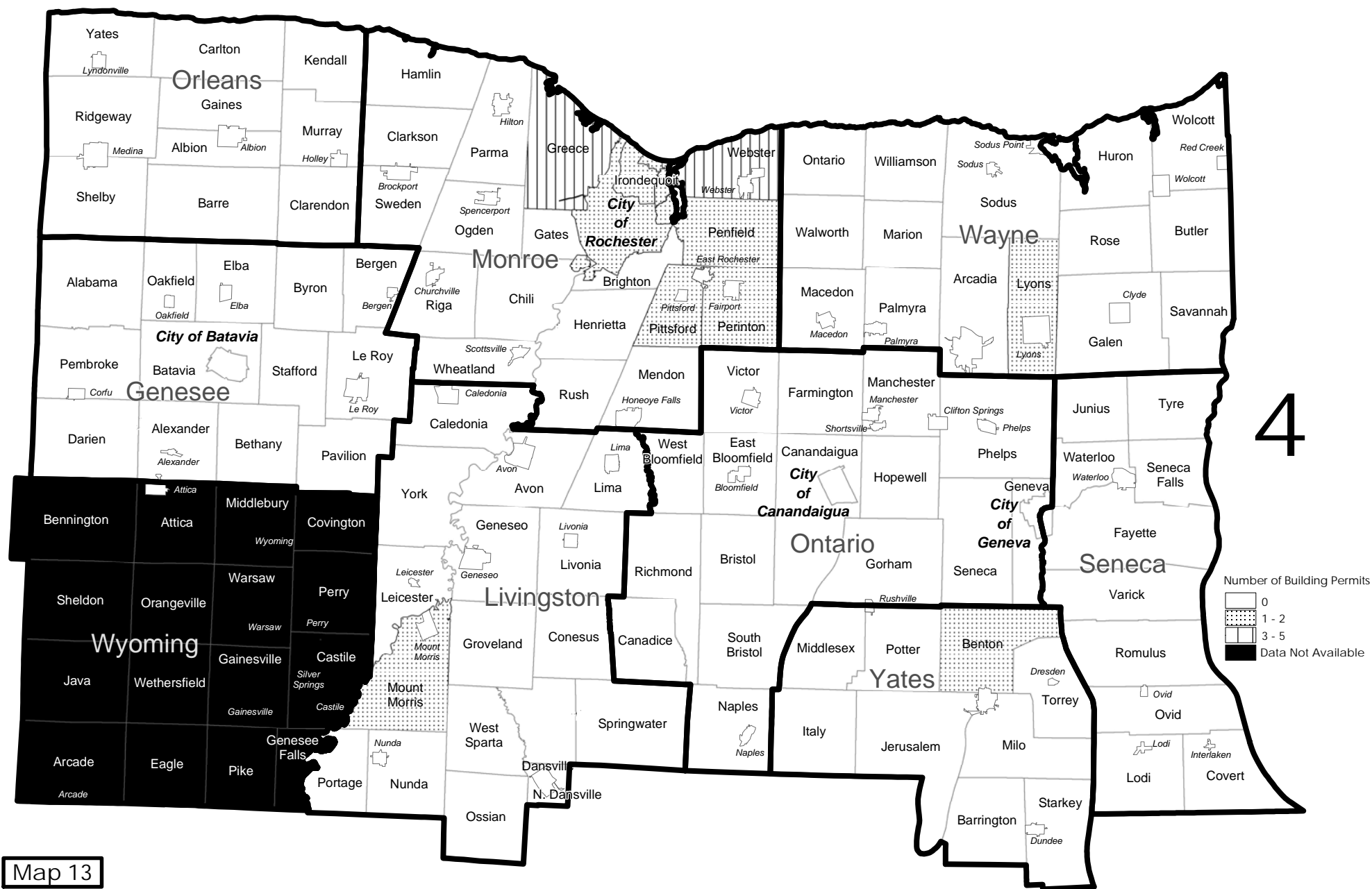

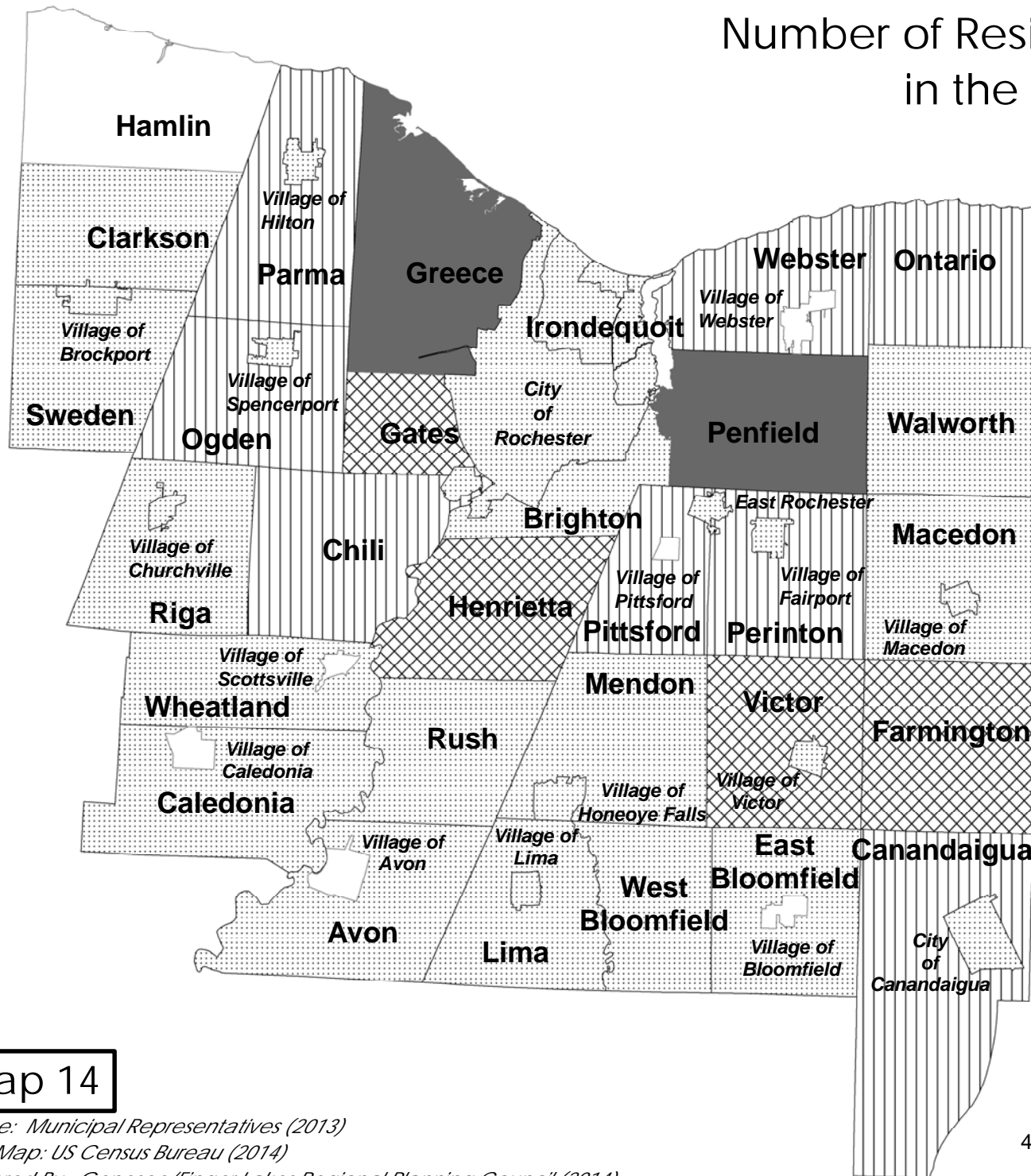

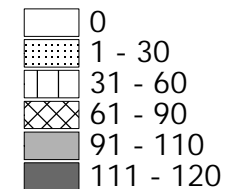

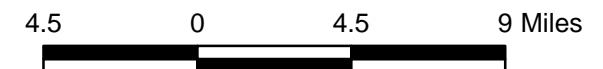

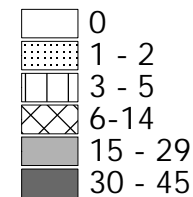


Number of Industrial Building Permits in the TMA (2013)

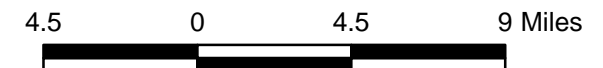

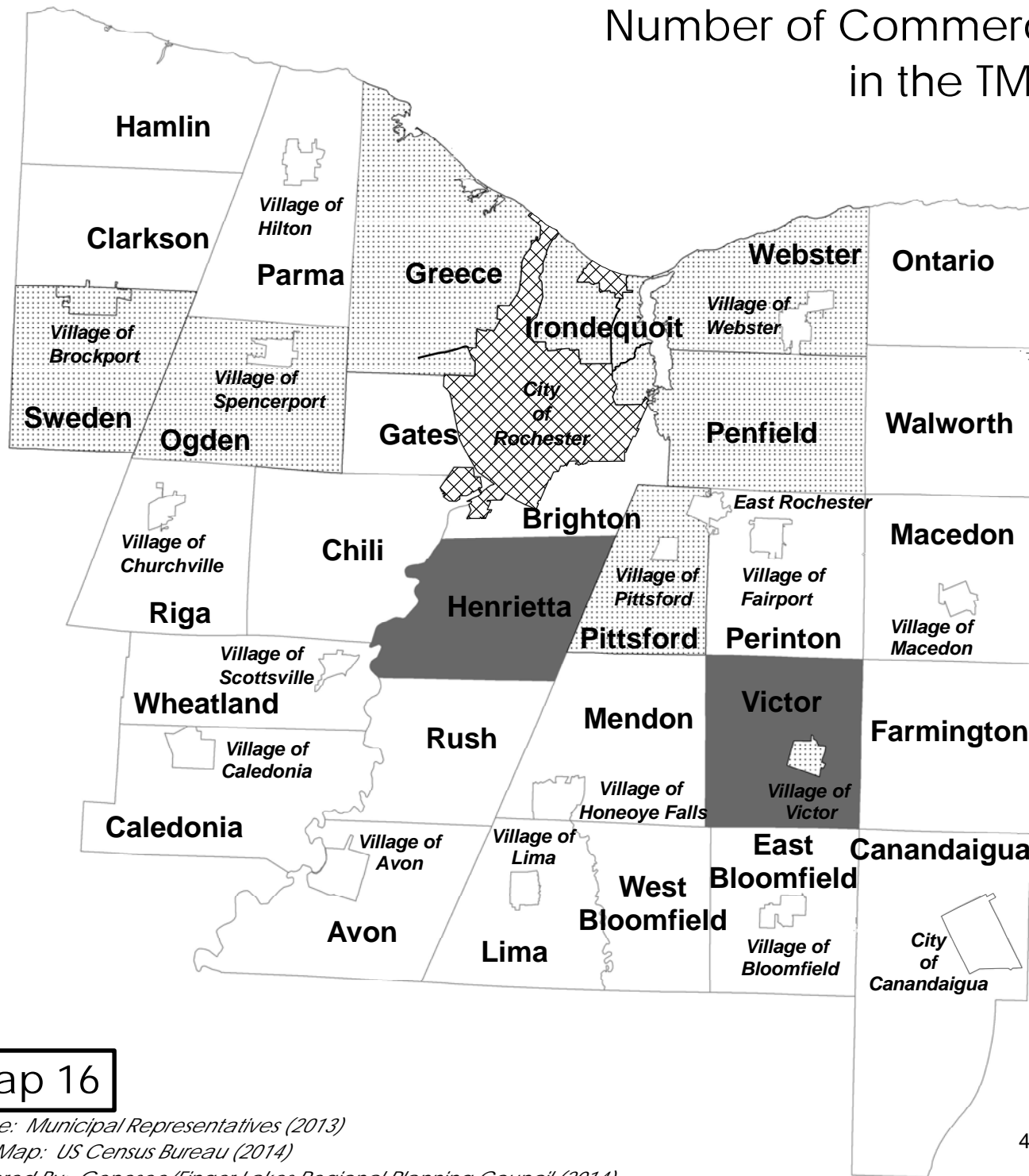

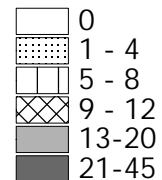


Number of Commercial Building Permits in the TMA (2013)

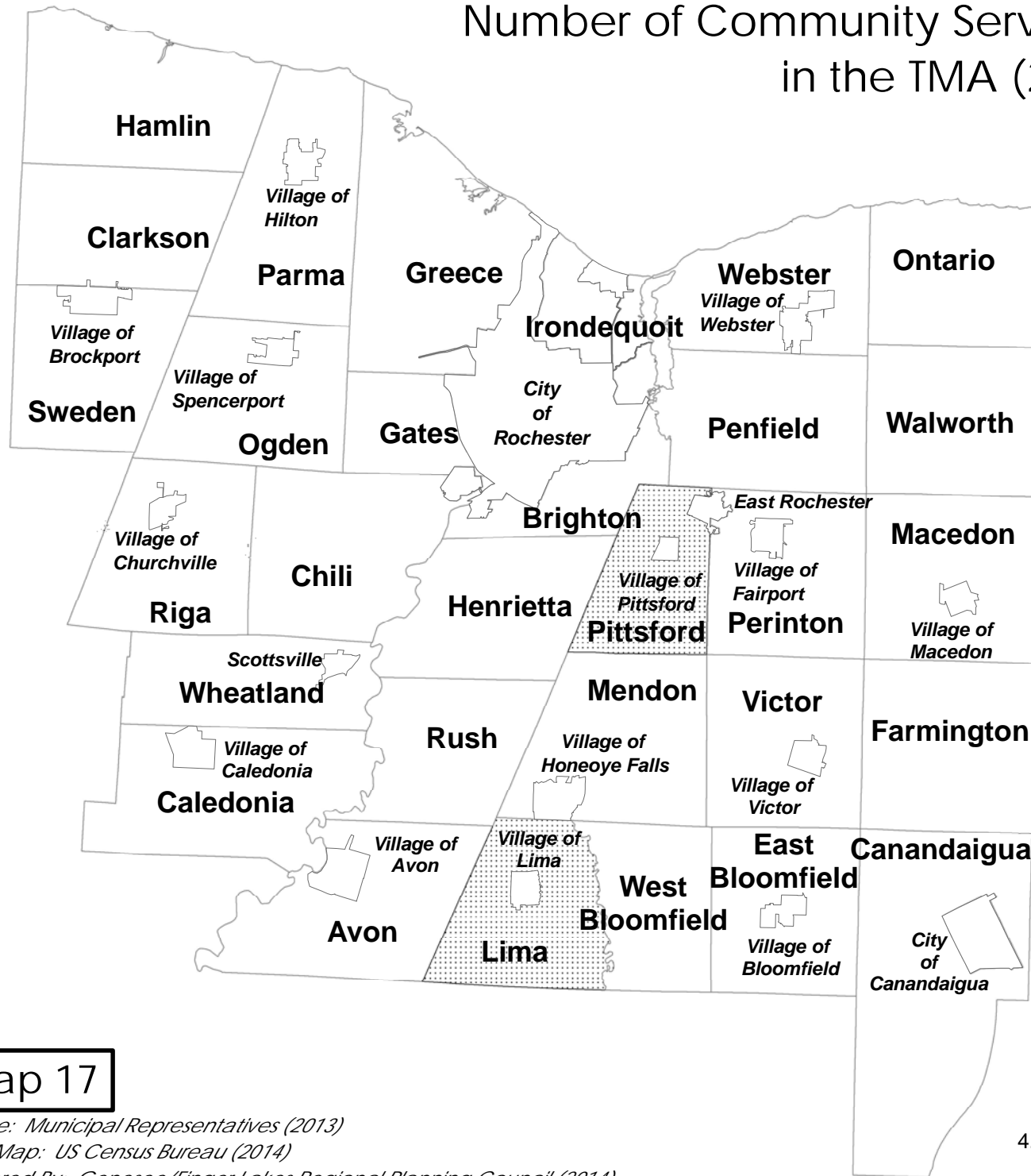

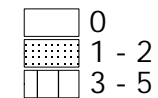


Number of Community Service Building Permits in the TMA (2013)

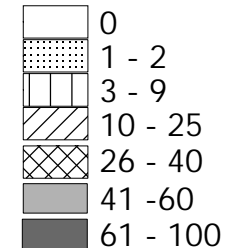


Number of Residential Building Permits in the TMA Transportation Analysis Zones outside of Monroe County (2013)

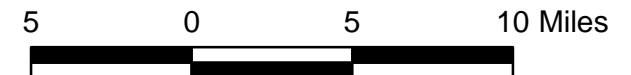

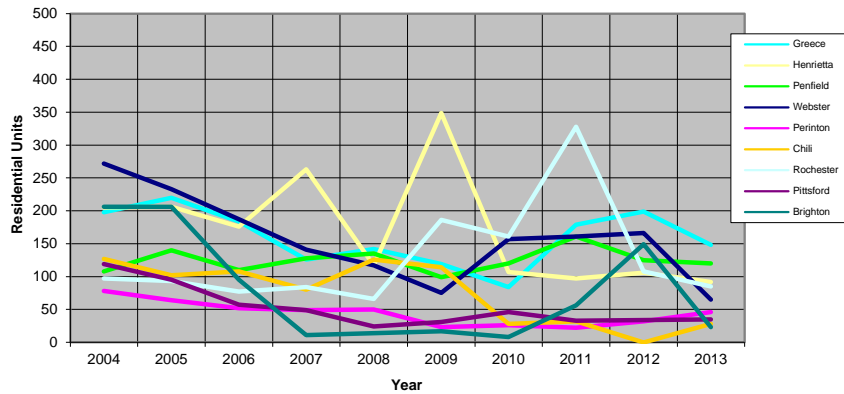

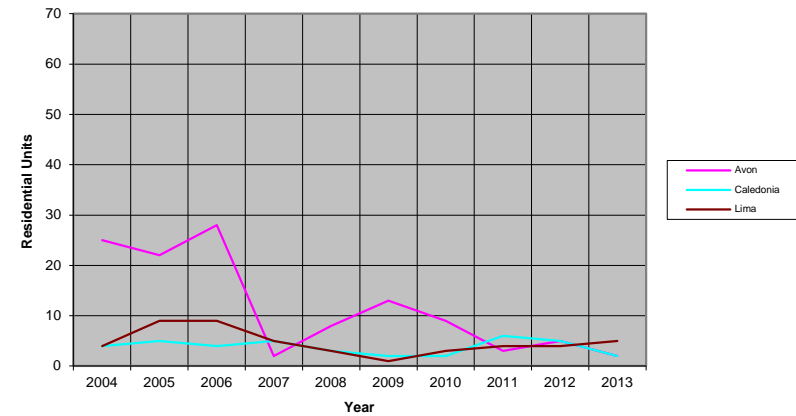

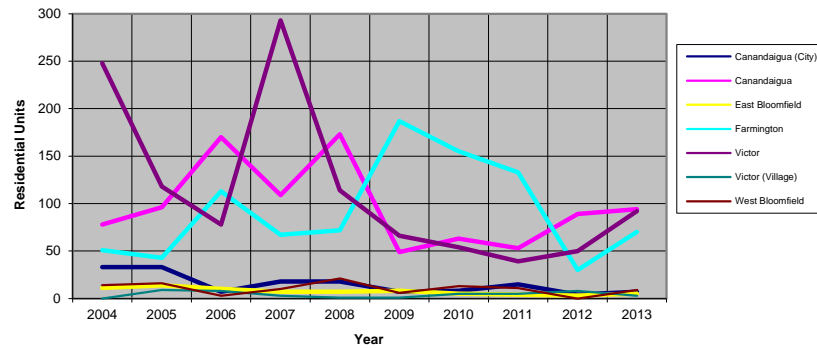
Towns with the Largest Numbers of Permitted Residential Units in Monroe County (2004 - 2013)



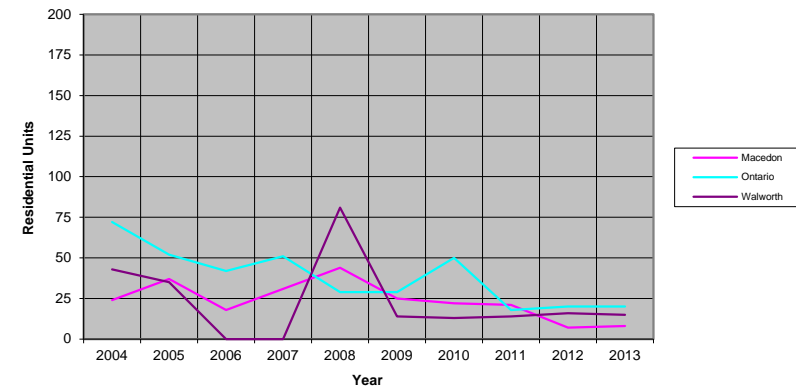
Number of Permitted Residential Units in Livingston County TMA Towns (2004 - 2013)

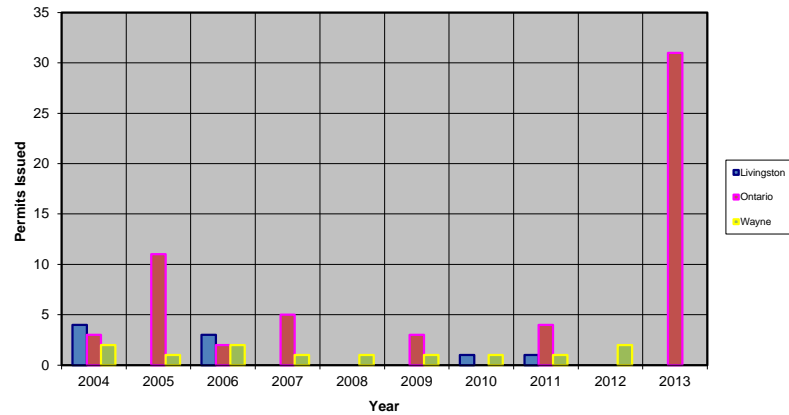

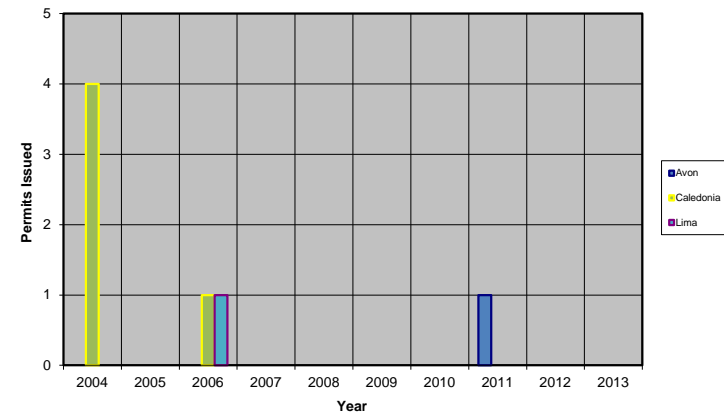

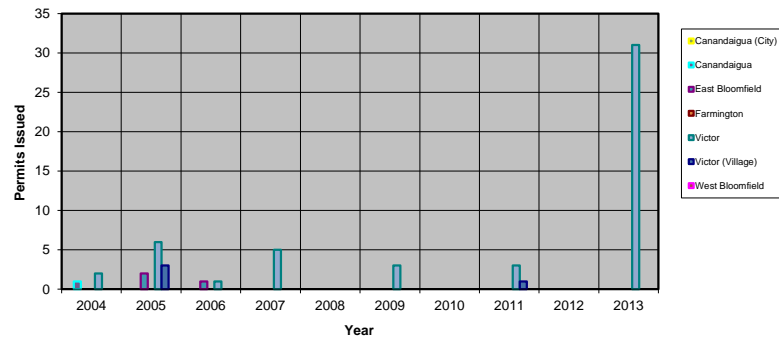
**Permits Issued for Industrial Buildings in TMA (outside Monroe County)
Towns by County (2004 - 2013)**



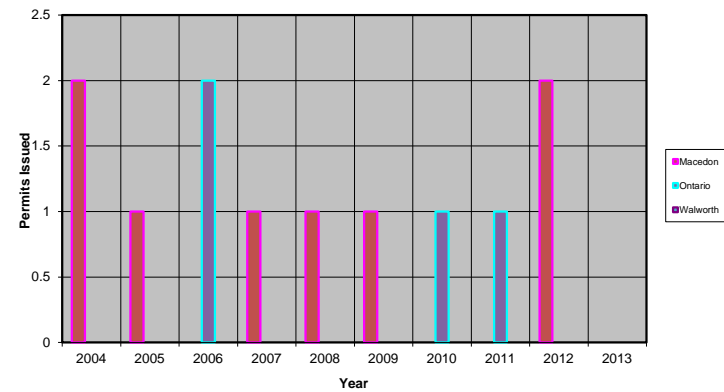
**Permits Issued for Industrial Buildings in Livingston County

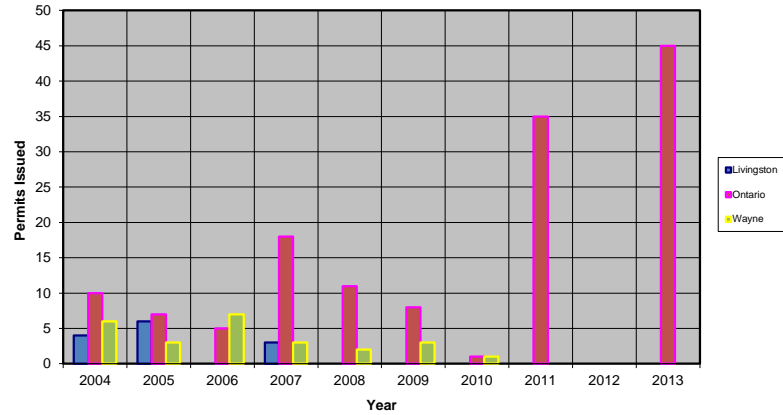

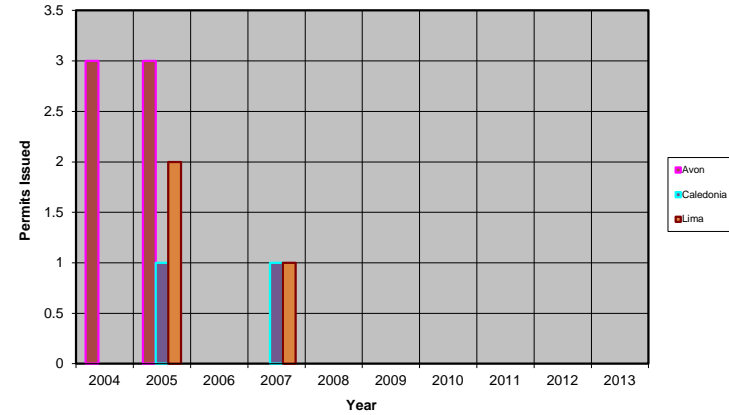

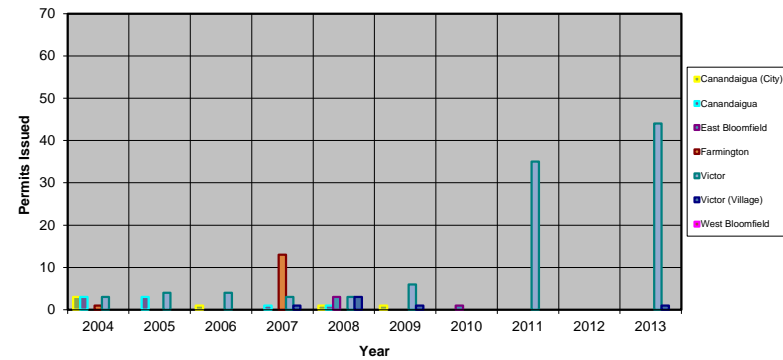
**Permits Issued for Commercial Buildings in TMA (outside Monroe County)
