This report was prepared by the Genesee/Finger Lakes Regional Planning Council for the Genesee Transportation Council under the Unified Planning Work Program (Task # 4220).

Mission Statement

The Genesee/Finger Lakes Regional Planning Council (G/FLRPC) will identify, define and inform its member counties of issues and opportunities critical to the physical, economic and social health of the region. G/FLRPC provides forums for discussion, debate and consensus building, and develops and implements a focused action plan with clearly defined outcomes, which include programs, personnel and funding.

Abstract

This report provides information on the issuance of building permits in 2015 to identify areas of growth within the Genesee-Finger Lakes Region (G-FL Region) that might require transportation planning and service modifications. The G-FL Region is comprised of Genesee, Livingston, Monroe, Ontario, Orleans, Seneca, Wayne, Wyoming, and Yates Counties. The report analyzes the number of permits issued, total square footage, and total value for buildings for each municipality within the region as well as the Metropolitan Planning Area (MPA). The MPA covers Monroe County and the municipalities adjacent to Monroe County in Livingston, Ontario, and Wayne Counties, as well as the Town and City of Canandaigua. The analysis looks at the following categories and respective subcategories: “residential” (single-family, two-family, three or four-family, five-or-more family, mobile/manufactured homes); “industrial;” “commercial” (offices/banks, retail/service, service stations, hotels/motels); “community service” (hospitals/health facilities, schools/churches, public works/safety, utilities); and “not elsewhere classified.”

Introduction

The Genesee Transportation Council (GTC) provides funding annually for the *Regional Land Use Monitoring Report* (LUMR) under its Unified Planning Work Program. The purpose of this report is to provide information for building permits by type, size, and value to identify areas of growth within the Genesee-Finger Lakes (G-FL) Region that may, as a result, require increased transportation planning and services.

The *Regional Land Use Monitoring Report* includes residential, industrial, commercial, and community service building permit data for all nine counties in the G-FL Region. The categories (and associated subcategories) for building permit data are as follows:

- Residential (single-family, two-family, three-or-four-family, five-or-more-family, and mobile/manufactured homes)
- Industrial
- Commercial (offices/banks, retail/service, service stations, hotels/motels)
- Community Service (hospitals, schools)
- Not Elsewhere Classified

A five-year trend analysis is provided for permitted residential units in all nine counties and industrial, commercial and community service building permits are analyzed over the five-year period. This time-series analysis is based on this year's and the four previous years' Land Use Monitoring Reports produced by the Genesee/Finger Lakes Regional Planning Council (G/FLRPC).

In addition, a time series (or historical trend) analysis is provided for residential, industrial, and commercial development and subdivision approvals in the Metropolitan Planning Area (MPA).

The MPA includes Monroe County and the adjacent municipalities to the south and east as well as the City and Town of Canandaigua. Table 1 represents the municipalities that, along with Monroe County, comprise the MPA.

An analysis of the collected data on the number, value, and size of buildings permitted in 2015 is provided for each county as well as the MPA.

Given that many conclusions can be drawn from the data on permitted building activity tables are provided in appendices at the end of this report for the reader to use for their own needs and analysis.

Methodology

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties these officials were, in most cases, the code or zoning enforcement officers; in some cases the municipal clerks. In Seneca and Wyoming Counties building permit application approval and inspection are the responsibility of the respective county building departments. Those two departments provided the data for their counties. The Monroe County Planning and Development Department's Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to G/FLRPC.

As noted above, each municipality other than Seneca and Wyoming Counties received a survey in January of 2015 asking for the requested data. The initial survey was followed up with a reminder e-mail along with a telephone reminder to those municipalities that had yet to respond. In some cases, several calls or e-mails were made to the appropriate parties in an effort to acquire the requested information. Overall, 100% of the data was collected from all 190 municipalities within the nine-county G-FL Region.

The survey requested information on the number of permits issued, total square footage and total value for buildings in the defined categories and associated subcategories. In addition, the same building permit information for buildings outside of these categories was requested along with a description of the type of building(s) in the "Other" category.

All analysis conducted in this report is based on data provided by each LUMR survey contact.

The instructions for completing the survey as printed on the survey document were as follows:

"Include only permits for the construction of buildings in 2015. Do not include additions, repairs, decks, in-ground pools, etc. or buildings used for storage such as sheds and pole barns. Do not include permits for construction that was completed in 2015 but permitted in a previous calendar year. If the responses below include a town and a village on the same sheet, please denote this by listing them separately on the same line (example: T – 8/V – 12)."

For each of the nine counties, there is a discussion of permitted building activity in 2015 and county maps of residential units permitted in 2015 by municipality (Maps 1 – 9, Map 10 represents Permits for Residential Units for the nine-county G-FL Region). Data of industrial, commercial, and community service building permits issued in 2015 are presented on maps of the nine-county G-FL Region (Maps 11-13).

The information and data provided for permitted building activity in Monroe County and the remaining portion of the MPA follows the same format. Maps 14 through 17 present the number of permitted residential, industrial, commercial, and community service buildings in the MPA in 2015. Map 18 shows the distribution of residential building permits among the Transportation Analysis Zones (TAZ) within the MPA outside of Monroe County.

The residential data for MPA municipalities were used in a time series analysis of the number of residential units permitted by municipality for the years 2006 through 2015. The

number of permits issued for industrial and commercial buildings from 2006 to 2015 in the MPA outside of Monroe County is also presented and discussed in the same manner.

The data gathered on number of building permits issued, square footage, and value in each category/subcategory by municipality in, and for the MPA, outside Monroe County are presented in Appendices A through H. The Appendices are as follows:

2015 County Building Permit Analysis

Genesee County

Residential Permits:

- Sixty two (62) residential building permits were reported in Genesee County in 2015 totaling 115 units. The largest number of permits (25) was reported in the Town of Batavia, totaling 38,400 square feet with a combined value of \$7,560,000. The Town of LeRoy reported the second most permits with six.

Industrial Permits:

- Three (3) industrial building permits were reported in 2015.

Commercial Permits:

- Two (2) commercial building permits were reported in 2015.

Community Service Permits:

Not Elsewhere Classified Permits:

Livingston County

Residential Permits:

- Fifty nine (59) residential building permits were reported in Livingston County in 2015. The largest amount of permits reported were in the Town of Livonia (13) and Village of Lima (7) respectively.

Industrial Permits:

- There were 12 industrial building permits reported in 2015.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2015.

Commercial Permits:

Community Service Permits:

Monroe County

Residential Permits:

- Municipalities in Monroe County reported 786 residential building permits for a total of 1,232 residential units in 2015. The largest number of permits reported was in the Town of Webster (111) and the Town of Greece (88). The Town of Perinton reported the next largest number of residential permits (85), followed by the Town of Penfield (81), and the Town of Henrietta (72).
- A total of 117 multi-family unit permits were reported for 563 units in the county.

Map 3 shows the number of residential unit permits in Monroe County in 2015.

Industrial Permits:

- There were 17 industrial building permits reported in the County, four in the City of Rochester and three in the Towns of Henrietta and Mendon respectively.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2015.

Commercial Permits:

- There were 17 commercial building permits reported in Monroe County. The Town of Henrietta reported the most with six permits.

- Three (3) permits were reported for community service buildings in Monroe County.

Map 13 shows the number of community service building permits by municipality in the G-FL Region in 2015.

- Ninety (90) permits were reported and that did not correspond to the above-described categories and included as not elsewhere classified.

Demolition Permits:

- Eighty seven (87) residential demolition permits were reported in Monroe County in 2015.

Ontario County

Residential Permits:

- Ontario County municipalities reported 373 residential structures permitted in 2015. The Town of Canandaigua reported the most permits with 162. The Town of Victor reported the second most with 65 followed by the Town of Farmington with 57.

Industrial Permits:

- There were eight industrial building permits reported in Ontario County in 2015.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2015.

Commercial Permits:

- Nineteen (19) commercial building permits were reported in Ontario County. The City of Canandaigua reported the most with 5.

Community Service Permits:

- There were two permits reported for community service buildings in Ontario County in 2015, both in the City of Geneva.

- Three (3) permits were issued and that did not correspond to the above-described categories and were included as not elsewhere classified.

Demolition Permits:

Residential Permits:

- Thirty (30) residential building permits, all single-family, were reported in Orleans County in 2015. The Towns of Carlton and Clarendon reported the most in the County with eight and four respectively.

Industrial Permits:

- One (1) industrial permit was reported in Orleans County in 2015.

Residential Permits:

- Twenty one (21) residential building permits, were reported in Seneca County in 2015. The largest number of permits reported was in the Town of Waterloo (8).

Industrial Permits:

- Three (3) industrial building permits were reported in Seneca County in 2015, all in the Town of Junius.

- Four (4) commercial building permits were reported in Seneca County in 2015, one each in the Towns of Fayette, Lodi and Seneca Falls and in the Village of Interlaken.

Community Service Permits:

- No community service buildings were reported in Seneca County for 2015.

Not Elsewhere Classified Permits:

- Five (5) permits were reported and included as not elsewhere classified for Seneca County municipalities.

Demolition Permits:

- Twenty two (22) residential demolition permits were reported in Seneca County in 2015.

Wayne County

Residential Permits:

- Municipalities in Wayne County issued 90 permits totaling 160 units in 2015. The highest total of permits reported in the County was in the Town of Walworth (19) followed by the Town of Ontario (17).

Map 7 shows the number of residential unit permits in Wayne County in 2015.

Industrial Permits:

- There were two permits reported for industrial buildings in Wayne County in 2015, one each in the Village of Clyde and the Town of Williamson.

Commercial Permits:

- Four (4) commercial building permits were reported in Wayne County for 2015.

Not Elsewhere Classified Permits:

- Three (3) permits were reported that did not correspond to the above-described categories and are included as not elsewhere classified.

Demolition Permits:

- Fifteen (15) residential demolition permits were reported in Wayne County in 2015.

Wyoming County

Residential Permits:

- In 2015, municipalities in Wyoming County reported 23 permits for residential structures. The Towns of Arcade and Gainesville reported the most permits with four each.

Map 8 shows the number of residential unit permits in Wyoming County in 2015.

Industrial Permits:

(Wyoming County does not categorize Industrial permits)

- The information reported by Wyoming County for permits issued does not correspond directly to the survey categories. Information related to industrial permits in Wyoming County is categorized under commercial permits. Therefore, it is unclear how many permits were issued for industrial buildings.

Map 11 shows the number of industrial building permits by municipality in the G-FL Region in 2015.

Commercial Permits:

- A total of 13 permits were reported for commercial buildings in the County in 2015. However, it is unclear how many of these are truly 'commercial' due to the other building type being included.

Map 12 shows the number of commercial building permits by municipality in the G-FL Region in 2015.

Community Service Permits:

(Wyoming County does not categorize community service permits)

- The Information reported by Wyoming County for permits issued does not correspond directly to the survey categories. 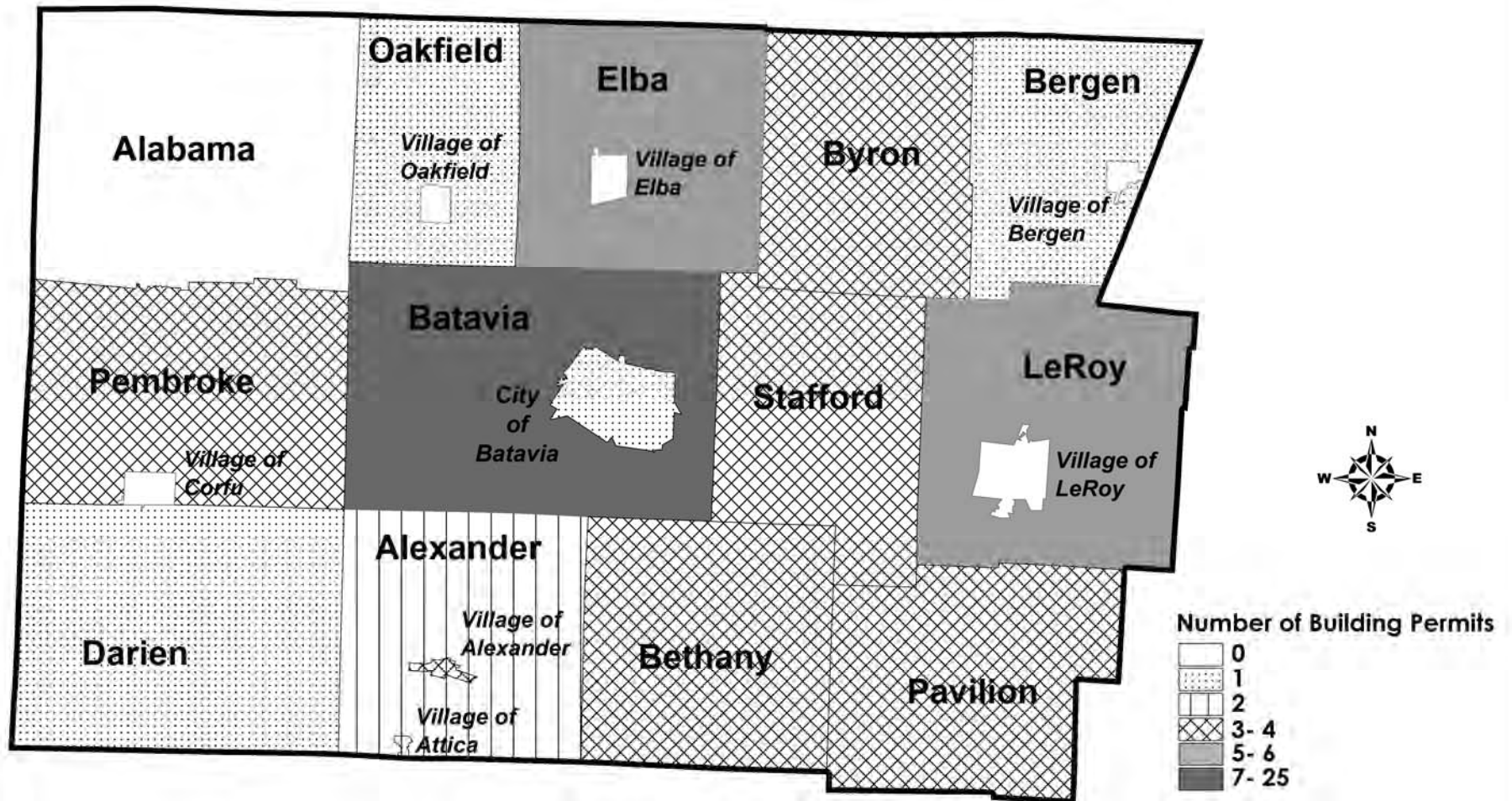

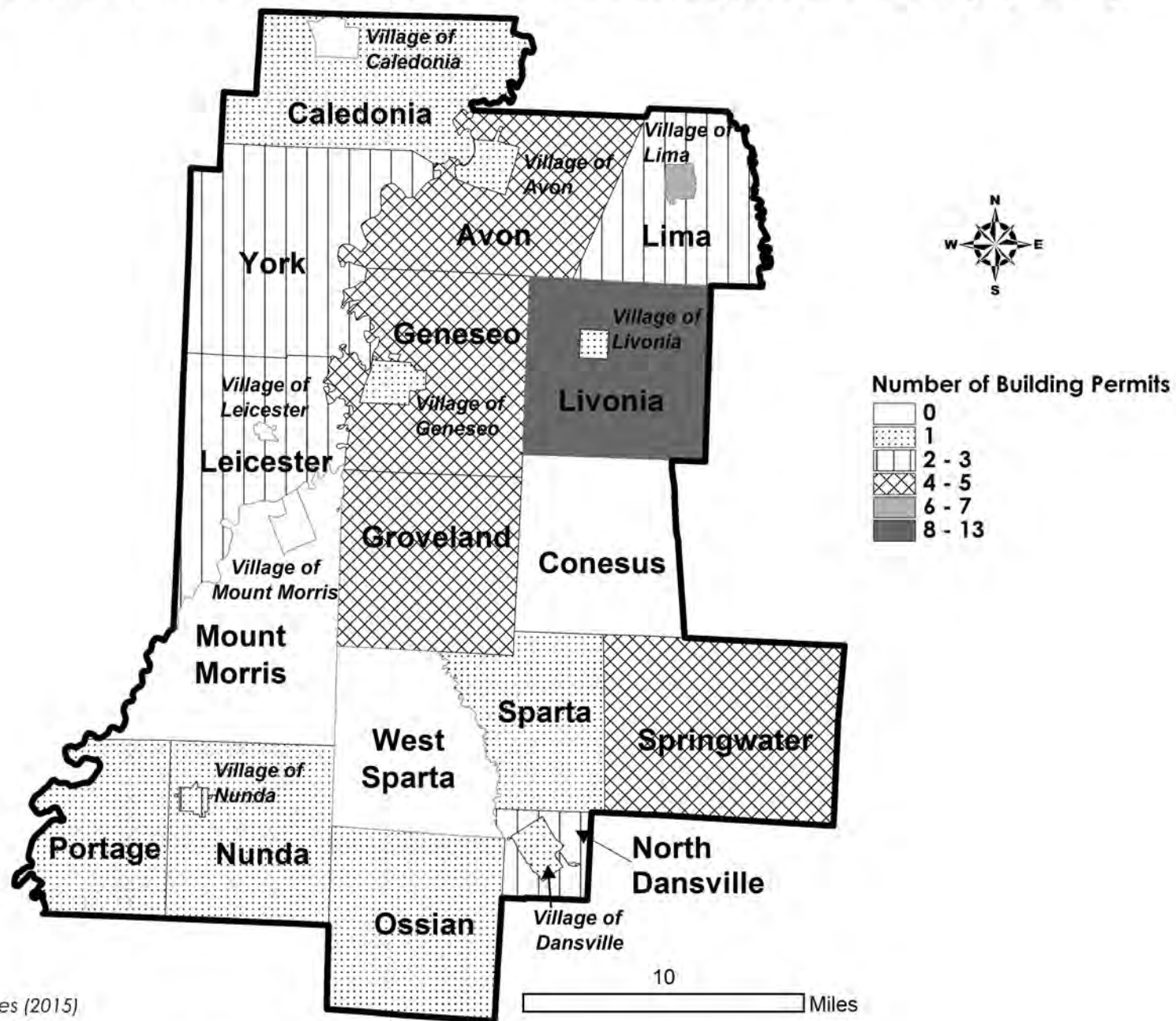

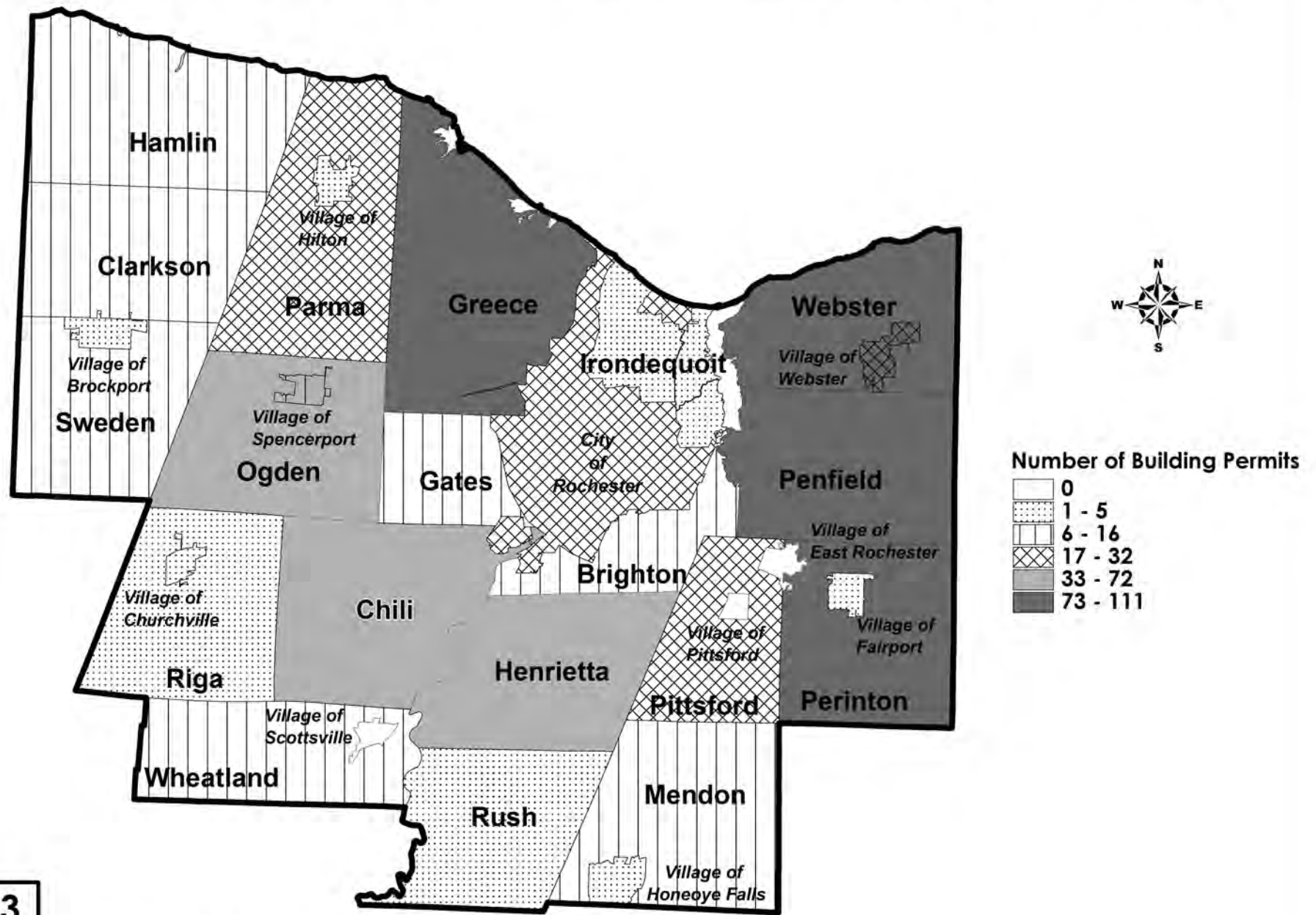

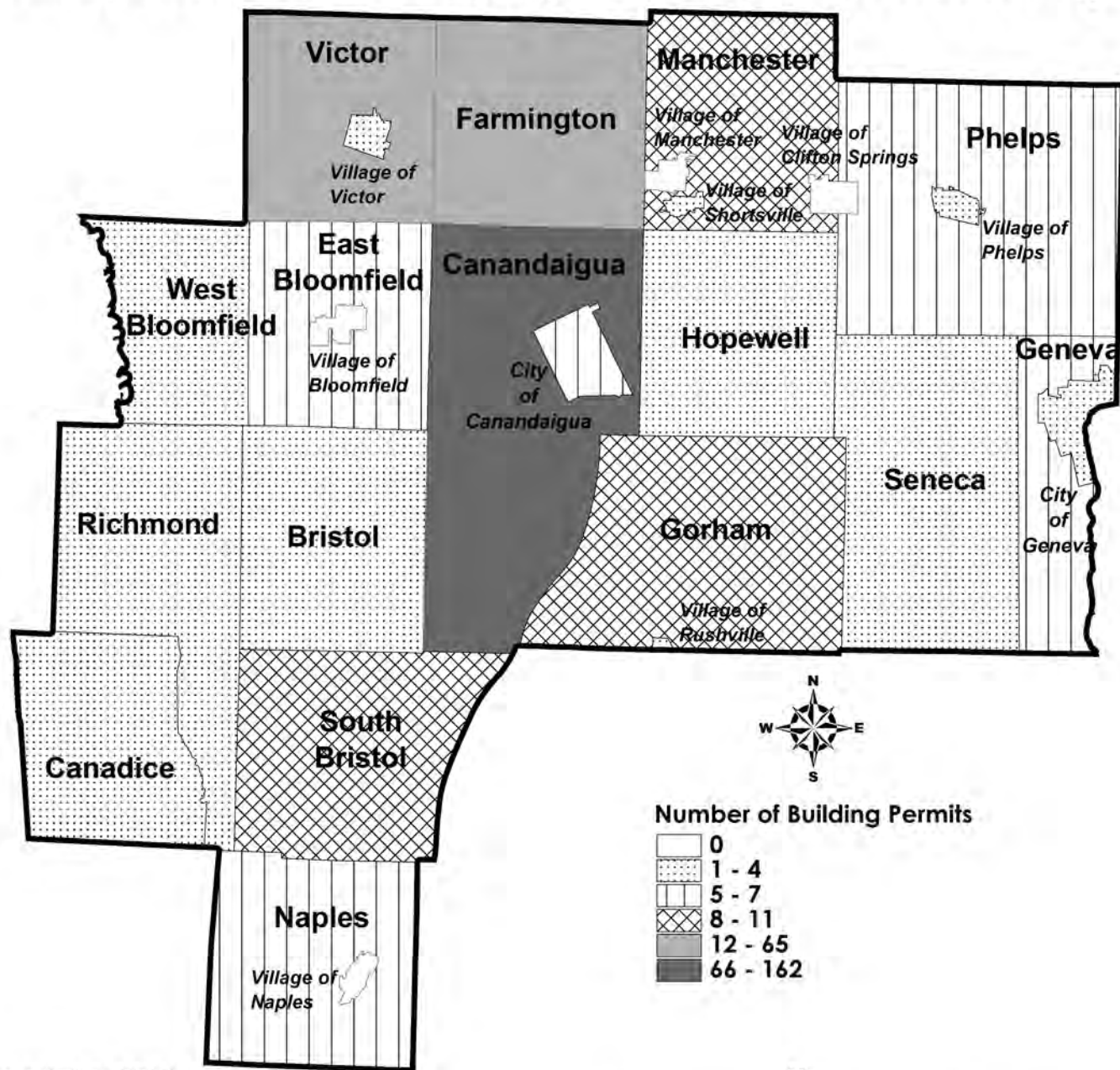

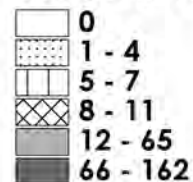

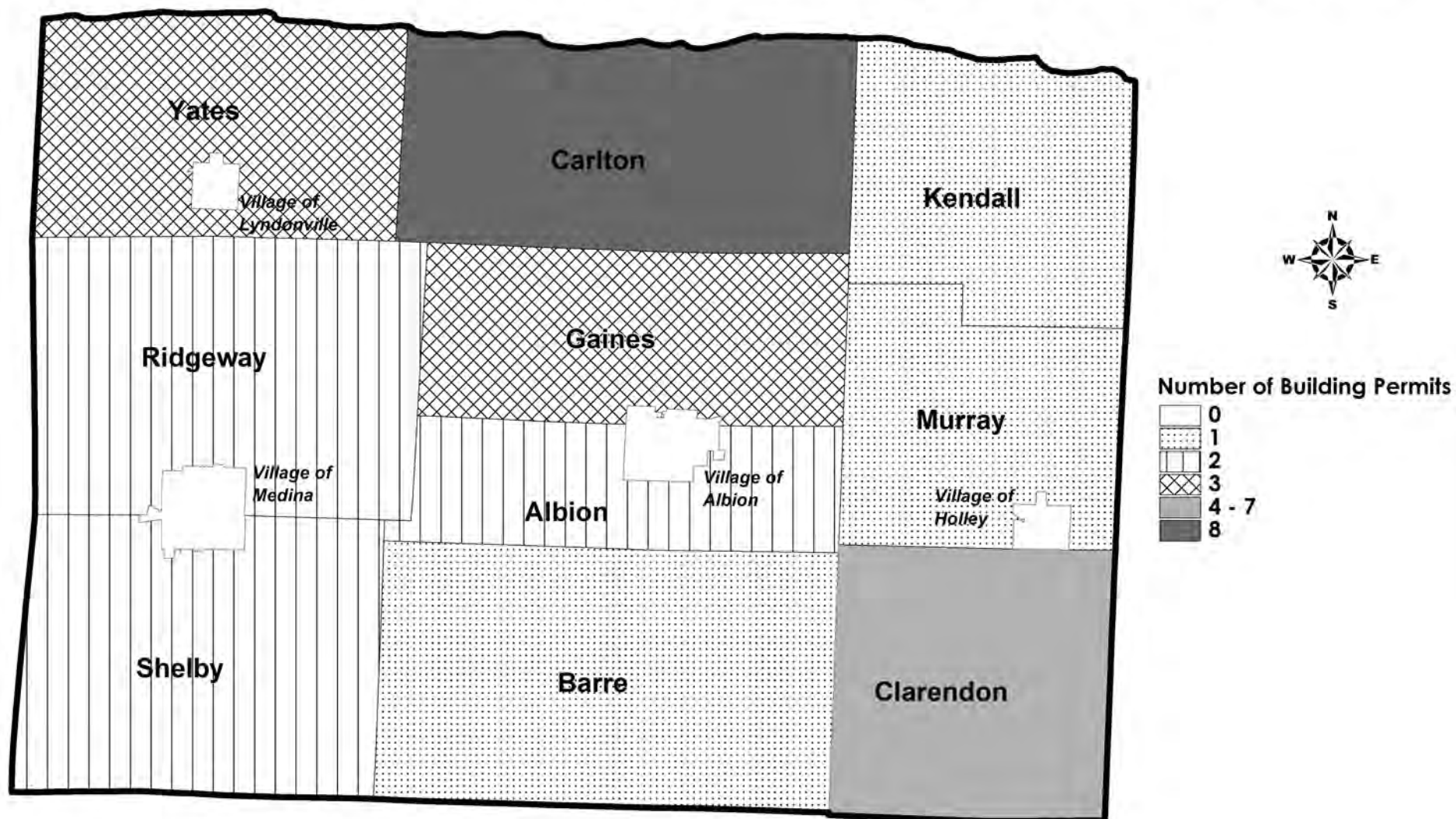

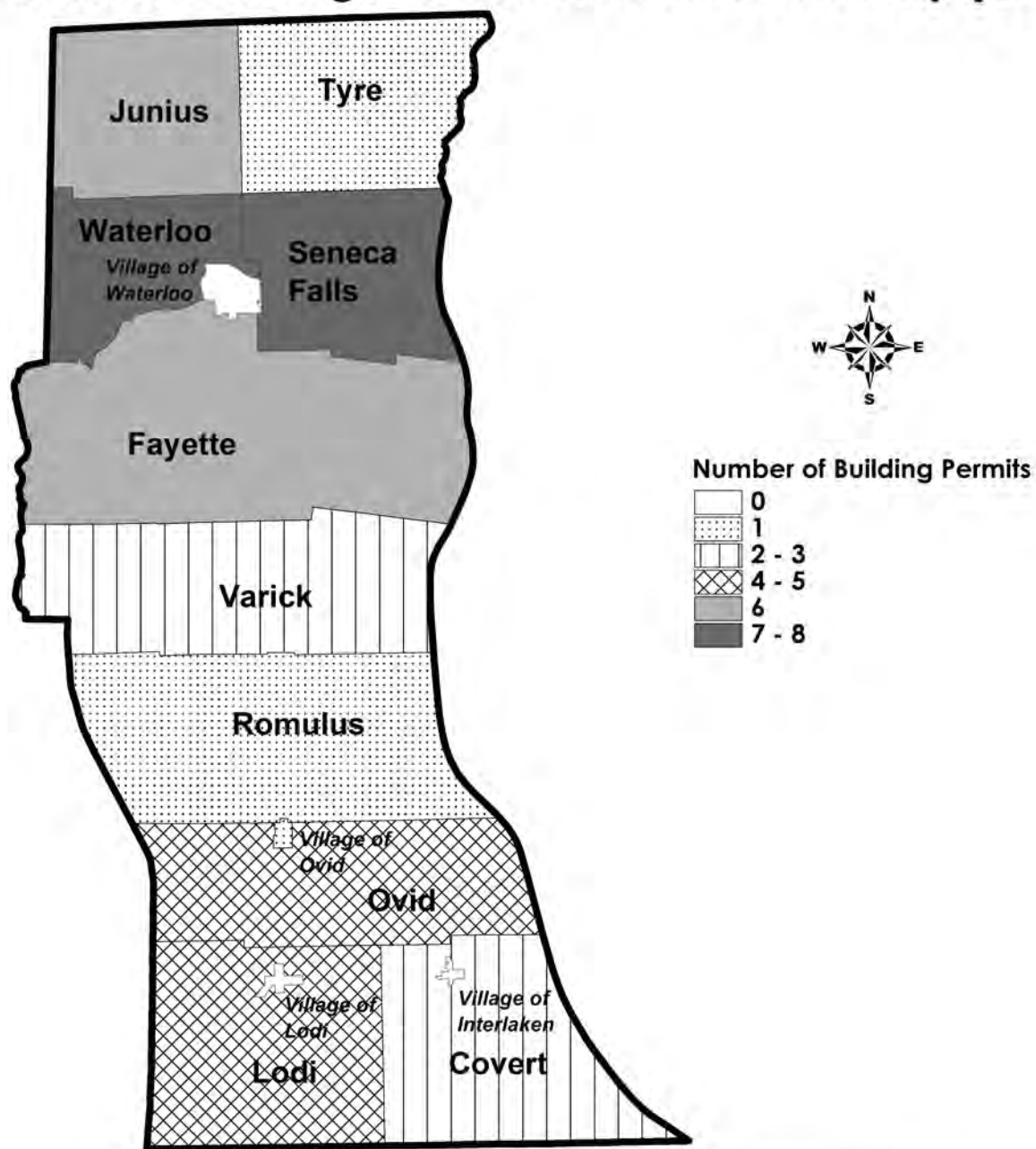

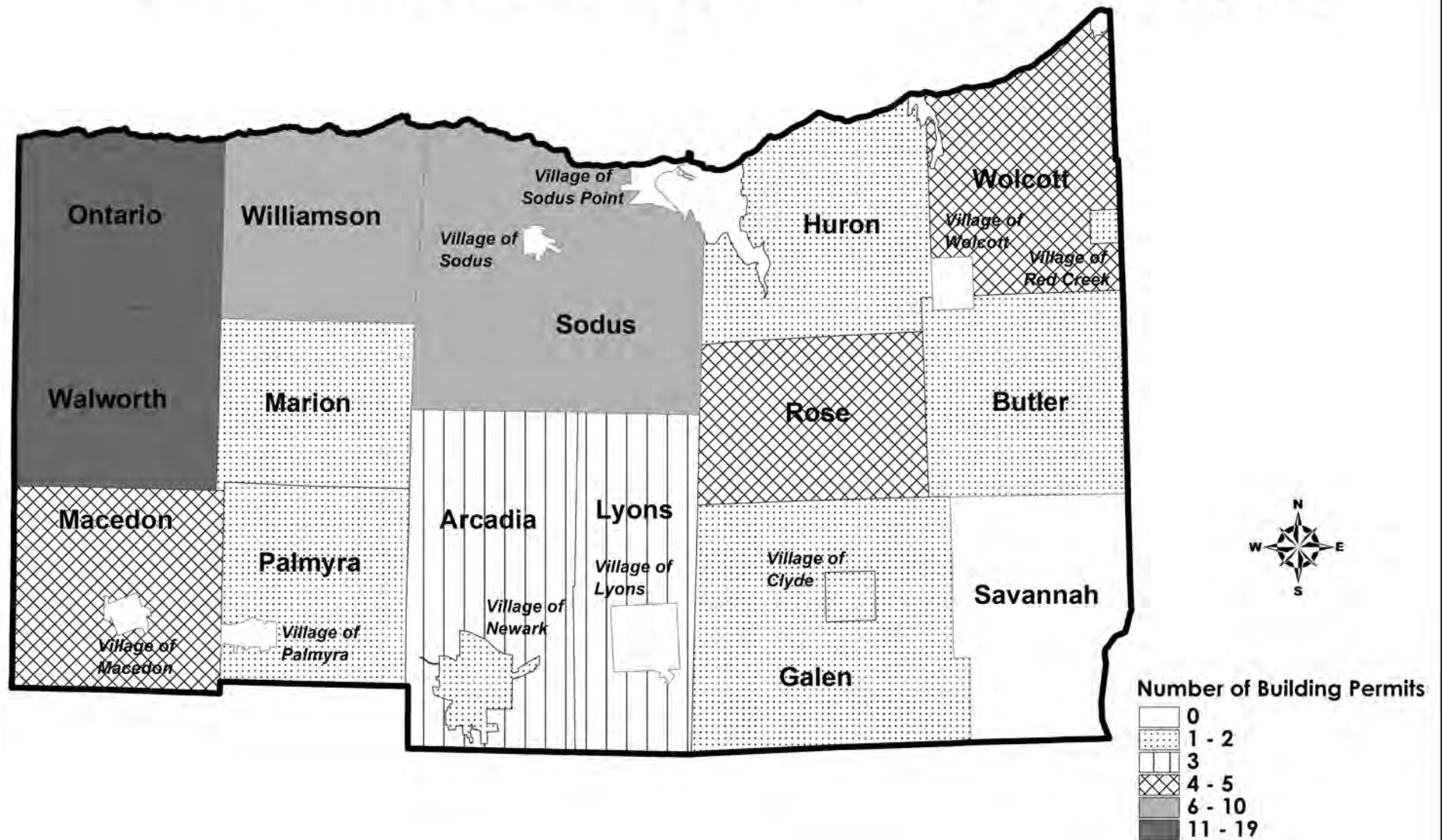

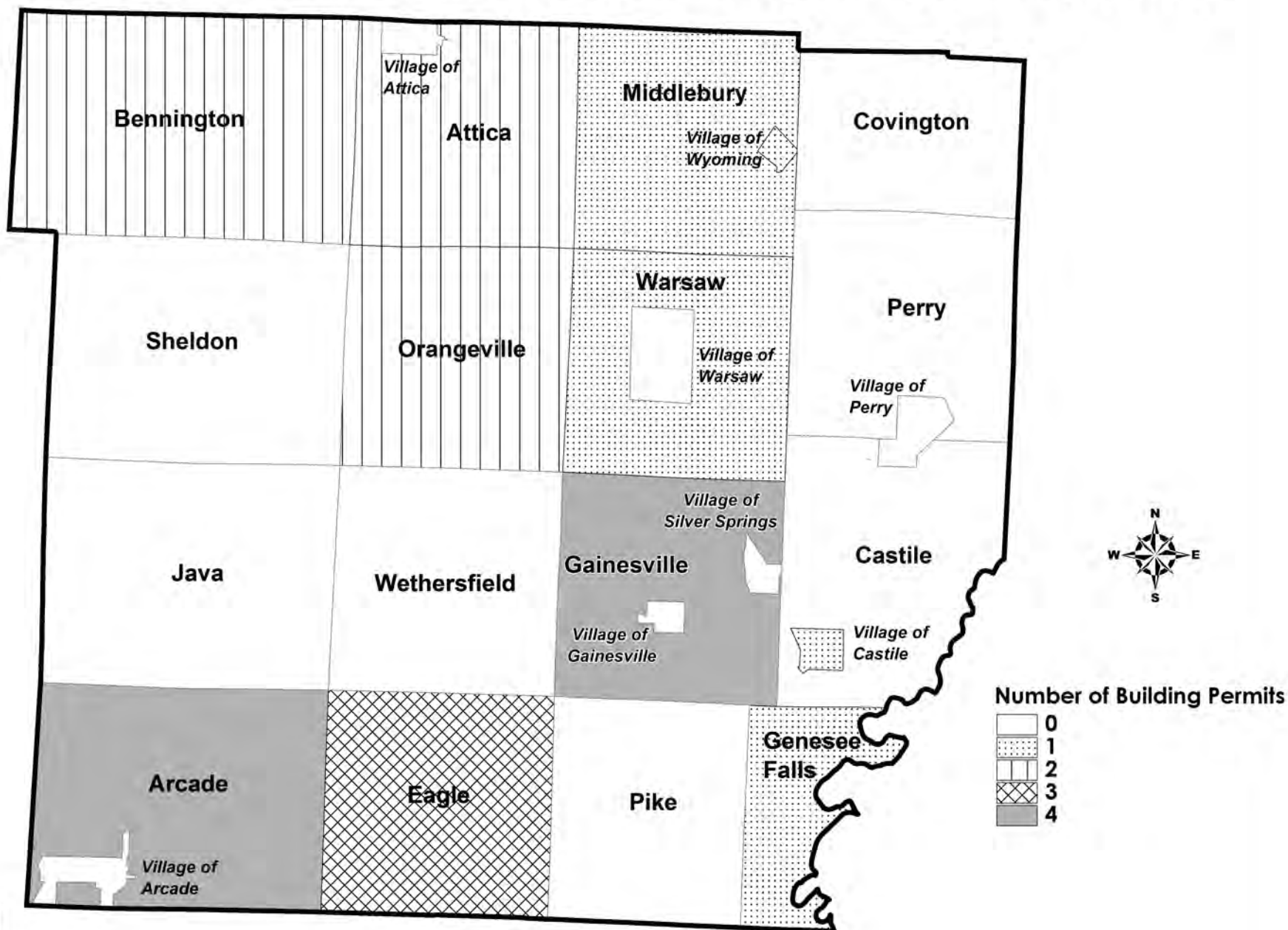

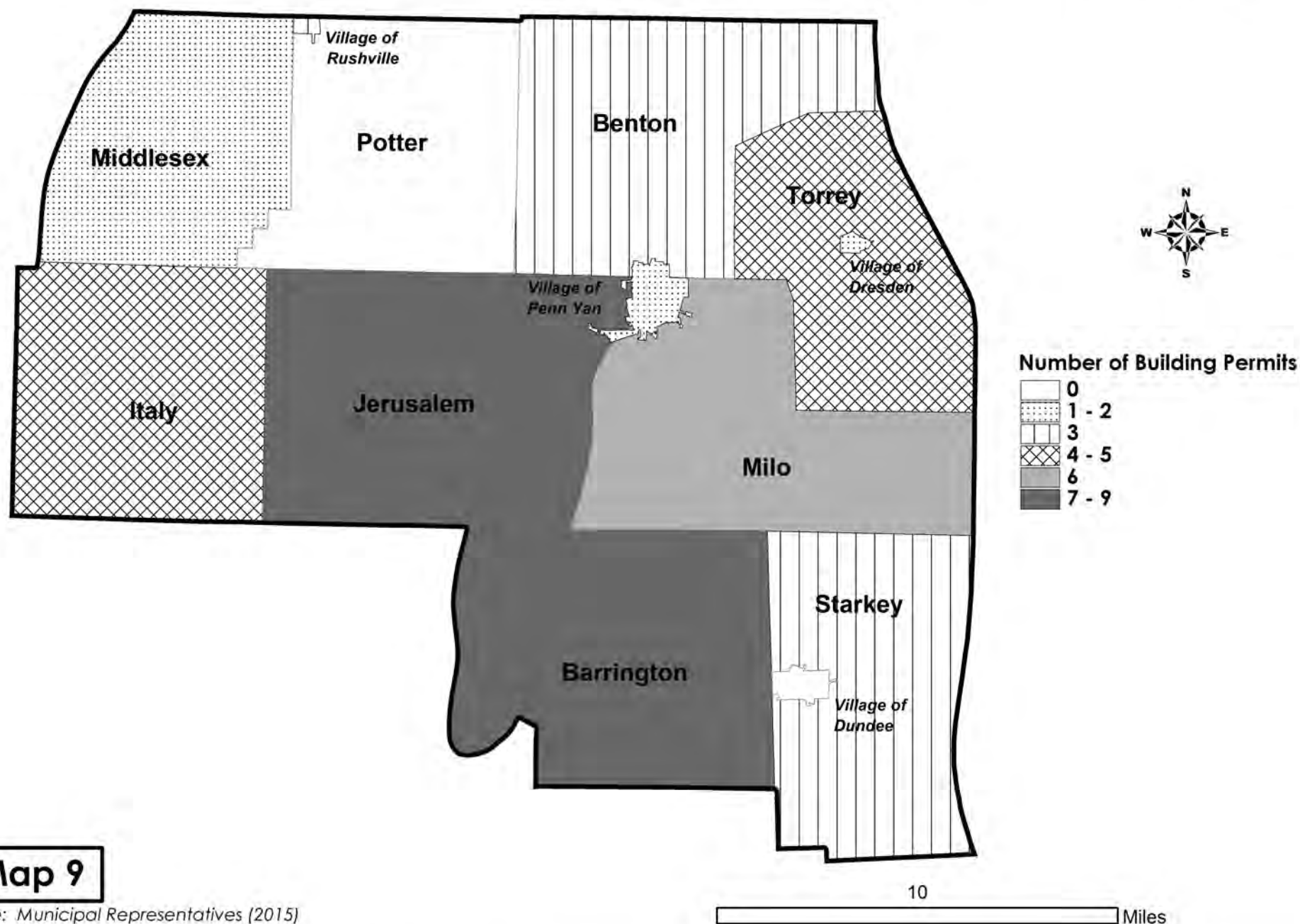

Number of Residential Building Permits in Yates County (2015)



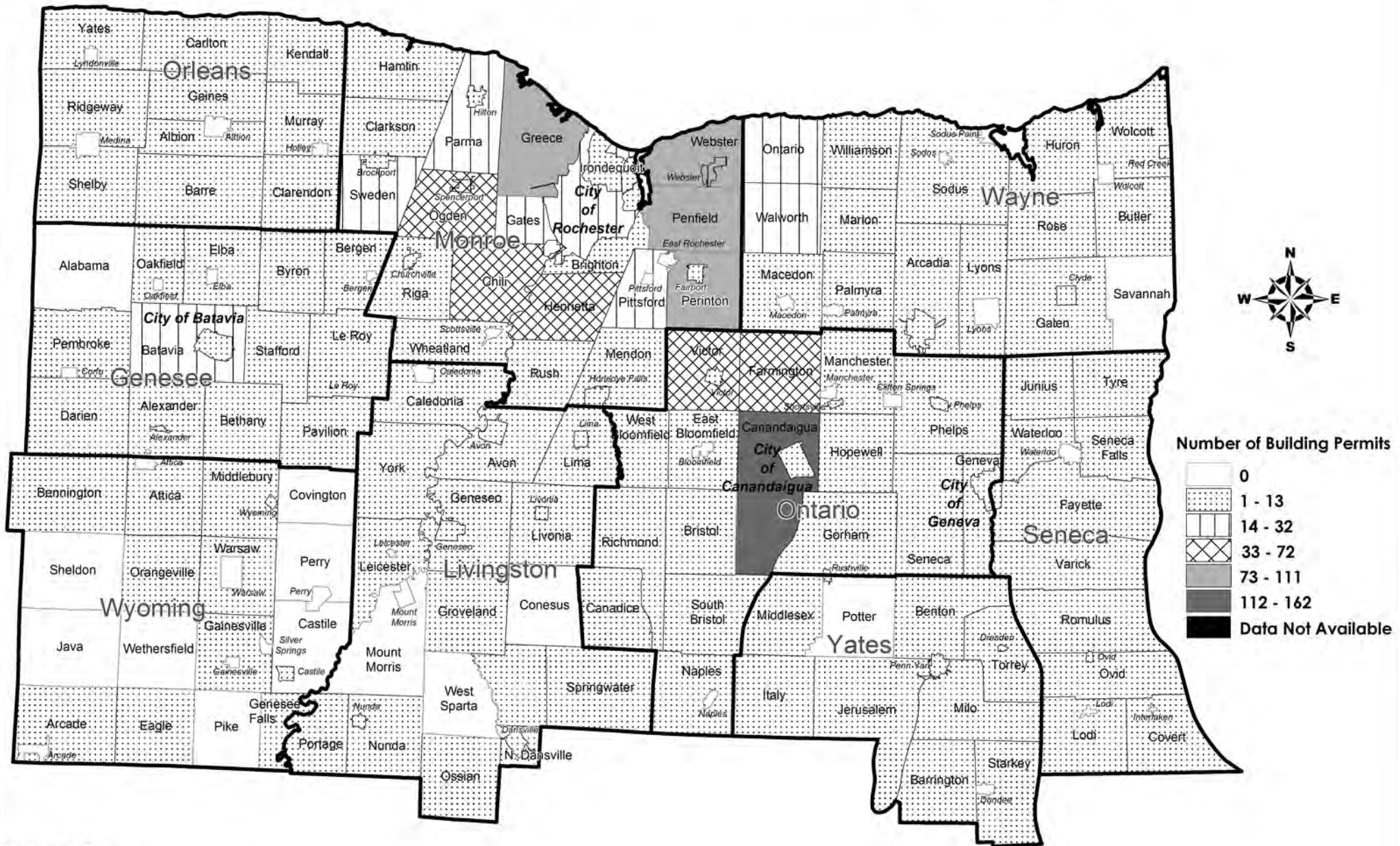

Number of Residential Building Permits in the Genesee/Finger Lakes Region (2015)



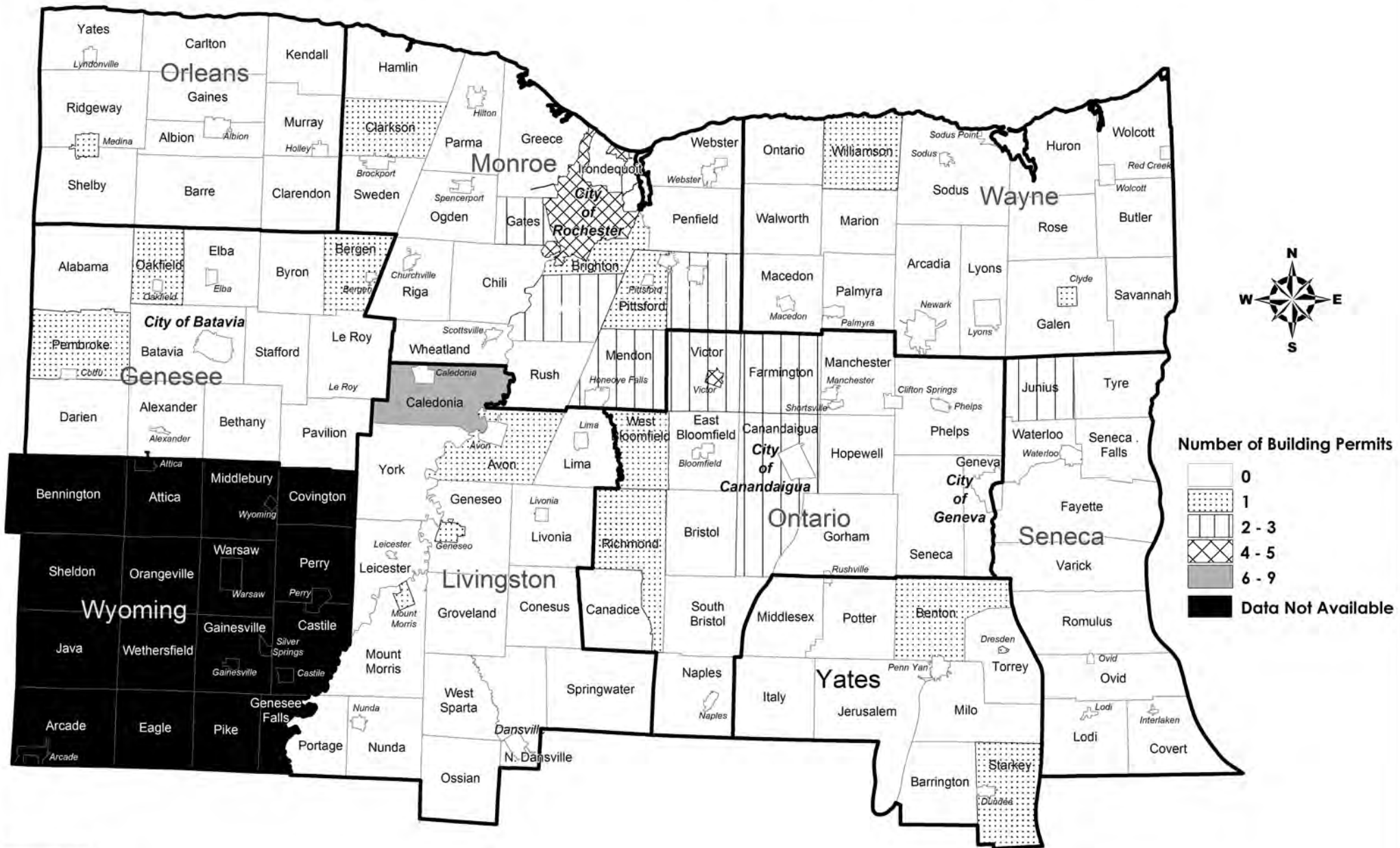

Number of Industrial Building Permits in the Genesee/Finger Lakes Region (2015)



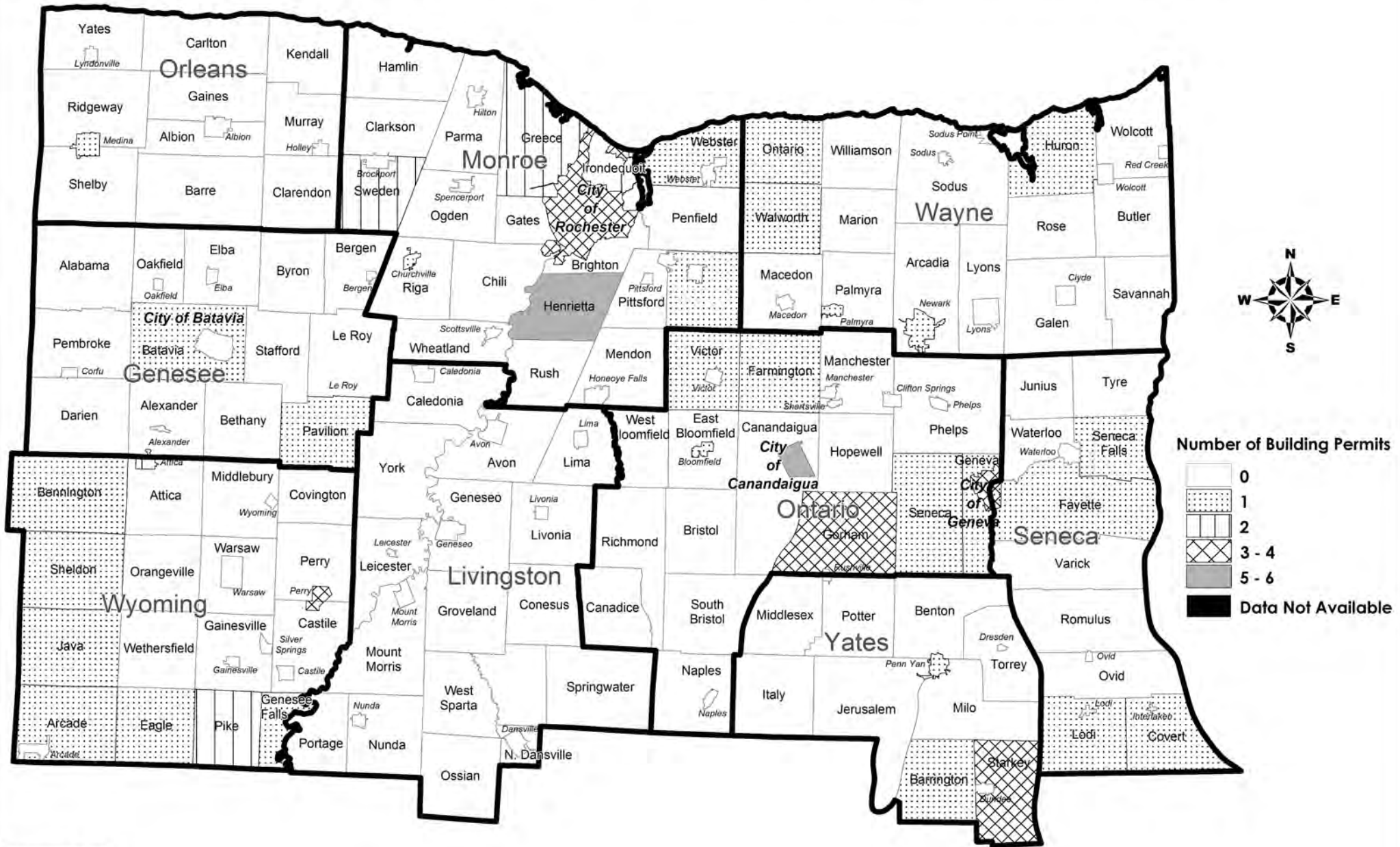

Number of Commercial Building Permits in the Genesee/Finger Lakes Region (2015)



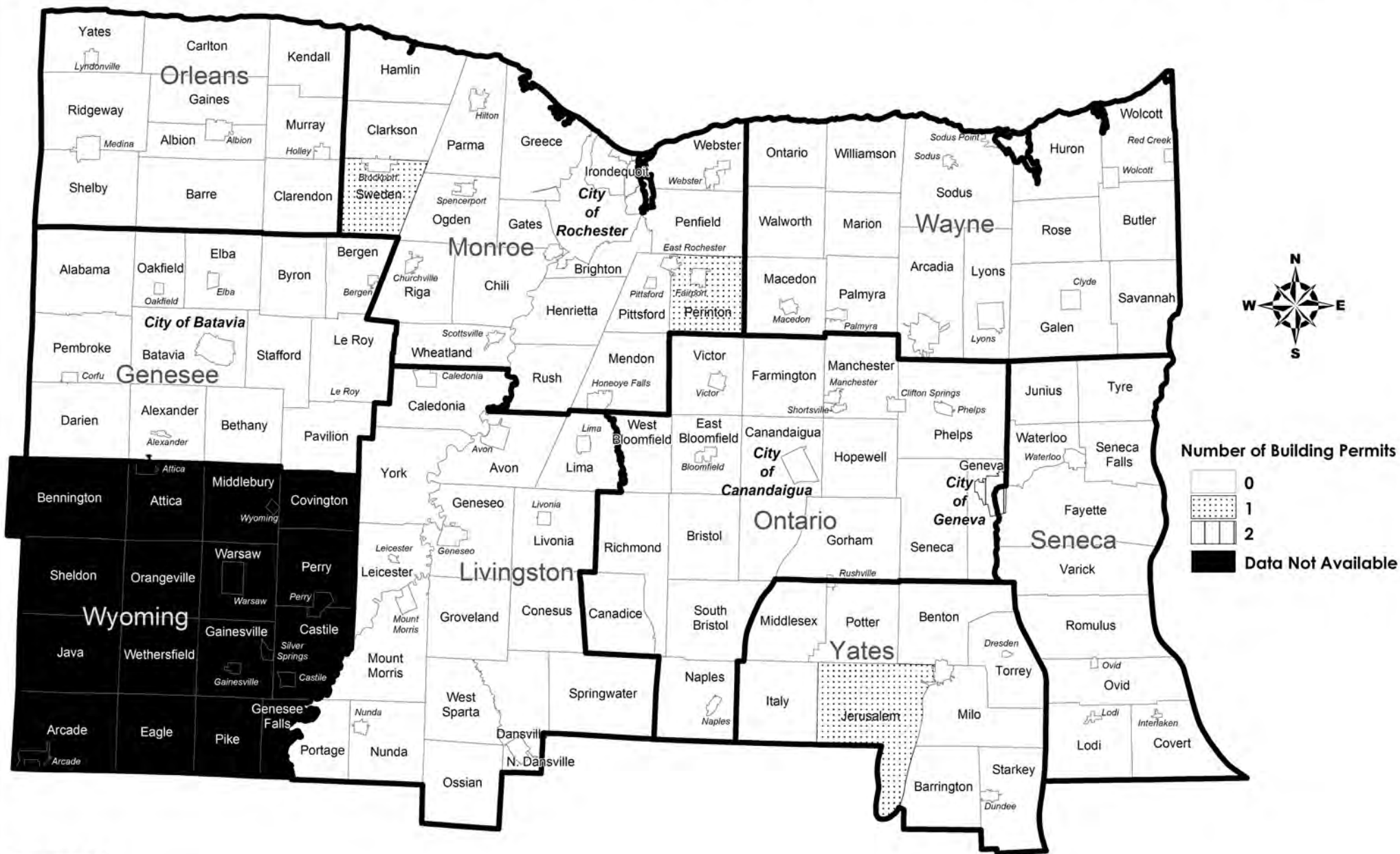

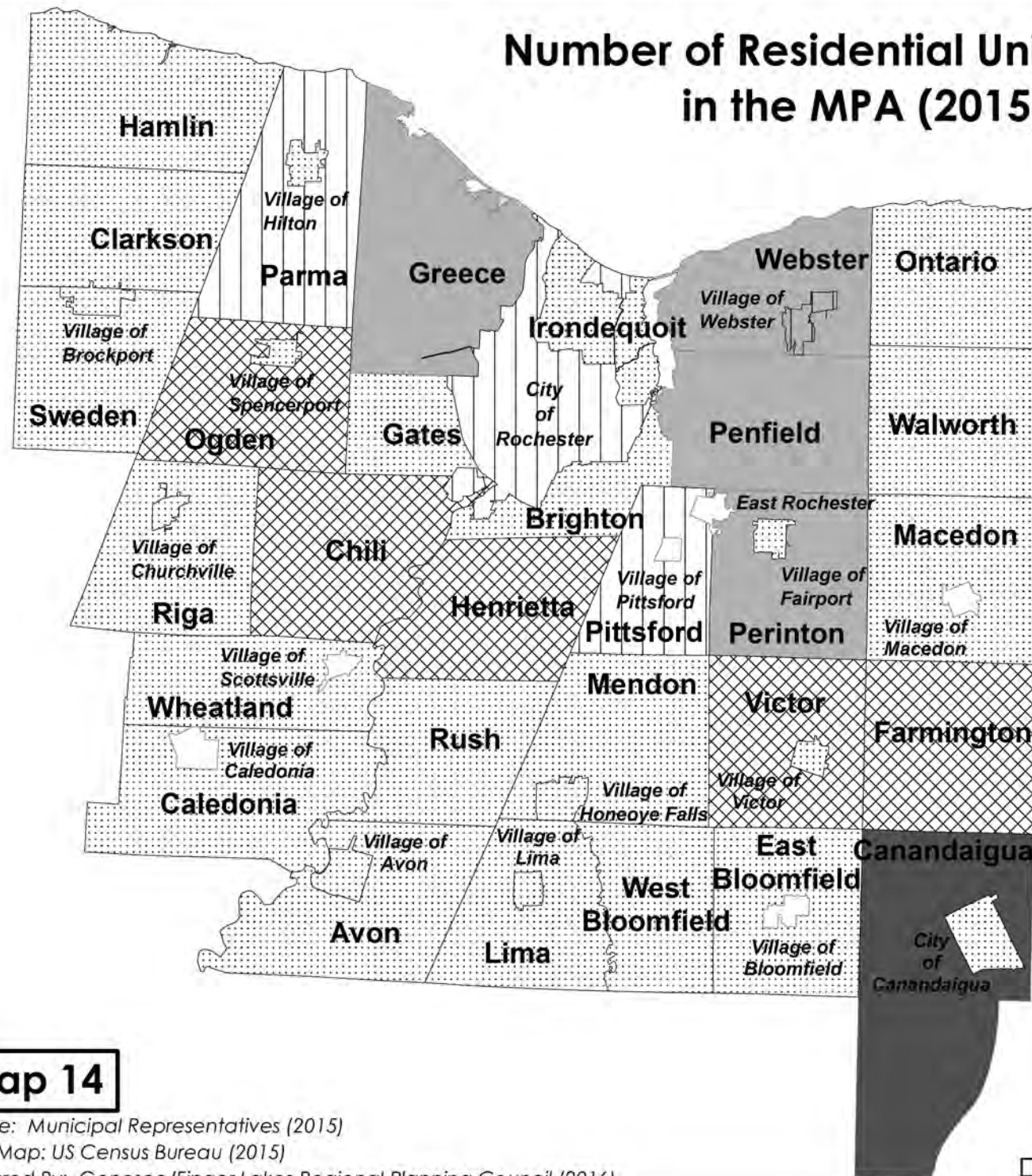

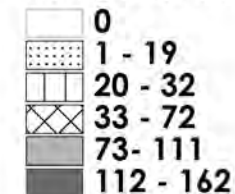

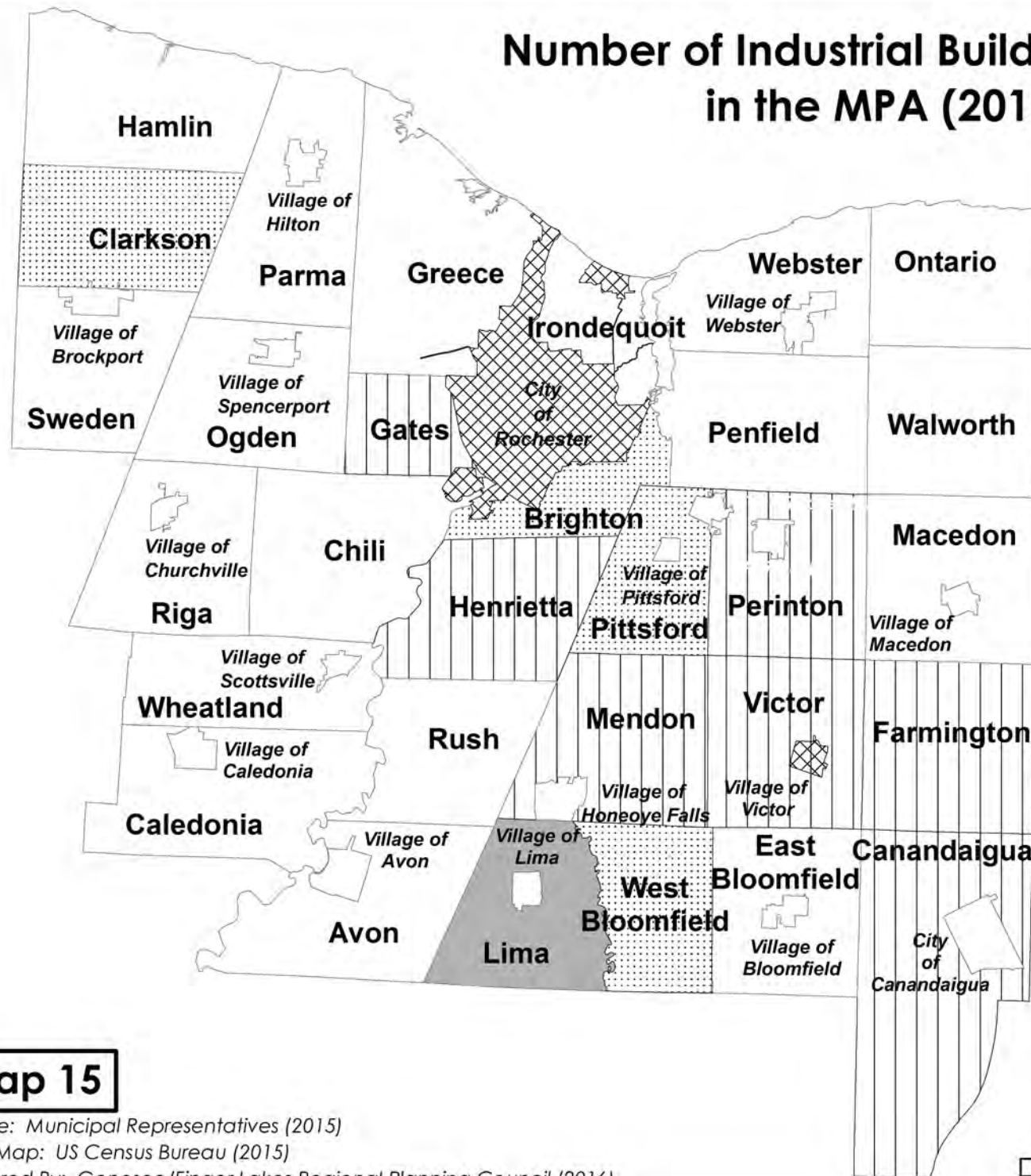

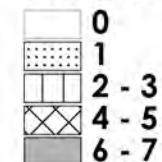

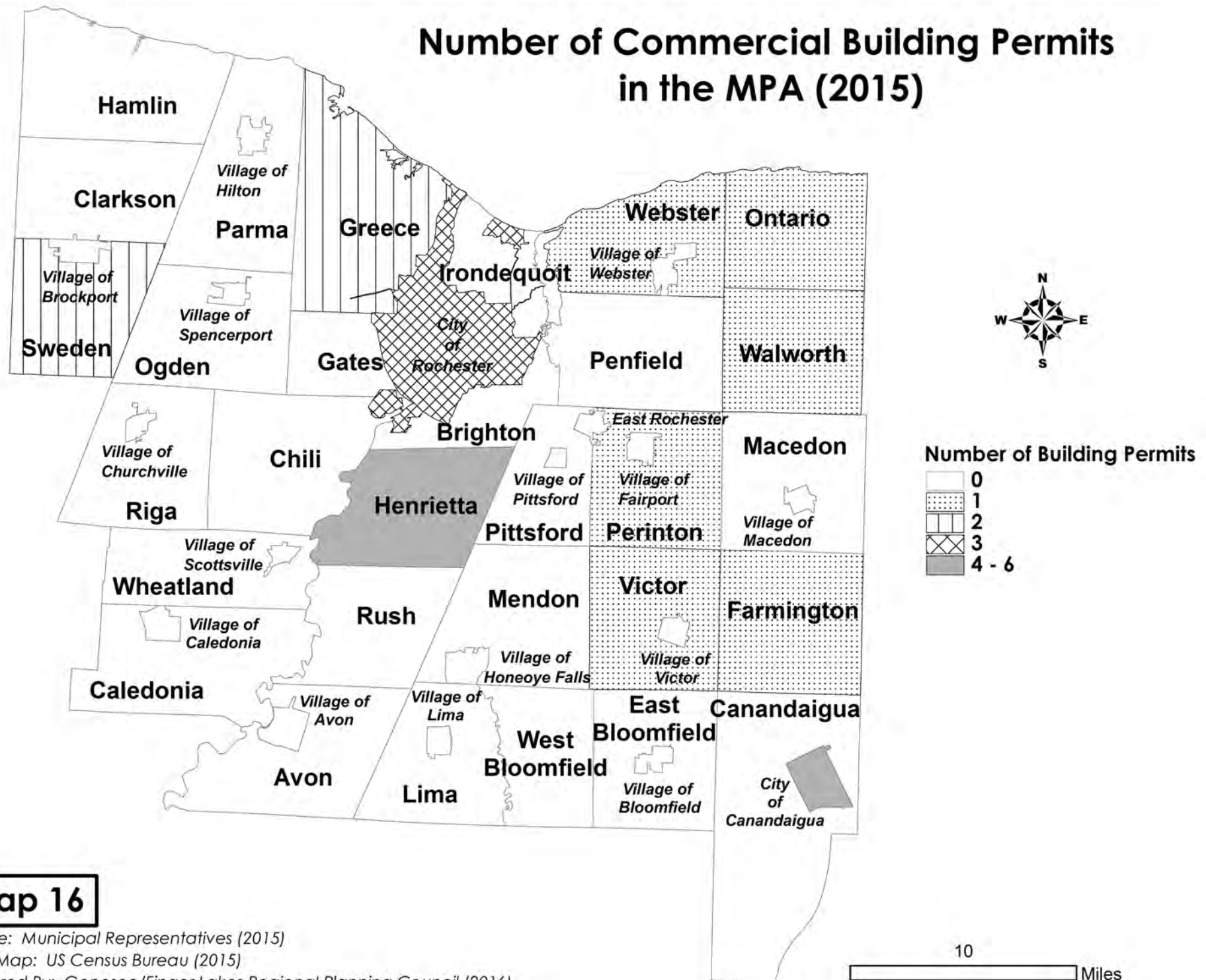

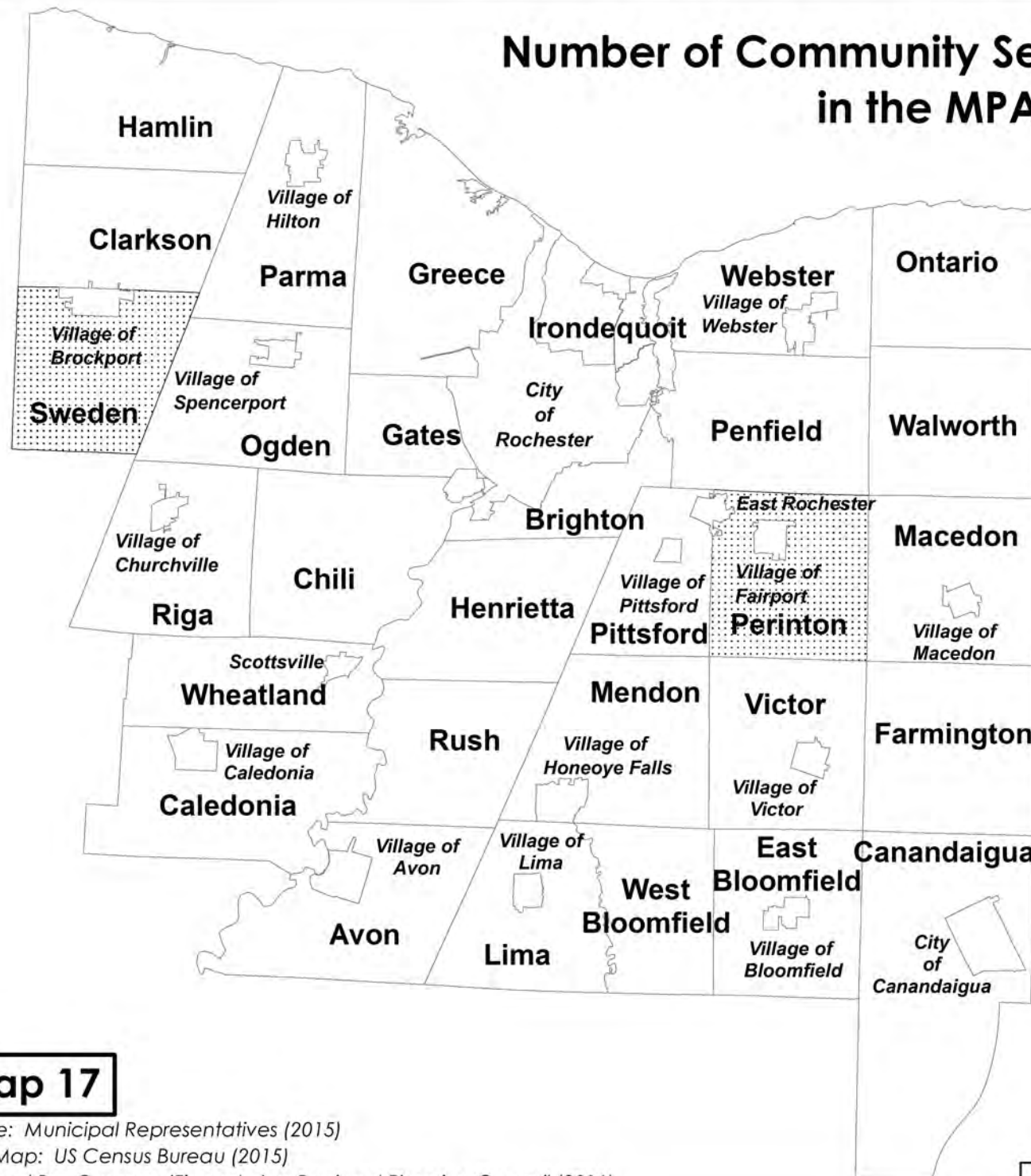

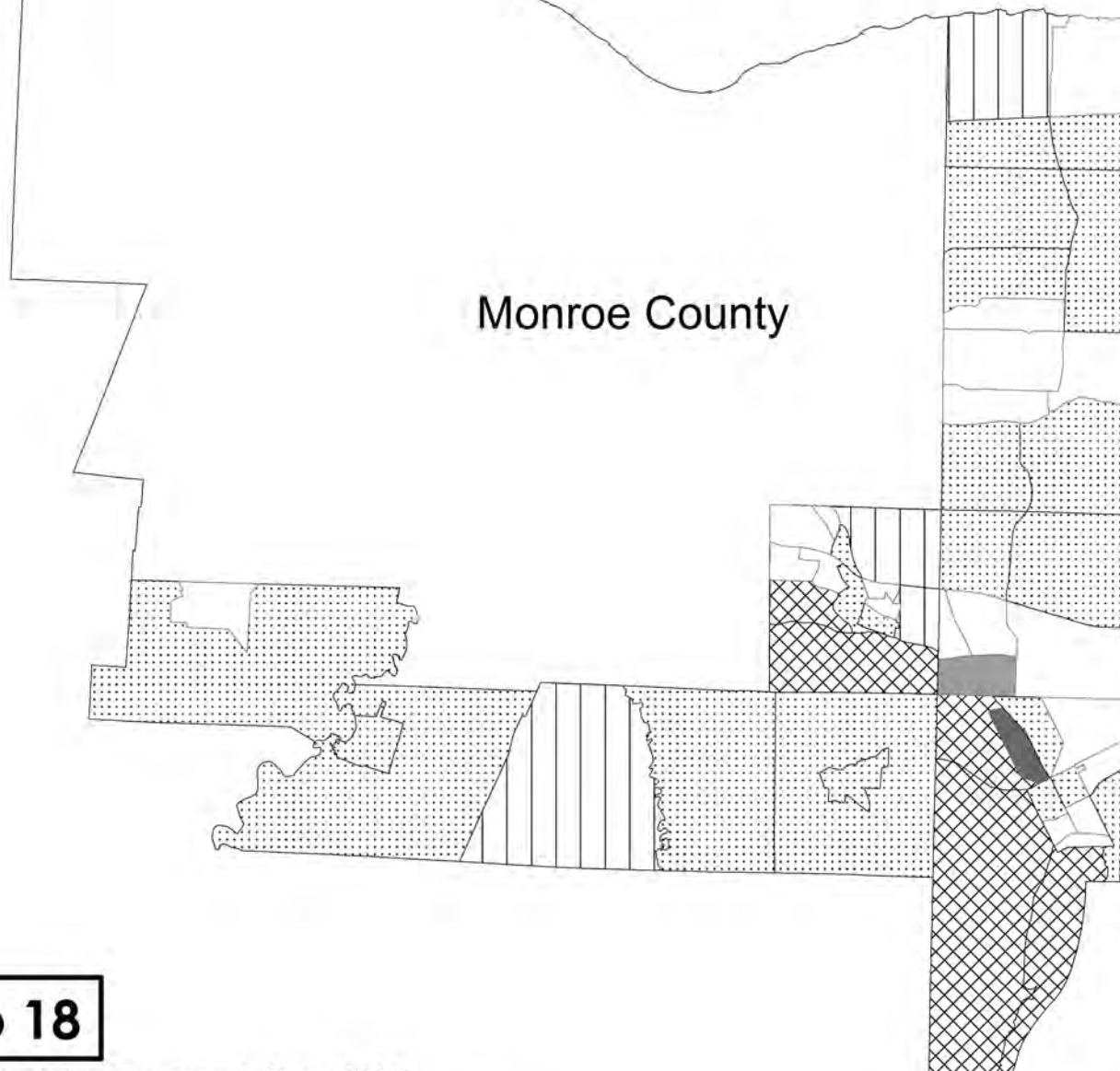

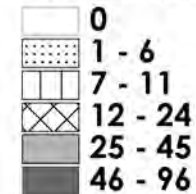

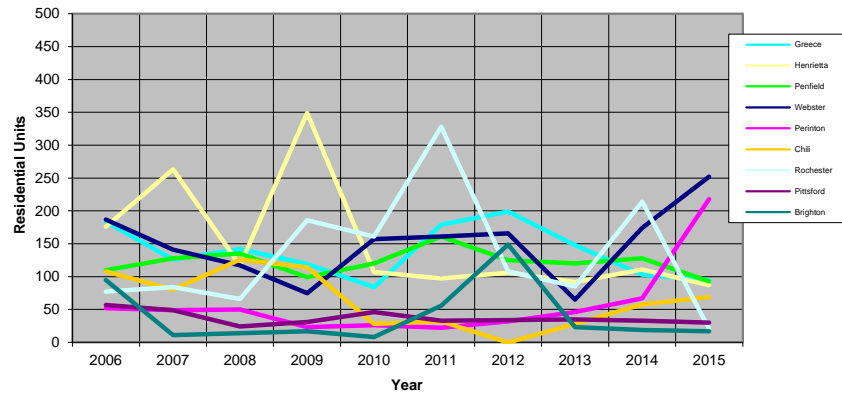

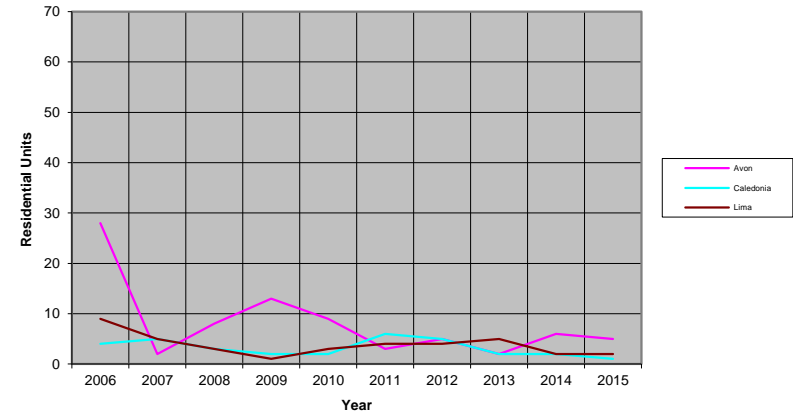

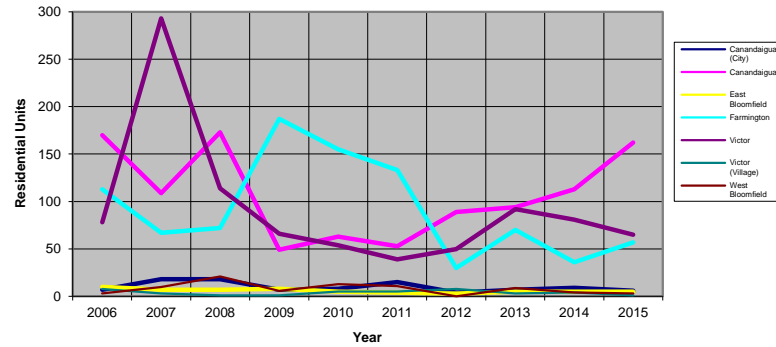
Towns with the Most Permitted Residential Units in Monroe County (2006 - 2015)



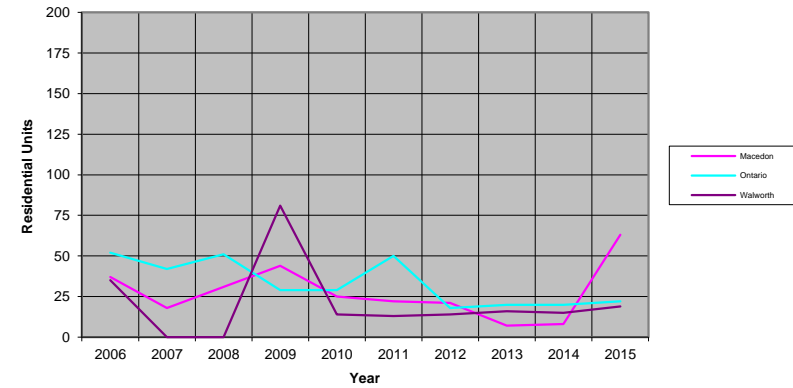
Number of Permitted Residential Units in Livingston County MPA Towns (2006 - 2015)

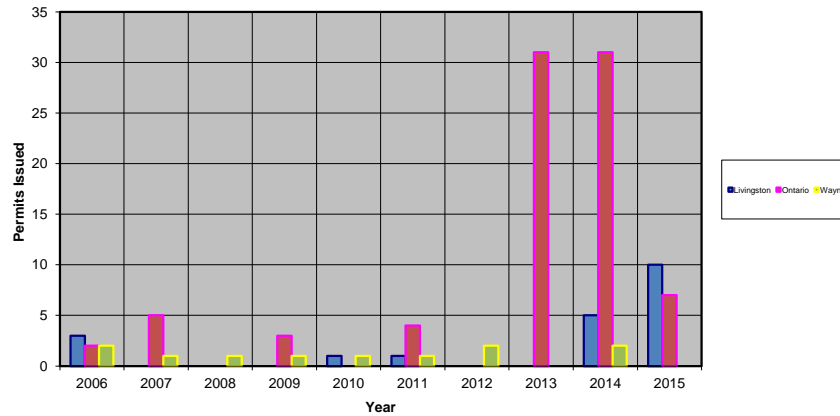

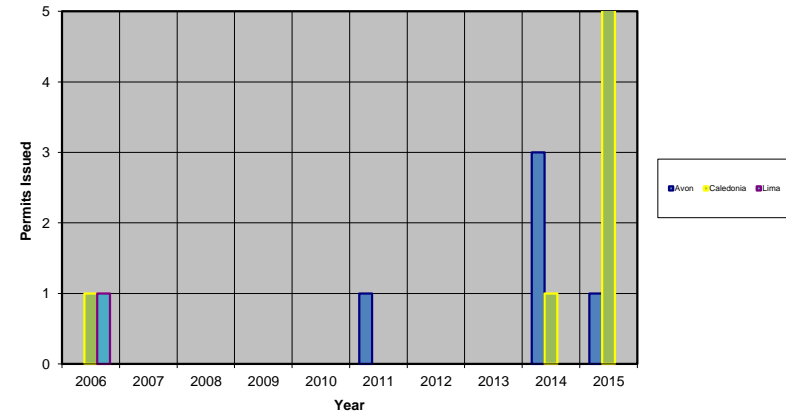

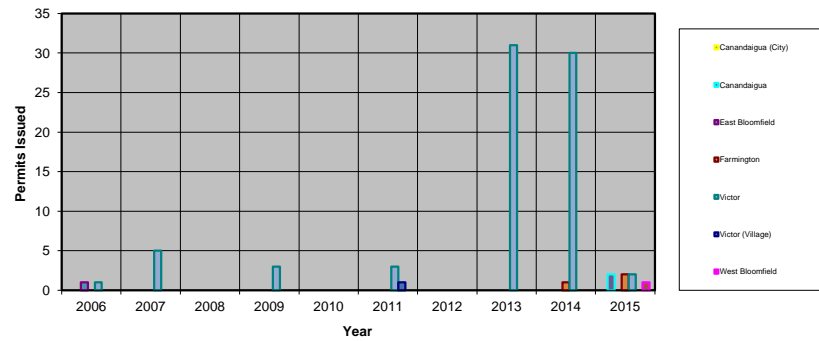
**Permits Issued for Industrial Buildings in MPA (outside Monroe County)
Towns by County (2006 - 2015)**



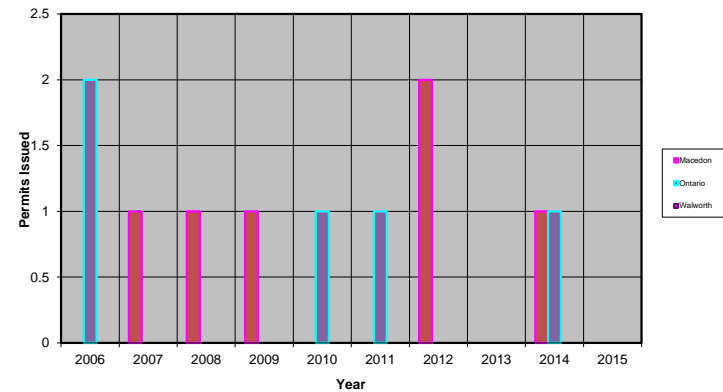
**Permits Issued for Industrial Buildings in Livingston County

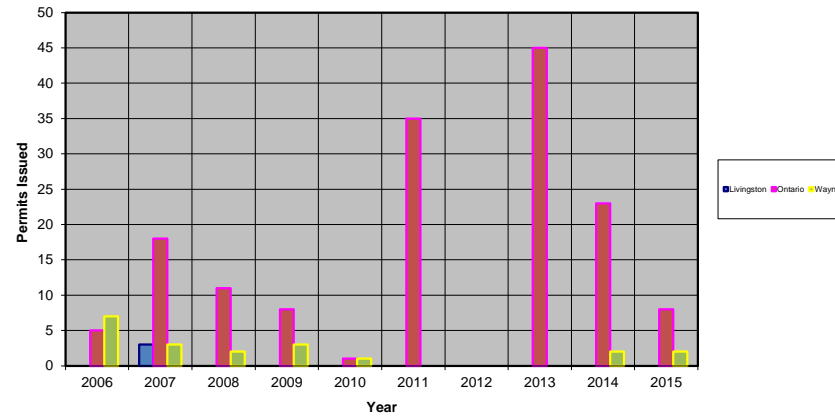

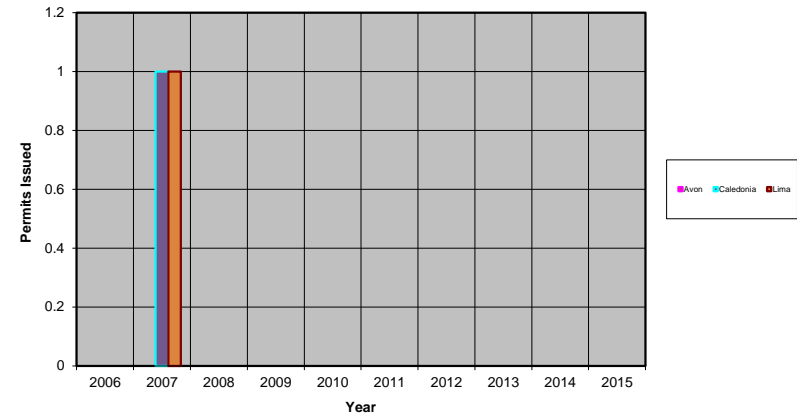

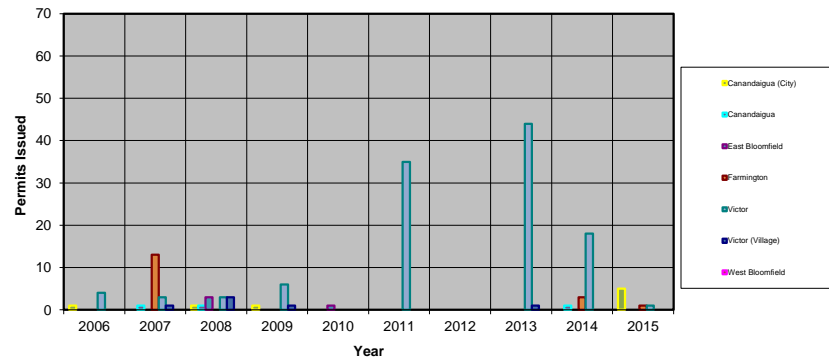
