## Clarification of Inquiry Organizer of Petition

July 23, 2025

The Hualapai Tribe, the Tribal Council and Administration is writing to address a petition currently circulating within our community regarding lineal descent. The Tribal Administration and Tribal Council have received several inquiries and noted some confusion surrounding this petition, and we wish to provide clarity on the matter.

We want to make it unequivocally clear that this petition for lineal descent is an independently organized movement and is not, in any way, organized or sanctioned by the Hualapai Tribe, or by any council member and not by the administration. This letter serves solely to provide clarification based on the inquiries we have received and is not intended to give any direction regarding the petition itself.

Our understanding is that the organizer of this petition is Cheyenne Gordon who should be contacted for direct inquiries regarding the petition's purpose and collection of signatures.

We also want to acknowledge that this petition drive is in compliance with the current Hualapai constitutional right for individuals to solicit interested Hualapai Tribal membership for signatures.

We thank each of you who have reached out with your inquiries. We appreciate the opportunity to provide you with this clarification and remain committed to keeping our community informed.



**Seeking Applicants for Two Seats on the Hualapai Tribal Utility Authority (HTUA) Board**

On September 24, 2014, the Hualapai Tribal Council adopted the Hualapai Tribal Utility Authority Governing Ordinance. This is a significant step toward self-determination in the realm of public utilities for the Hualapai Tribe.

Established as an institution of Tribal government, the five members of the Hualapai Tribal Utility Authority board are chosen by Council. As noted in Section 107.b.3, of the Ordinance, the HTUA Board is authorized to acquire, construct, operate, maintain, promote, and expand electric power service, and eventually water service, and sewage service at Grand Canyon West and on such other locations within the Hualapai Reservation and on other Tribal lands under the jurisdiction of the Hualapai Tribe as the Tribal Council may deem appropriate. The HTUA board is delegated full authority and responsibility for the management and operation of HTUA consistent with the Ordinance.

At this time, the Tribe is seeking two candidates to apply for Board membership to maintain this important function of Tribal government.

- ◆ The position may be filled by a member of the Community who has sufficient education, experience, and sound judgment to learn basic utility business practices and procedures.
- ◆ The new board member will be appointed for a three-year term.
- ◆ No employee of the Bureau of Indian Affairs, employee of the HTUA or member of the Tribal Council shall be a member of the Board.

## Understanding Your Child's Thinking and Learning

Cognitive development is all about how children grow in their ability to think, learn, and understand the world around them. It includes skills like remembering things, solving problems, using their imagination, and figuring things out.

Even at just 4 months old, babies start to show that they expect things to exist even when they can't see them, like a toy hidden under a blanket. Between 14 and 24 months, little ones love to explore through trial and error. You might notice them trying the same thing over and over until they get it right. They can be surprisingly determined!

During this time, toddlers also become excellent imitators. They remember what they see others do, sometimes even days later and will try to copy it themselves. This is all part of how they learn and make sense of the world.

Kids are like little scientists. They're curious, eager to explore, and constantly soaking up information.

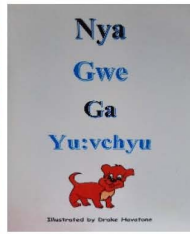

### Helping young children find nature outside the front door

**Parents and caregivers can start looking for nature right where they are.**

For families who want to introduce their babies, toddlers and preschoolers to outdoor play, there's only one main thing to know: nature is everywhere.



That's the advice from Ellen Bashor, education director of Nature Niños in Prescott. "You don't have to drive to a big park. You don't have to have hiking gear," Bashor said. "You don't have to leave your yard or your house to access the benefits of outdoor and nature play. Young children have the ability to connect with nature anywhere. You can explore three square feet and they'll find magic. There will always be a beetle to follow or a line of ants."

"You can watch the different cloud shapes and how they blow," Bashor said. Bashor wants parents to get rid of the idea that they have to travel for nature. A child can see a beetle either at the Grand Canyon or just outside of their

apartment. "The significance for them is being with their caregiver outside."

Play in an outdoor, natural environment helps engage a young child's senses and allows toddlers and preschoolers to exercise their bodies and minds. "There is nothing more different than nature," Bashor said. "No leaf is the same. For a child, a pinecone can be a school bus, a spaceship, a bear, your mom or dad. It challenges our brains to think and create in new ways." Even a few minutes outside can bring nature alive for young kids. Start with 5 minutes and go up from there.

- Collecting is a perfect place to start. Get an egg carton and put something special in each egg spot. Use the collection as a way of noticing new things. You can base the collection on colors, the five senses, sounds, things that feel nice, etc.
- Help your child create a small world. Use this as a way of processing and learning. You can help them make a tiny home of leaves and sticks. Bridge the outdoors with their toys. Bring out a favorite stuffed bear and make a home for that animal outside.
- Create nature art. Scribble on nature. Make a decorative landscape using found nature objects like sticks, rocks and leaves. Put your art on a piece of paper and when you're done, you let it go back to nature.
- Make a fort to hide in by taking a blanket outside.
- Watching wildlife is special and it could be looking for birds and bugs, instead of trying to find a javelina.

Colville, Portland

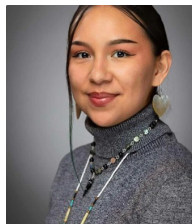

Muscogee Creek, Oklahoma City

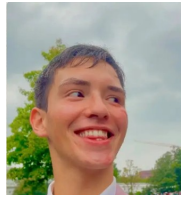

- **Terms of Understanding:** Funding is only for specific spay neuter surgery for feline/canine. Pet owners are responsible for any other direct fees (i.e. overweight, medication, other medical). Pet Owners are responsible to provide own transportation to and from selected location for spay neuter surgery in Kingman, Arizona at Humane Society Mohave County Animal Medical Center (Formally known as Low Cost Spay Neuter of Kingman).
- **Pre-Surgery Instruction:** DO NOT FEED your pet after 10 PM the day before your pet's appointment. Water is ok to leave out. If your pet accidentally gets a small amount of food the day of surgery, discuss with staff upon arrival of your pets appointment.
- **Appointment:** It is IMPORTANT you keep your appointment for your pet's surgery
