Zoning information for the Village of Kent City can be received via our website @ www.kentcitymi.org . You can also contact Tom Knauf, Zoning Administrator @ 616.678.7232. or vkc.zoning@kentcitymi.org. . The Zoning Administrator is in the office on Tuesdays and Thursdays.

Ordinance Reminders:

The Village has ordinances in effect for the following issues:

- Grass & Weeds Inoperable Vehicles Trash & Junk -•
- Parking on Streets or Village Lot Snow Removal Streets & Sidewalks
- Noise



The Zoning Ordinance requires a Sign Permit for any sign placed or erected within the Village of Kent City, with a few exceptions. Prior to placing any signs within the Village, please contact the Zoning Administrator. Signs placed within the public right-of-way are routinely confiscated and held for 10 days unless prior permission by the Zoning Administrator has been granted for placement of the sign.

~/ Fencing & Walls: Permits are not required to construct a fence or wall; however, they must comply with the provisions of the Zoning Ordinance. The ordinance regulates the height and location of fences and walls. Barbed wire and above ground electrically charged wire are prohibited in residential districts. A free one-page information sheet is available at the Village Office or on the website. We will mail or fax upon request.

Permits Authorized By The Zoning Administrator:

- Zoning Permits Building Permits Fences/Walls Signs •
- Dwellings/Additions to existing structures Porches & decks/Sheds
- Swimming pools / hot tubs Gazebos -Freestanding Antennas/Towers
- Razing (demolition) & moving a building

This service does not include trees that you have taken down or major trimming. The Village has a secured area where you can dump tree debris. Contact the DPW Manager @ 616-293-0693 to make arrangements.
