 - Granted a Variance of 380-38.I (Schedule of Required parking Spaces) for Lot#1
 - Granted a Variance of 380-117.I (Off-Street Parking & Loading Requirements for Shopping Centers) for Lot #2
 - Granted a Variance of 380-117.P (Shopping Center Design Requirements) for Lot#2
 - All variances granted were conditioned on meeting the conditions suggested by the Borough Solicitor.
- h. Borough Manager's Report: Mr. Powl reported that the school district did hire GFL Environmental, Inc. for refuse/recycling collection to begin in February. He also mentioned that the recycling tonnage from the schools in the Borough will be made available annually to the Borough as requested.
