C. Communication Equipment

Mayor Moore said they asked Chief Rose to get prices for the Radio's. He asked Chief Rose to see if Government would finance this.

Chief Rose said the cost for eight (8) radios, shoulder mic and base station is \$17,905.52.

A. Presentation of Sterile Doctor application for Rhome Family Park and Veteran's Park.

Trent Tabor was present and he explained how the application of his product keeps germs down. He said they would like to do the application to both parks at no charge. He asked the city to advertise his company. He said he would get us his MSDS sheet. He said it would take about an hour to spray the park. Mayor Pro Tem Wilson said she would be happy to if Brandon Evans from the Wise County Messenger would be working on it also.

Mayor Pro Tem Wilson said another thing in Walt Leonard's letter of February 27th vaguely suggests we need a contract with the volunteers that are going to be doing the incentives before we move forward. She asked has that happened.

Walt Leonard said they can have a contract or they can have a statement of the rules which they could sign off on it. The city can have a program and specific how it's going to work. The Fire Department could have something that says anyone that's a member in good standing can be eligible if they agree to operate under the terms.

Mayor Moore said they talked about adding this to the Fire Department By-laws.

Walt Leonard said this is not a guaranteed right. It is basically gift from the city and it's budgeted. If the council budgets \$1,000 per year and we run out of that in July then it stops. He said anyone that gets this is subject to a 1099.

. Mayor Moore said he would get a list to Ramah with everybody's that's participating.

Michelle Pittman said she would like to make a positive comment. A schedule was set on February 24th and on February 28th on their first and only daytime shift that is the day they had an alarm call at Chisholm Trail Middle School. There was a person here that was able to answer the call. The school was evacuated. She believes it is a positive program.

Mayor Pro Tem Wilson said she didn't think anyone is objecting to the program we just need to get out ducks in a row to set it in place and go forward. She said the intent of this was to bring in more volunteers. She asked if anyone else had applied.

Mayor Moore said a couple did the other night. He said Walt Leonard and he will work on that.
