City Administrator Ashton followed up with costs and a fee schedule proposed by a new credit card company for Municipal Court.

Motion made by Council Member Crenshaw, seconded by Council Member Eason, authorizing Staff to begin the Request for Proposal for Banking Services process. Motion carried unanimously.

Motion made by Council Member Crenshaw, seconded by Council Member Mackowski, to authorize the Mayor to purchase a replacement police patrol vehicle if there is money. Motion carried unanimously.
