Mayor Pittman Di Credico thanked Ms. Adams for her hard work and thanked Ms. Northrop for implementing the program, recognizing our employees, who are doing an exemplary job - many days a thankless job.

Regular Agenda – Old Business

F. Discussion and update on COVID-19 and the effect for the City of Rhome including but not limited to preliminary property tax values for 2020 and sales tax revenue

In an effort to update Council, Mayor Pittman Di Credico stated that there have been some different orders from Texas Governor Abbott's Office. The governor is beginning to let Texas re-open in phases and the City will stay in line with those orders.

The City has now returned to full in-person hours of all Staff, businesses have begun to re-open and in Wise County, the threshold to open is 50 percent for certain businesses. There are certain businesses that still have not opened yet, but will be re-opening in the coming weeks as the Governor allows Texans to re-open. The City is sharing information with City businesses to make sure that they receive accurate information.

Staff is working on evaluating when the City will re-open to the public and when in person meetings will be held for Council, Planning & Zoning, Parks & Recreation and also Municipal Court. Staff continues to attend biweekly virtual meetings with the Wise county judge, mayors and city administrators. Staff is also on virtual calls with the Governor's Office.

Staff is working on the re-opening plan; they had a meeting with the Municipal Court Judge to determine the requirements for Municipal Court to re-open.

With the Governor's extension of his emergency disaster order, allows the City to continue holding virtual meetings for another thirty days. This time will allow Staff to get all the plans in place for meetings, making sure all social distancing requirements are observed, purchasing disinfecting supplies, and training for newly written procedures are completed. Staff has already begun to receive training on handwashing, disinfecting and social distancing.

Mayor Pittman Di Credico also updated Council on information pertaining to property taxes and sales tax revenue. The City has received preliminary information for 2020 taxable values in the amount of \$159,315,440, which is down from the 2019 values of a little over \$167,000,000, a difference of approximately \$9,000,000. This estimate is before the protesting of values, the County anticipates many property owners to protest as these values are from January 1st. Staff is taking this information into account while working on next year's budget.

As for sales tax revenue, what the City receives in a month, is actually for two months prior sales activities. What the City received in May is actually March's activity. The City is watching for June's revenue, which is April's activity to start seeing the effects of COVID-19. The City is still ahead of last year, the City has received about 76.6% of our total projected budget for sales tax revenue, with only four months remaining, the City is already ahead about 14.9 % of the budget. The City is thankful that we have not seen huge effects just yet, people are still spending money and there is still traffic coming through town to get to the essential businesses.

Council Member Eason wanted to reiterate that when the budget was discussed last September that it was stated that the Mayor is conservative with revenue and not with expenses and this situation just demonstrated why that reasoning works.

Mayor Pittman Di Credico moved to the next update, stating that the City has received more definitive numbers as far as relief funds that are available for the state, counties and cities. The Wise County relief allotment is \$470,899 and of that, the City's portion, based on population is \$21,263 that is available. This is not free monies, it is to go towards any expenditures that are for specific, related items, the City can get reimbursed up to that amount. This is good news that there is some money available to the city for reimbursement.

G. Discussion and update on Revised Schedule for the Fiscal Year 2020-2021 Budget

Mayor Pittman Di Credico updated the Council on the revised schedule for the fiscal year 2020-2021 budget process. Di Credico stated that the departments have already submitted a preliminary budget, which she and City Administrator Northrop are meeting with the department heads next week.

The Mayor asked that any directives that Council would like to see this budget year, but sent to City Administrator Northrop, so Staff can take those into account while they work to complete the budget.

Di Credico listed the following meetings:

- May 28 Council will review City contracts and employee compensation
- June 11 Budget will be presented to Council
- June 25 present the proposed tax rate and proposed budget for public input
- July 9 Required Public Hearing on final proposed budget

H. Discussion and update on Parks Master Plan in conjunction with the University of Texas at Arlington

City Administrator Northrop stated that the citizen survey is open through May 31, 2020, currently 144 surveys have been completed. Dependent upon re-opening, the Parks Master Plan Steering Committee will either hold a public engagement meeting event or virtual focus group meetings in July.

City Secretary Montgomery read the one response received into the record:

"Hello Ms. Montgomery, I am the owner of Lots 17 and 18 in Blk:4 of the Original Town of Rhome. I received the memo regarding the public hearings regarding the request for replat and just wanted to say that from what I can see, it seems like a good idea. In my phone conversation to day with your office, I was informed of the massive growth that is about to take place in Rhome and it sounds a little scary, but also exciting."

Mayor Pittman asked if anyone on the call had any comments, being none, Di Credico closed the Public Hearing at 7:03pm.

"SUBDIVISION REGULATION" TO BE ENTITLED, "REPLATTING" TO PROVIDE FOR PROCEDURES AND REQUIREMENTS FOR REPLATS AND RENUMBERING REMAINING SECTIONS ACCORDINGLY; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR PUBLICATION IN THE OFFICIAL NEWSPAPER; AND PROVIDING AN EFFECTIVE DATE.

L. Discussion and any necessary action regarding agreement with Walnut Creek Special Utility District and authorization to engage special legal counsel regarding the same

Mayor Pittman Di Credico stated the City received a TCEQ violation on April 8, 2020; Walnut Creek also issued a notice that they were required to issue on March 11, 2020. The City issued our notice of violation to our residents on April 22, 2020 as required by TCEQ; the City is revisiting the issue of trihalomethanes. Di Credico reminded Council that the city does not have a water treatment facility, the City purchases its majority of water from Walnut Creek Special Utility District and the City expects water quality, to have received water be within requirements.

The Mayor continued by stating while the City is limited on what it can do regarding water quality, because the City does not have a water treatment facility, the City is proactively working on a list of items to help increase water quality, including having an open dialogue with Walnut Creek, making sure they understand our expectations within our agreement and having those expectation fulfilled.

Di Credico requested Council's authorization to engage special counsel, if needed, to discuss the contract as TOASE is not able to represent the City in that capacity due to a conflict. The Mayor would like to engage the firm previously used, it is her hope that this matter does not get that far, but having Council's authorization, if it is needed between now and the next meeting, if it is something Staff needs to utilize. The City does want to work with Walnut Creek to make sure the water that is coming to us is within the levels that are in the agreement.

Mayor then discussed the other items that Public Works Director Densmore is doing to help increase water quality: tank inspections and cleaning, and disinfecting and reducing the aging water by flushing the lines. One of the higher priorities is completing a water source water study. The City takes our water quality very seriously and expects the requirements within the contract to be met.
