AN ORDINANCE APPOINTING A JUDGE AND ALTERNATE JUDGES OF THE MUNICIPAL COURT OF RECORD THE CITY OF RHOME, AND ESTABLISHING A SALARY FOR SUCH TERM

#### Regular Agenda – Old Business

C. Discussion and any necessary action regarding Eastside Wastewater Treatment Plant Expansion including design and bidding

Mayor Pittman Di Credico stated that this agenda item is to allow the Council to make a decision on which design they would like to move forward with – the small or larger design. Di Credico stated that the City Engineers are here to provide background and answer any questions prior to Council making their decision.

Kyle Kubista, Kimley-Horn, stated his team designed both options and stated that the smaller design will also help resolve flow issues.

Kyle Welden, Kimley-Horn, provided a time line of the proposed project:

- Begin working on TCEQ Permit in June, completion in July
- Bid Project in August
- Award Bid in November
- Start Construction January 2021, with completion end of 2023

Kimley-Horn continued by stating that the larger design is out of the current price range; while the smaller design would allow for cost savings. The cost savings may be used to address other issues at the wastewater treatment plant, such as clay pipe replacement.

Motion made by Council Member Crenshaw, seconded by Council Member McCabe, to authorize the Mayor to proceed with the smaller design and comeback to Council to discuss what projects can be done with the proposed cost savings at a later date.

#### D. Update, discussion and any necessary action regarding Municipal Complex Renovation Project

Mayor Pittman Di Credico stated that this is just an update and that Kim Dowdy, with Quorum will be at the June 11 Council Meeting with a cost estimate and a finished design plan at the end of September. Di Credico also stated that the target to complete construction would be the end of 2021.

Di Credico shared that Quorum is proposing an upfront demo to better check for any unforeseen issues.

Council Member Eason stated he has concerns regarding a cost projection in June and a final design in September; he is not confident that the cost projection would be accurate if it is completed before the final design is submitted. Mayor Pro Tem Priest shared Eason's concerns and requested final numbers in June to aid with the budgeting process.

## E. Discussion and any necessary action regarding rescinding approval of Amendment to Agreement with Monarch Utilities I, L.P. for water services and related fees (approved at the December 12, 2019 Meeting)

Mayor Pittman Di Credico stated that Council approved a legal reviewed Amendment to the Agreement with Monarch Utilities I. L.P. for water services and related fees at December 12, 2019 Council Meeting. The City has heard nothing from Monarch Utilities and would like to rescind the proposed amendment at this time.

# F. Discussion and any necessary action regarding partnering with Wise County and other local municipalities for grant program for local businesses affected by COVID-19

Mayor Pittman Di Credico shared that Wise County Jude Clark and Wise County Emergency Management Coordinator Cody Powell proposed a grant program for local business affected by COVID-19 to the Wise County Mayors. Di Credico introduced Cody Powell, Wise County Emergency Management Coordinator, and asked Mr. Powell to explain the program to the Council.

Powell stated that the CARES Act established funding for local governments and explained that the allocation nets to approximately \$55 per capital, thus allowing cities to draw twenty percent of the total allocation up front, which can be used to provide economic development relief to small businesses affected by COVID-19.

Powell continued by stating that there are seven non-profits and 173 businesses within Wise County that could potentially apply for this grant. If each city contributes, that would be \$3000 for each business.

Mayor Pittman Di Credico stated that the City's portion would be \$21,263.

Council Member Eason stated that the City of Rhome currently has seven businesses that would be able to apply for the grant and asked how would this grant be advertised.

Powell anticipates wide spread public announcements, cities will be able to spread the word to local businesses.

Di Credico stated that the county has been paying for the city's PPEs and that the County has helped other cities in this regard.

Motion made by Council Member Crenshaw, seconded by Council Member McCabe, to partner with Wise County to allow Wise County to administrator the grant as Rhome does not have the staff.

Powell ensured that there would be no double-dipping, businesses would not be allowed to participate if they have received federal funding.

### G. Discussion and any necessary action regarding training for elected and appointed officials as well as staff

Council Member Eason stated that his goal, with requesting this item was to ensure checks and balances, that the "good ole boy" mentality was no longer being used, and requested required training for elected and appointed staff.

City Attorney Adkins stated that there is required training, such as the open meetings act and public information act training. Adkins also stated that current councils could not mandate future councils. Adkins also mentioned the newly elected officials TML training.

City Administrator Northrop stated that TML training could be more expensive and offered alternative training methods, such as webinars, include dedicated training agenda items throughout the year. Northrop stated she and City Attorney Adkins could put a calendar together for training.

Council Member Eason requested either an ordinance or resolution requiring bare minimum training to be drafted.

Adkins stated that a training resolution would be more appropriate.

Mayor Pro Tem Priest liked the idea of training be held during the Council meetings as this would educate both the Council and the citizens attending.

Motion made by Council Member Eason, seconded by Council Member Mackowski, to authorize Staff to draft a resolution for training setting city policy with periodic training not less than three times a year.

Eason also asked that TML webinars be provided to Council and citizens.

Mackowski stated that as the city grows, city administration will become more complex and training will become even more important.

Mayor Pittman Di Credico stated that staff will also be relied on more to help train the elected and appointed officials and staff needs to continue their training.

"OFFENSES AND NUISANCES" OF THE CITY OF RHOME CODE OF ORDINANCES TO REPEAL SECTIONS 8.08.032(A)(5) AND 8.08.033(A)(5); PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR PUBLICATION IN THE OFFICIAL NEWSPAPER; AND PROVIDING AN EFFECTIVE DATE
