MINUTES OF REGULAR SESSION OF THE RHOME CITY COUNCIL

Call to Order and Establish a Quorum

Public Presentations and Input

City Secretary Montgomery read a presentation by Deborah BeCraft, 360 West Second, Rhome, Texas, into the record:

"I am asking that the council approve waiving fees for city limit based non-profits and charities. There are not that many in the city limits of Rhome and the publicity of a non-profit holding an event here is great PR for the city and for the pavilion. The city makes money from our events even though we have never been charged any fees. They make money because the public that comes to our events spends money at the gas stations, convenience stores and restaurants and the city gets sales tax dollars from that. People that have come to our events have liked it and ask about having their own event here. It is advertising Rhome in a positive light, and that is never a bad thing and always needed. We have had people at our event ask about housing here and ask about business opportunities here. Even if the city never gets one dime from our events what they get in advertising, good will and positive PR could not be paid for.

I understand that the city needs to recover and/or make some money on the rental of the pavilion. But I think that they could waive the fees for the non-profits that are based in the city limits only. This would be along the same lines as the difference in pricing for residents and non-residents. We have a wonderful park and great pavilion but it has been grossly under promoted. The city needs to promote the pavilion rental to host weddings, family reunions, company picnics, and other such events. There could even be outdoor corporate seminars. It needs to be aggressively promoted in order to make money for the park and rec dept, not just on the city website. Reach out to local and area businesses, corporations and manufactures. Find websites, Facebook pages and other social media to promote the rental of the pavilion.

I will again ask that the council consider waiving fees for non-profits that are based in the city limits of Rhome."

Public Input

B. Receive Public Input regarding proposed fiscal year 2020-2021 budget

Shirly Mize, 170 Russell Street, Rhome, Texas, made comments and asked questions of the proposed fiscal year 2020-2021 budget:

- Concerned that the budgeted amount for General Fund Hiring/Testing Expenses is too low.
- Does not understand where the marketing analysis is coming from for payroll and wages budget items; feels residents should see the breakdown
- Does not understand why the City is budgeting for Rolling V platting and permitting. Mayor Pittman Di Credico stated that platting and permitting is part of the contract with Rolling V
- Questioned the street repair budget
- Questioned passing credit card fees to residents versus Staff working harder if more residents pay by check or cash
- Questioned whether or not there was funds for emergency repairs in the budget

C. Discussion regarding proposed fiscal year 2020-2021 budget

D. Discussion and update on Revised Budget Schedule for the Fiscal Year 2020-2021

Mayor Pittman Di Credico highlighted the budget schedule changes:

- July 9 Meeting budget and inventory
- July 23 Meeting budget
- July 25 City will receive certified property values
- July 30 Special Council Meeting review budget with certified property values
- August 27 Possible Public Hearing on Budget
- September 3 Special Council Meeting for Public Hearing on Budget
- September 10 Adopt Budget and Tax Rate

E. Update, discussion and any necessary action regarding Municipal Complex Renovation Project

Council discussed the basic design service fees for the Municipal Complex Renovation Project, including the Fire Station façade upgrade and the Community Center renovations as requested at the June 11, 2020 Council Meeting. The additional projects would cost an additional \$48,000 in addition to the \$150,000 design service fees of the Municipal Complex and exterior rendering.

Council discussed piecing the projects and seeking alternative funding.

Mayor Pittman Di Credico stated that the \$150,000 has been covered, there is no source for the additional \$48,000 in the current year's budget. Di Credico questioned if Council wanted the additional \$48,000 to come out of the Fiscal Year 2020-2021 budget. Discussion ensued regarding adding the additional projects or moving forward with just the Municipal Complex.

Motion made by Mayor Pro Tem Priest, seconded by Council Member Crenshaw, to approve the amendment of adding the Fire Station Façade upgrade and Community Center renovations design fees, fund from the Fiscal Year 2020-2021 budget, while focusing on obtaining alternative funding.

Regular Agenda - New Business

F. Discussion and any necessary action regarding changing temporary vendor fees to exclude non-profit organizations

Mayor Pittman Di Credico stated this agenda item was brought before Council to clarify Council's position on vendor fees. Di Credico stated not all fees would be excluded, but in regards to the pavilion and whether Council wants to consider as a whole, non-profits, having that exemption for the sum of the rental fees. This would not exclude the health permits as this is a public safety concern for all events that requires a health inspection.

Council consensus was to keep the fees as is; no action taken.

G. Discussion and any necessary action regarding Telephone and Internet Services

City Administrator Northrop provided a provider cost comparison showing an approximate \$10,000 savings moving to CenturyLink for both telephone and internet services, including fiber and new voice over internet phones. Northrop recommended moving to CenturyLink for both telephone and internet services and cancel NextLink altogether.

Twenty percent of the allotment was for the economic relief of the city's businesses affected by COVID-19. The remaining funds, \$85,052 can be mitigated to use for COVID-19 related expenses the City has incurred. Di Credico needs authorization from Council to spend these funds on backup uniforms for both Fire and Police, an extractor for the Fire Department, washer/dryer for the Police Department, AEDs for the Community Center, Fire and Police, cleaners, masks, thermometers, hand sanitizer, etc.
