AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RHOME, TEXAS, CANVASSING THE RETURNS, INCLUDING THE RETURNS OF ABSENTEE AND EARLY VOTING BALLOTS CAST IN CONNECTION THEREWITH, AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 1, 2021 RELATING TO THE ELECTION OF ONE (1) COUNCIL MEMBER TO PLACE NO. 1 FOR A TWO (2) YEAR TERM, ONE (1) COUNCIL MEMBER TO PLACE NO. 2 FOR A TWO (2) YEAR TERM AND ONE (1) COUNCIL MEMBER TO PLACE NO. 3 FOR A TWO (2) YEAR TERM TO THE CITY OF RHOME CITY COUNCIL; PROVIDING FOR THE CONFIRMATION OF VOTE TABULATIONS; IDENTIFYING THE OFFICIALS ELECTED AND TERMS OF OFFICE; AUTHORIZING THE ISSUANCE OF CERTIFICATE OF GENERAL ELECTION; AUTHORIZING THE ISSUANCE OF THE CANVASS OF THE GENERAL ELECTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on February 11, 2021, the City Council of the City of Rhome, Texas (the "City") passed and approved Ordinance No. 2021-04, ordering a General Election for the purpose of electing one (1) Council Member to Place No. 1 for a two (2) year term, one (1) Council Member to Place No. 2 for a two (2) year term, and one (1) Council Member to Place No. 3 for a two (2) year term to the City of Rhome City Council to be held on May 1, 2021; and

WHEREAS, the official returns of the General Election, including the returns of absentee and early voting ballots in connection therewith, and as such returns are related to the election of one (1) Council Member to Place No. 1 for a two (2) year term, one (1) Council Member to Place No. 2 for a two (2) year term, and one (1) Council Member to Place No. 3 for a two (2) year term to the City of Rhome City Council have been presented to the City Council acting in its capacity as the Canvassing Board; and
