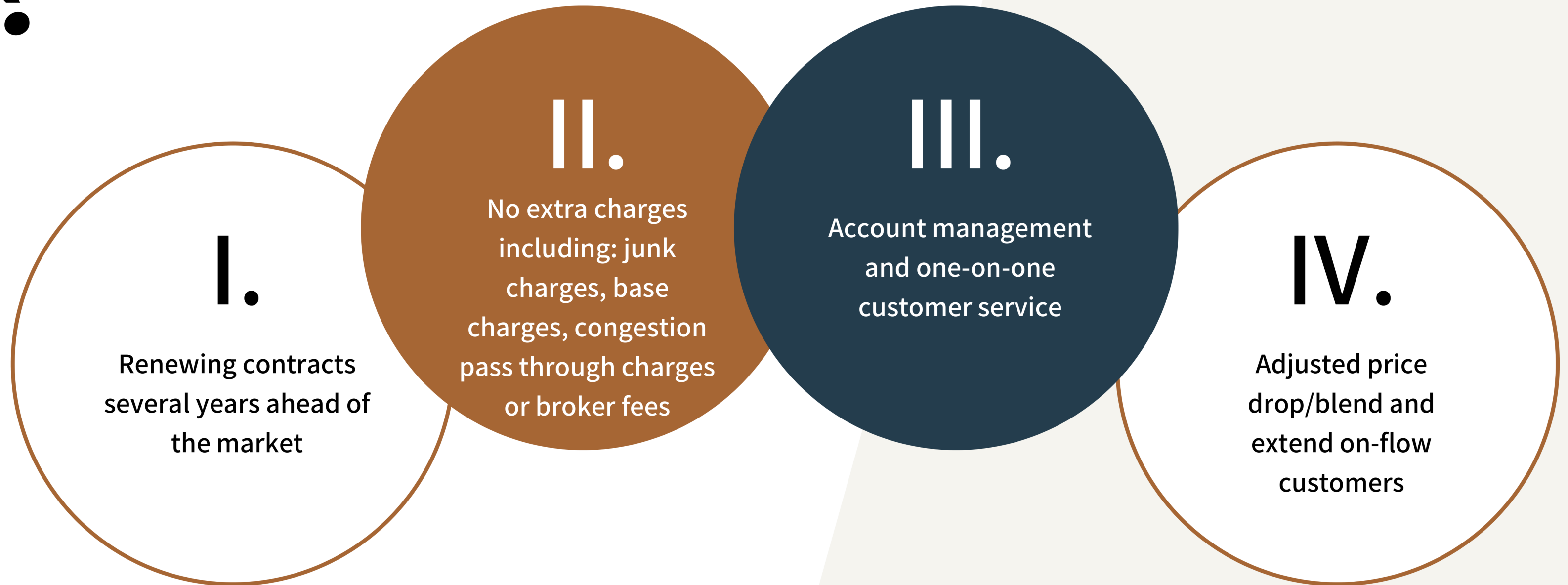

Long-Term Protection

Let's Run the Numbers!

$$\$0.04288 - \$0.085 = \$0.043$$

$$\$0.043 \times 56,888 \text{ kWh}^* = \$2,446.18$$

Let's Run the Numbers!

$$\$0.10 - \$0.085 = \$0.015$$

$$\$0.015 \times 56,888 \text{ kWh}^* = \$853.32$$

$$\$853.32 \times 108 \text{ months} = \$92,158.56 \text{ more}$$



Add and Delete clause:

- Anytime you need to add a new meter or location, I can add it to the existing agreement and the same low rate.

Adjusted Price Drops:

- During the duration of your contract, at any point if the market drops, I as your broker, have the ability to lower your current rate and extend the terms.
