COVID-19 UPDATES

2 years of COVID-19 in Scioto County; Where are we now?

Since the beginning of the COVID-19 pandemic the Scioto County Health Department has continued to implement mitigation strategies to help keep our communities safe and informed. Since 2020, our agency staff has worked hard to keep up with the ever-changing data, information, and education in order to ensure we are giving the most up-to-date recommendations per CDC guidelines and apply them to our current county level situation.

We continue to address many other public health issues with education and prevention strategies. We believe these last two years have prepared us to be even better at responding to any future COVID-19 surge or other public health emergencies. We continue to promote and protect the health, safety, and well-being of all through the many services we have to offer.

In the recent months we have slowly been making changes to our on-line reporting; you will see that we have added direct links that will take citizens directly to the CDC on-line COVID-19 dashboards for more data and statistics per county, state, and national levels.

Although we are no longer making contact with positive COVID-19 cases or contact tracing to the extent we were in the beginning of the pandemic, we continue to monitor these cases as we do with other communicable diseases; investigating outbreaks and offering recommendations to individuals and businesses on how to manage and/or mitigate the illness for their specific situation.

Scioto County Health Department wants to remind everyone it is that time of year again. Mosquitoes can be found around many households, campgrounds, and parks in Ohio. It is common for humans to come in contact with mosquitoes in the spring, summer, and early fall in Ohio when going outdoors. There are 59 species of mosquitoes in Ohio. Some of these mosquitoes are known to spread disease. Although rare, mosquitoes can spread diseases such as West Nile Virus, Encephalitis, and Malaria if an infected mosquito bites a human. Dogs can also get heartworms from bites from infected mosquitoes.

The Scioto County Health Department is in partnership with The Ohio Department of Health (ODH) Zoonotic Disease Program to conduct county wide vector borne disease surveillance to help with mosquito control activities. Environmental Health Division staff are available to help assist you with questions regarding mosquito prevention, filing complaints regarding mosquito problems in Scioto County, and reducing mosquito harborage conditions in Scioto County. Guidance for Homeowners

Step by Step Process for installing, Replacing, or Altering a Sewage Treatment System

1.) Soil Evaluation:

A soil evaluation must be completed in accordance with rule 3701-29-07 of the Ohio Administrative Code the soil evaluation may be conducted by The Scioto County Health Department or a qualified soil scientist.

2.) Sewage Treatment System Design:

Once the soil evaluation is complete, a STS design must be created in accordance with rule 3701-29-10 OAC."STS designs shall be prepared and submitted by persons capable of reviewing the soil evaluation, site conditions, information provided by the homeowner, and these rules to facilitate the choice of an appropriate, site specific STS..." 3.) Site Review Application & Associated Fee:

After the above two steps are completed, the following information must be submitted to the Scioto County Health Department: Soil Evaluation, STS Design, Sewage Treatment System Site Review Application, and Site Review Fee. The Sewage Treatment System Site Review Application and a list of fess can be found on the left of the screen.

4.) Permit Application & Associated Fee: Once the Sewage Treatment System Site Review Application has been approved, the applicant may apply for aPermit to Install or Alter a Sewage Treatment System. The a copy of the permit can be found to the left of thisscreen. Submit the permit and associated fee to the Scioto County Health Department. Once approved, the applicant will receive the permit and installation may begin.





Private Water Testing

Prior to an Installation or alteration of a private water system, a permit from the Scioto County Health Department must be obtained by the property owner or installer. Private water systems include wells, ponds, hauled water storage tanks or cisterns as a water source. Determination of water quality by testing private water systems for Coliform bacteria and E.coli is also an important service. In addition to these water tests being required as part of the permit process, the health department will, upon request, collect samples from private water systems and report the lab results. Contact us for current fees. If you are buying/selling a home or upon the homeowners request, the Scioto County Health Department can evaluate your existing household private water system.

How to Collect an Anterior Nasal Swab Specimen for COVID-19 Testing



Use only an authorized specimen collection kit given to you by your healthcare provider or personnel at the testing center, or purchased over the counter in a pharmacy or other store. Follow the instructions included with the specimen collection kit which may be used on site or at home. Use only materials provided in the kit to collect and store or mail the specimen, unless the kit syste of otherwise. These instructions can also be used with self-testing kit if the kit specifies and collection.

Vital Statistics of Scioto County

The Vital Statistics of Scioto County Health Department maintains birth records from December 20, 1908 to present of births anywhere in OHIO and Death records from 1931 to present (only if death occurred in Scioto County outside of Portsmouth City limits). Costs are \$25.00 per certified copy. Scioto County Health Department in accordance with Scioto County Auditor Office accepts cash, money orders, cashier's and local checks made payable to Scioto County Health Department. Records may be requested in person Monday-Friday from 8:30-4:15. You may also send a request for a birth or death record by mail.

Please include; the request form, method of payment, a phone number, and a stamped, self-addressed envelope. Please do not send cash by mail.

Tobacco Facts

- 1 in 4 (25%) of adults in Scioto County smoke, compared to 19.3% in Ohio and 17% in the U.S.
- Scioto County has a higher cancer incidence rate (494.5 cases per 100,000 people) than Ohio (461.6)
- On average, Ohio children try smoking for the first tijme at age 12-1/2 years.
- Over 40% of Ohio high school students have tried ecigarettes.
- Over 90% of adult smokers started smoking before age 18.

Tobacco use is the leading preventable cause of disease and death in the U.S. Early start of tobacco use has been shown to increase the likelihood of lifetime smoking and the risk for tobaccorelated illness and death.
