On 09/22/23, about 2:00 PM, Owego Police Officers were dispatched to a residence on George Street for 70 year old Male down and not breathing. Upon arriving on scene, Owego Police Officers and Owego EMS provided First Aid, including the administration of CPR. The male was successfully rescued and is recovering in a hospital.

There are roughly 350,000 resuscitation attempted outside of a hospital setting in the United States with the average survival rate of administered CPR is about 5 %.
