**Jason A. Deskin**, 40, Owego, NY, was arrested for Criminal Sale of Controlled Substance 3<sup>rd</sup> degree ó Methamphetamine (**B Felony**) and Criminal Sale of Controlled Substance 3<sup>rd</sup> degree ó Heroin (**B Felony**). **Deskin** was arraigned in the Village of Owego Court and was remanded to the Tioga County Jail without bail.

**Arnold R.
