**Shantale N. Harris**, 27, Binghamton, NY, was arrested for Aggravated Unlicensed Operation of a Vehicle (**Misd**), Uninspected Vehicle and Inadequate Exhaust.

**Kaelyn J. Lloyd**, 27, Binghamton, NY, was arrested for Aggravated Unlicensed Operation of a Vehicle (**Misd**) and Uninspected Vehicle.

**Peter P.
