Richard A. Chrysler, 19, Owego, NY, was arrested for Attempted Petit Larceny (**Misd**) and Criminal Mischief 4th degree (**Misd**) after an investigation of shoplifting from a business on West Main Street. **Chrysler** was issued an appearance ticket returnable to the Village of Owego Court.

Annette L.
