1. The Applicant agrees to secure a Permit from the Village of Peck
2. The Applicant agrees to save harmless, indemnify, defend and represent the Village of Peck elected officials, its agents and employees against any and all claims for bodily injury, property damage on any claim arising out of or related to the creation, operation, use, or continuing existence of the structure or facility covered by this Permit.
3. Deposit fees are refundable three (3) months after completion of the specified project, provided there occurs no undue settlement, spalling, etc. and/or work is approved by the Village of Peck.
4. Forty-eight (48) hours advance notice shall be given to the DPW supervisor prior to the commencement of any proposed work within Village Right-of-Way.
5. This application shall not be constructed to grant rights whatsoever to any public utility, except as to the consent specifically outlined.
6. The Applicant agrees to construct, operate, use and/or maintain facilities to the satisfaction of the Village as long as the facility remains in Right-of-Way under jurisdiction of the Village. Applicant is obligated to repair any and all damages to the Right-of-Way resulting from installation of the facility, occurring or appearing after the Permit Licensee is released.
